NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2023 AND 2022

1. DESCRIPTION OF PLAN

The following description of the Gateway-Longview, Inc. Employee Savings Plan (the Plan) provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Gateway-Longview, Inc. (the Plan Administrator), which includes employees of the Plan Administrator, New View Alliance (New View), and the Gateway-Longview Foundation (Foundation) (collectively, the Sponsors) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Gateway-Longview Retirement Plan Committee (the Committee) is responsible for oversight of the Plan and monitoring investment performance.

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) was the custodian of the Plan for the period from January 1, 2022 to December 27, 2023. Lincoln Financial Group Trust Company, Inc., (Lincoln) was the custodian of the Plan beginning December 28, 2023.

Eligibility

Employees of the Plan Administrator, New View and the Foundation, and New View employees who were formerly employed by the Plan Administrator, may begin participation in the Plan immediately upon employment. Employees are eligible to receive employer contributions upon achievement of age 18 and 1,000 hours of service in a 12 month period.

Contributions

Participants may elect to defer a specified amount of eligible compensation, as defined, on a pre-tax and/or after-tax basis subject to the Internal Revenue Code (the Code) limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover).

The Plan Sponsors will provide eligible participants, as defined, a non-elective contribution equal to 2% of eligible participants' annual wages, as defined. The Plan Sponsors provide matching contributions equal to 50% of participant contributions, up to a maximum of 3% of the participant's eligible compensation, as defined. Sponsor contributions are subject to certain vesting requirements.

Participant Accounts

Each participant's account is credited with the participant's contributions, sponsor's contributions, an allocation of plan earnings, reduced for benefits paid, and charged directly for benefit processing fees, if applicable. Allocation of Plan earnings are based on the investment balances held in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investments

Participant elective deferral contributions and employer contributions are invested as directed by plan participants. Participants may change their investment allocation on a daily basis.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are vested immediately in their contributions and earnings/losses thereon. Participants are vested in employer contributions as set forth in the following table:

Less than One Year	0%

Two Years but less than Three Years	25%
Three Years but less than Four Years	50%
Four Years but less than Five Years	75%

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account. Participants with an account balance less than \$1,000 will receive a lump-sum distribution. Participants may also elect to make withdrawals from their accounts in the event of financial hardship, as defined.

Hardship Withdrawals

Participants who have suffered a financial hardship as defined in the Plan document may take withdrawals up to the value of their vested account balance. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are reallocated as contributions to plan participants. Forfeitures amounted to \$52,121 and \$29,900 for the plan years ended December 31, 2023 and 2022, respectively. Forfeitures reallocated to plan participants amounted to \$73,621 for the plan year ended December 31, 2023. There were no forfeitures reallocated to plan participants for the year ended December 31, 2022. Net earnings (losses) on forfeited balances amounted to \$2,929 and \$(6,081) for the years ended December 31, 2023 and 2022, respectively. Unused forfeited account balances amounted to \$54,970 and \$73,541 for the plan years ended December 31, 2023 and 2022, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Sponsors have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between knowledgeable unrelated parties at the measurement date. See Note 3 for discussion of fair value measurements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsors and are excluded from these financial statements. The Plan pays for certain recordkeeping and investment advisory fees. Other investment related expenses related to fund management are included in net appreciation (depreciation) in fair value of investments.

Income Taxes

The Plan is exempt from federal taxes under Section 403(b) of the Code. The Plan is required to operate in conformity with the Code to maintain its tax exemption. The Plan obtained its latest determination letter on August 24, 2012, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2023 and 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

General Account Fund

The general account fund's asset is invested in group annuity contracts that have a guarantee of principal and previously credited interest to protect against market risk. The guarantee is based on Lincoln's financial strength and claims-paying ability. Lincoln assumes the investment risk of the underlying investments of the Lincoln NY Stable Value Account.

The Lincoln NY Stable Value Account is a fully benefit-responsive investment contract and is reported at contract value. Benefit responsiveness is defined as the extent to which a contract's terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents participant contributions, plus earnings at guaranteed rates, less participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

3. FAIR VALUE MEASUREMENTS (Continued)

General Account Fund (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Lincoln Financial determines the crediting interest rate by considering many factors, including economic and market conditions, the general interest rate environment and the expected and actual return on the portfolio within the general account. The crediting interest rate may not be less than 1.00% for the year ended December 31, 2023 and is reviewed on a semi-annual basis for resetting. At December 31, 2023, the contract value of the general fund from Lincoln amounted to \$8,752,903. There was no balance in the general account fund at December 31, 2022.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The value provided to the Plan for the general account fund represents the redeemable value of the fund and is comparable to a cash equivalent and, therefore, is not subject to the leveling requirements above.

Group Annuity Contract

The Plan allowed participants to direct their contributions into an investment contract with PLIC. PLIC maintained the contributions in a general account. The contract guarantees a rate of interest that is credited to participant accounts and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by PLIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

3. FAIR VALUE MEASUREMENTS (Continued)

Group Annuity Contract (Continued)

Certain events limit the Plan's ability to transact at contract value with PLIC. Such events include the following: (a) surrender charges if it is terminated by the contract holder or the Plan terminates its interest in such contract within certain time periods, (b) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. PLIC determines the crediting interest rate by considering many factors, including economic and market conditions, the general interest rate environment and the expected and actual return on the portfolio within the general account. The crediting interest rate may not be less than 1.75% for the year ended December 31, 2022 and is reviewed on a semi-annual basis for resetting. At December 31, 2022, the contract value of the group annuity contract from Principal amounted to \$130,632. There was no balance in the Group Annuity Contract at December 31, 2023.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

4. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2023 and 2022, as well as transactions for the years then ended, have been derived from information provided by Lincoln and Principal, the custodians of the Plan, and has been certified by them as complete and accurate to the best of their knowledge. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent accountants.
