Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Smith and Keene 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. Plan Description

The following description of the Smith and Keene 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document available from the plan administrator for a more complete description of the Plan's provisions.

General

The Plan, established May 1, 2020, is a defined contribution plan covering all employees of Smith and Keene Electric Service Inc. (the "Company" or "Employer"), except leased employees, who have completed ninety days of service and are twenty-one years of age or older. Eligible employees may begin participating in the Plan as of the first day of each month immediately following satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective February 18, 2022, the Plan was restated for regulatory compliance purposes and adopted a pre-approved plan document of to be in compliance with recent legislation. There were no changes in the Plan's provisions.

Custodian and Administration of the Plan

The custodian and recordkeeper of the Plan is Principal Trust Company (Principal). The administrator of the Plan is the Company. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance, with the assistance of investment advisors.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, and may also contribute on an after-tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Employer, at its discretion, may match employee contributions made during the plan year in an amount determined by the Employer, expressed as a percentage of participant compensation. The discretionary match for the year-ended December 31, 2023 was 25% of the first 3% of a participant's yearly compensation. All eligible participants share in the allocation of matching contributions regardless of service completed during the plan year or employment status at the end of the plan year, as defined by the Plan. Additionally, the Company may elect to make nonelective contributions on an annual basis. Contributions are subject to certain regulatory limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, and employer matching contributions and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant requested transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions, and Company contributions made on their behalf, into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their deferral, after-tax, and Company nonelective contributions, plus actual earnings thereon. Participants who retire, die or become totally and permanently disabled are entitled to the full amount in their account. Participants who terminate employment prior to 100% vested are entitled to a percentage of their Company employer contributions account depending on their years of service. A participant will be vested in their employer matching contributions 20% per year beginning after one year of service and is 100% vested after five years of service.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective contributions if any are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Participants may not apply for more than one loan during a 12-month period and may only have one loan outstanding at a time. Loans are repayable ratably through periodic payroll deductions, at a reasonable fixed rate of interest set by the Company. Payments of principal and interest are credited to the participant's account.

Payment of Benefits

Upon termination of employment, retirement, disability, or death, participants whose vested interest in their account balances exceeds \$5,000 may elect to receive a distribution of their vested account balance. Distributions may be paid to qualified participants in the form of a lump sum payment, installments, or a rollover to a qualified Plan. Participants whose vested interest in their account balance is \$1,000 or less will automatically receive a lump-sum equal to the value of their vested balance. Participants whose vested interest in their account balance is between \$1,000 and \$5,000, and make no elections, will automatically have their vested account balances rolled over to an IRA. The Plan allows for hardship distributions, and in-service withdrawals upon attainment of age 59 ½, from all vested account balances. Participants will receive the value of their vested

interest in their account balances as soon as administratively feasible following the date of termination.

Forfeitures

There were no unallocated forfeitures as of December 31, 2023 and 2022. Forfeitures may be used to pay administrative expenses or allocated to participants. Forfeitures totaling \$351 were used to offset administrative expenses during the year ended December 31, 2023.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in the fair value of investments in the statement of changes in net assets available for benefits. Administrative expenses of \$11,381 were charged to the Plan for account maintenance and participant requested transactions for the year ended December 31, 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Plan management determines the Plan's valuation policies utilizing information provided by Principal. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus unpaid accrued interest. A participant's loan shall be considered in default if any scheduled repayment remains unpaid as of the end of the calendar quarter following the calendar quarter in which the missed payment was due. Defaulted notes receivable from participants are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits. For the years ended December 31, 2023 and 2022, there were no deemed distributions.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants in 2023 and 2023 excess contributions to the applicable participants in 2024.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2024, the date which the accompanying financial statements were available to be issued.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to measurements involving significant unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which a fair measurement falls is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used at December 31, 2023 or 2022. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: units held in the common collective trusts are valued at NAV. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. These are direct filing entities.

Pooled Separate Accounts (PSAs): Pooled separate accounts are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. These are direct filing entities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fixed Annuity Contracts

The fixed annuity contract consists of the investment option available to participants known as the Principal Fixed Income Guaranteed Option. The annuity contract is a guaranteed general-account backed group annuity contracts that has been issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian. A rate of interest contractually guaranteed by Principal Life is credited to participant account balances.

Annuity accounts are credited with a guaranteed minimum rate of interest that is determined annually. This net crediting rate is after the deduction for fees for administrative and recordkeeping services provided to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer, but may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting. Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents, (b) changes to the Plan's prohibition on competing investment options or deletion of equity provisions, (c) bankruptcy of the Company or other Company events, and (d) the failure of the Plan to qualify for exemption of Federal Income taxes. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with the Plan participants, is probable.

During the year ended December 31, 2023, the crediting rates of the annuity contract ranged from 1.55% to 1.75%.

5. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2023 and 2022, and net appreciation in fair value of investments, dividends and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal and Principal Life Insurance Company, qualified institutions.

6. Party-in-Interest and Related Party Transactions

Certain Plan investments are funds managed by Principal or its affiliates. Principal is the custodian as defined by the Plan and therefore, these transactions qualify as exempt party-in-interest transactions. Investment management fees were paid to the custodian in the form of a reduction of net appreciation in fair value of investments earned by Plan participants. Additionally, the Employer pays certain administrative expenses on behalf of the Plan and provides certain recordkeeping services at no cost to the Plan, both of which are considered to be exempt party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions.

7. Tax Status

The Plan uses a pre-approved plan document sponsored by Principal. Principal received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. As such, the Plan is not subject to income taxes; however, it is required to file tax returns.

In accordance with Accounting Standards Codification (ASC) 740, *Income Taxes*, accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Employer contribution accounts.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2023 and 2022, the Plan held three investments comprising of 48% and 49% of the total fair value of investments, respectively.
