Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of the Heartland Health System, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

Effective January 1, 2005, Heartland Health System, Inc. (the Company), created the Plan for the benefit of the Company's employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

The Plan permits eligible employees through a salary reduction election to contribute a portion of their salary up to the maximum amount prescribed by law. The Plan provides for two categories of Company contributions; discretionary matching and employer non-elective. The Company elected to make a matching contribution in the amount of \$ 50,522 and \$ 106,973, for the period ended October 13, 2023 and year ended December 31, 2022, respectively. Employer non-elective contributions are allocated to eligible participants based on their proportional share of eligible compensation. There were no employer non-elective contributions made during 2023 or 2022.

3. Participant Accounts and Forfeited Accounts

Each participant's account is credited with the participant's contributions and actual earnings, an allocation of the Company's contribution and Plan earnings. Allocations of Company contributions are based on participant contributions and compensation. Allocations of Plan earnings are based on participants' account balances. The non-vested portions of terminated participants' account balances are forfeited and such forfeitures serve to reduce future administrative expenses and employer contributions. At October 13, 2023 and December 31, 2022, the Plan retained \$ -0- and \$ 1,931 in forfeitures, respectively.

4. Vesting

Participants are 100% vested in their voluntary contributions plus actual earnings on these contributions. Vesting is based on years of continuous service. The Company's matching contributions and their related earnings are vested at a rate of 20% each year after two years of vesting service. Due to the plan termination, all participants still in the plan at that date will become 100% vested in their account balances.

5. Investment Options

Upon enrollment in the Plan, a participant may direct contributions to selected investments as made available and determined by the Plan's Trustees. Participants may change their investment options at any time pursuant to procedures established in the Plan document.

6. Payment of Benefit

Upon termination of service, participants may elect to receive a lump-sum amount or installments equal to the value of their account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

7. Plan Termination

The plan was terminated effective October 13, 2023, with no further contributions to be made under the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

3. Payment of Benefits

Benefits are recorded when paid.

4. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions. Those estimates and assumptions affect the reported amount of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

5. Subsequent Events

The Plan assessed events that have occurred subsequent to October 13, 2023 through October 7, 2024, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements. No events have occurred that would require adjustment to or disclosure in the financial statements.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at October 13, 2023 and December 31, 2022, and net appreciation in fair value of investments and dividends for the period ended October 13, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company.

NOTE D - FAIR VALUES OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 13, 2023 and December 31, 2022.

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

The Plan invests in American Funds' mutual funds. American Funds and Capital Bank and Trust Company, the Plan's Custodian, are affiliates. Additionally, the Company provides certain administrative services at no cost to the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

NOTE F - INCOME TAX STATUS

The Plan has received a favorable opinion letter under Section 401(a) of the Internal Revenue Code from the Internal Revenue Service. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

NOTE F - INCOME TAX STATUS - Continued

The Plan follows accounting principles generally accepted in the United States of America related to the accounting for uncertainty in income taxes which sets a minimum threshold for financial statement recognition of the benefit of a tax position taken or expected to be taken in a tax return. Tax positions for the open tax years as of October 13, 2023 were reviewed and it was determined that no provision or disclosure for uncertain tax positions is required.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
