Opinion

Note 1 - Description of Plan

The following description of the New Jersey Urology, LLC Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of New Jersey Urology, LLC (the "Company" or "Plan sponsor") who have one year of service (one year of service is defined as being credited for 1,000 working hours) and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

An eligible employee is one who is not: governed under a collective bargain agreement, a non-resident alien, a leased employee, or an employee of an affiliate who has not adopted the Plan. In addition, there are specific excluded employees who are not direct or indirect owners of UMA Physician Holdings LLC, or non-physician employees who are employed at specific locations and divisions as noted in the plan adoption agreement.

The Plan was merged into the Summit City MD 401(k) Plan on November 1, 2022. In October 2023, the remaining assets of the Plan were transferred to the Summit City MD 401(k) Plan. The final Form 5500 is being filed for the plan year ending December 31, 2023.

Contributions

The Plan does not allow for employee deferral contributions.

The Company has the option, but not the requirement, to make a discretionary non-safe harbor profit-sharing contribution to eligible participant accounts (employed by the Company on the last day of an allocation period). Compensation eligible for employer contributions includes all compensation received during the year.

Participant Accounts

Each participant's account is credited with rollover contributions, if applicable, and allocations of (a) the Company's contribution and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Company's match and non-safe harbor profit-sharing contribution portion of the participant's account, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service. For all other types of contributions, participants are vested 100% upon receipt of contributions.

Note 1 - Description of Plan (cont'd.)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1 to 5 years or up to a reasonable period of time for the purchase of a primary residence, which will be determined at the time that the loan is made. The loans are secured by the balance in the participant's account and bear an interest rate at the prime rate plus 1% at the time of the loan. Principal and interest are repaid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may receive a lump-sum or a partial distribution amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

Forfeitures are used to reduce future employer matching contributions, future employer non-safe harbor profit-sharing contributions, or administrative expenses. There were no unallocated forfeited nonvested accounts as of December 31, 2023.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 - Summary of Significant Accounting Policies (cont'd.)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded at December 31, 2023. Delinquent notes receivable from participants are reclassified as distributions once the participant is no longer employed by the Company. There were no outstanding receivables from participants at December 31, 2023 and 2022.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Company pays for certain administrative expenses of the Plan, including various professional fees. Administrative expenses incurred by the Plan include account maintenance fees and loan processing fees charged directly to participants' accounts and investment management fees that are netted against investment returns.

Note 3 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 3 - Fair Value Measurement (cont'd.)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

As the Plan had no assets measured at fair value held at year-end, there is no classification to present nor any significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 4 - Party-In-Interest Transactions

Principal Trust Company is considered to be the Plan custodian as defined by the Plan and, therefore, fees paid to this entity qualify as party-in-interest transactions. There were no such fees for the year ended December 31, 2023.

The Plan is managed by a third-party administrator, Danziger & Markhoff, LLP ("TPA"). The TPA aids the Company in the administration of the Plan. All costs associated with such recordkeeping are paid by the Company.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 5 - Plan Merger

On November 1, 2022, the Plan sponsor approved an amendment to merge the Plan into the Summit City MD 401(k) Plan as of November 1, 2022 ("effective date").

During the year ended December 31, 2023, employer contributions receivables, totaling \$45,230, were transferred to the Summit City MD 401(k) Plan.

Note 6 - Income Tax Status

The Internal Revenue Service has determined and informed the Plan administrator by a letter dated August 11, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after December 31, 2023 through October 9, 2024, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
