## **Barrington Venture/The Garlands of Barrington Retirement Savings Plan Notes to the Financial Statements**

---

### **1. Description of Plan**

The following brief description of the Barrington Venture/The Garlands of Barrington Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan name was changed from Barrington Venture/The Garlands of Barrington Retirement Savings Plan to The Garlands of Barrington Retirement Savings Plan through restatement of the previously adopted plan. The effective date of the plan restatement is January 1, 2024.

**General** – The Plan is a defined contribution plan sponsored by Barrington Venture Holding Company LLC (Company) for the benefit of its non-union employees of The Garlands of Barrington, LLC, Garlands Management Services, LLC and The Garlands of Briarcliff Manor, LLC, who are at least 21 years of age, have completed 90 days of employment for full-time employees scheduled to work at least 1,000 hours per year. Other employees may enter the Plan on the entry date coinciding with or next following 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Voya Retirement Insurance and Annuity Company (Voya) serves as Plan custodian.

**Contributions** – The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan provides for automatic enrollment contributions, deferring 2% of eligible compensation, for all eligible employees that do not elect to opt out of the Plan prior to their eligibility date. Contributions are subject to certain limitations.

During 2023, the Plan did not allow for employer contributions. Effective January 1, 2024, the Plan was restated to allow for employer matching contributions at the sole discretion of the Company. The employer matching contribution is subject to a 2 to 6-year graded vesting schedule.

**Participant Accounts** – Each participant's account is credited with the participant's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.00% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** – A participant's account balance may be withdrawn upon retirement, death, disability, or termination of employment as defined by the Plan. Benefits are payable in a single lump-sum amount. In-service withdrawals from rollover contribution accounts, distributions after age 59-1/2 and hardship distributions are also allowed by the Plan.

**Plan Termination** – Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. The termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, all account balances as of the date of termination shall be payable to the participants and beneficiaries.

2. **Summary of Significant Accounting Policies**

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are recorded at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**2. Summary of Significant Accounting Policies (cont'd)**

**Payment of Benefits** – Benefits are recorded when paid.

**Forfeited Accounts** – At December 31, 2023 and 2022, there were \$1,456 and \$1,389 of forfeited accounts, respectively. Forfeited accounts consist of distributions to former participants that were not cashed and returned to the Plan and may be used to reduce administrative expenses as determined by the Plan Administrator. During 2023, no forfeitures were used to pay for plan expenses.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to optional educational and fund selection services are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**CARES Act** – On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act, ('CARES Act'), was passed by Congress. The CARES Act contains several provisions that temporarily impact 401(k) plans.

On August 3, 2022, the IRS issued Notice 2022-33, which extends the deadline for qualified retirement plans to adopt amendments reflecting certain optional and required changes under the SECURE, CARES, and Miners Act. Plan sponsors of defined contribution plans generally now have until December 31, 2025, to amend their plans if they took advantage of benefit changes permitted by these laws, including changes allowed by the CARES Act as part of COVID-10 relief.

Written amendments to the Plan to reflect these operational changes were adopted effective January 1, 2022 in accordance with applicable law and IRS guidance.

**Subsequent Events** – The Plan has evaluated subsequent events through October 8, 2024, the date the financial statements were available to be issued.

**3. Information Prepared and Certified by Custodian**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information prepared by Voya Retirement Insurance and Annuity Company, the custodian, and furnished to the Company. The Company has obtained certifications from the custodian as of December 31, 2023 and December 31, 2022, and for the year ended December 31, 2023, that such information is complete and accurate.

**4. Fair Value of Investments**

Investments at fair value consists of pooled separate accounts which qualify for a practical expedient to value them at net asset value (NAV) per unit. The NAV, as provided by the custodian, is based on the fair value of the underlying investments comprising the pooled separate accounts. The practical expedient is not used when it is determined to be probable that the fund will sell for an amount different than the reported NAV.

All of the Plan's investments recorded at fair value are valued using NAV practical expedient for fair value, and as such are not classified pursuant to the valuation hierarchy. The significant investment strategies and investment balances of pooled separate accounts is as follows as of December 31:

**5. Fixed Income Investment Option**

The Plan invests in one traditional fully benefit-responsive guaranteed investment contract (FBRIC) with Voya Retirement Insurance and Annuity Company (Voya). The contract had a balance of \$394,092 and \$486,655 at December 31, 2023 and 2022, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.00%. Such interest rates are reviewed periodically for resetting.

This contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan, 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA, or 5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, and 4) a material amendment to the agreement without the consent of the issuer.

**6. Tax Status**

The Plan has adopted a prototype profit sharing plan document with an IRS opinion letter dated June 30, 2020, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and has no income subject to unrelated business income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Related Party and Party-in-Interest Transactions**

The Plan has investments in a fixed interest investment contract and pooled separate investment accounts managed by Voya. As Voya is the custodian and recordkeeper for the Plan, these are party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity, which were not covered by revenue sharing. These payments were made to Voya and Hunter Benefits Consulting Group, which provides the optional educational and fund selection services. These are also party-in-interest transactions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
