## **Independent Auditor's Report**

To the Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Troy Corporation Profit Sharing and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **1. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Troy Corporation Profit Sharing and Savings Plan (the “Plan”) are prepared on the accrual basis of accounting.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisers and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan’s gains on investments bought and sold as well as held during the year.

### **Administrative Expenses**

Certain administrative fees of the Plan are paid out of Plan net assets. During the years ended December 31, 2023 and 2022, such expenses totaled \$81,639 and \$95,850, respectively, and are included in the Statements of Changes in Net Assets Available for Benefits.

Certain other expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**2. Description of the Plan**

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan is a combination profit sharing and savings plan. Contributions by the employer pursuant to the profit-sharing provisions of the Plan are at the discretion of the employer. The Plan is qualified under Section 401(a) of the Internal Revenue Code.

Prior to May 1, 2017, non-union employees of the Company and FTI, Inc., Troy Chemical Corporation, Inc., and Troy Corporation affiliated companies who adopted the Plan, who had completed 6 months of service, were eligible to participate in the Plan. Entry into the Plan for eligible employees occurred monthly and was voluntary. Effective May 1, 2017, the Plan was amended to add an Automatic Contribution Arrangement (ACA) at a pre-tax deferral election equal to 2% of compensation if the participant fails to make an affirmative election, applicable for newly eligible participants and to modify the eligibility conditions from 6 months of service to an eligible employee's date of employment. Participants will still enter the Plan on the Entry Date, which is the first of the month following. The Plan is subject to the provisions of ERISA.

Effective January 1, 2022, the Plan was amended and restated.

**2. Description of the Plan (continued)**

**Contributions**

Under the terms of the Plan, allowable contributions are as follows:

**Participant**

A participant may elect to contribute an amount not to exceed 15% of his or her annual compensation (the “Basic Contribution”). On a before-tax or after-tax (“Roth”) basis, compensation is equal to base salary plus bonus. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, contributions from a qualified retirement plan established by a new participant’s previous employer may be “rolled over” into the Plan. Effective May 1, 2017, nonparticipants will be automatically enrolled at a rate of 2% unless they elect otherwise.

**Employer**

For the Plan years ended December 31, 2023 and 2022, the Company matched employee contributions not to exceed 6% of the employee’s compensation (the “Matching Contribution”) in accordance with the following schedule:

**Employer Optional**

The Company may make a discretionary profit-sharing contribution to the Plan in an amount determined by the Company (the “Optional Contribution”). The Company made Optional Contributions of \$700,000 during 2022 that were designated as 2021 Optional Contributions. No Optional Contributions were made by the Company for the 2023 and 2022 Plan years.

**2. Description of the Plan (continued)**

The contribution is allocated based on total compensation plus excess compensation (compensation in excess of the Social Security Taxable Wage Base) to a maximum of 5.7%. Any remaining contribution is allocated in proportion to all compensation.

In order to satisfy nondiscrimination rules of Section 401(k) of the Internal Revenue Code of 1986 (the “Code”), the amount of contributions is limited so as not to exceed the maximum permissible amount for the highly compensated group, as defined in the Code. Individual contributions for which income taxes may be deferred are limited to \$22,500 and \$20,500 in 2023 and 2022, respectively, plus a catch-up contribution of \$7,500 and \$6,500 in 2023 and 2022, respectively, for participants aged 50 and older.

**Vesting**

A participant will always be 100% vested in the value of his or her Basic Contribution and rollover accounts. Vesting in the employer contribution accounts is as follows:

**Investment of Contributions**

Participants may direct their contributions to any of the various investment funds offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's Optional contribution and Plan earnings. Income earned on investments in the Plan is allocated to the participants' accounts quarterly in the ratio that the value of each individual's account bears to the aggregate value of all participants' accounts. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

The Plan is permitted to make loans to participants, subject to certain provisions. In general, loans shall not exceed the lesser of 50% of the vested interest or \$50,000. The loans are secured by the balance in the participant's account. Loans are repaid via automatic payroll deductions in equal installments, one per payroll period, representing a combination of interest and principal sufficient to amortize the loans over their terms. At December 31, 2023 and 2022, the outstanding participant loans bear interest at the Prime Rate plus 1%, with various maturity dates.

**Forfeitures**

Participants who terminate before becoming fully vested forfeit the nonvested portion of their employer contribution accounts. At December 31, 2023 and 2022 forfeited nonvested accounts totaled \$251,678 and \$12,178, respectively. These accounts will be used to pay Plan expenses first, then reduce future employer contributions. During 2023 and 2022, \$80,465 and \$93,026, respectively, of forfeitures were used to pay Plan expenses. Also, in both 2023 and 2022, employer contributions were not reduced by forfeited nonvested accounts.

**Withdrawals**

Prior to termination of employment, the participant may withdraw all or a portion of his or her vested interest, including investment income thereon, when the participant has attained age 59 ½. Withdrawals for financial hardship are permitted upon approval from the plan administrator and are limited to the participant's Basic Contribution amount.

## **2. Description of the Plan (continued)**

### **Distributions**

Upon death, disability or retirement, the participant's balance is distributed in the form of a lump sum payment. Upon termination, the participant may request distribution immediately following termination or immediately after the participant's 65<sup>th</sup> birthday.

### **SECURE Act and CARES Act**

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement ("SECURE") Act was passed, and most provisions in the law became effective on January 1, 2020. The SECURE Act implements key retirement legislation reform for plan sponsors and individuals. These provisions did not have a material impact on the financial obligations under the Plan.

In response to the COVID-19 global pandemic, on March 27, 2020 the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was enacted and signed into law. Certain provisions of the CARES Act impact the operation of retirement plans during 2023 and 2022. These provisions did not have a material impact on the financial obligations under the Plan

On August 3, 2022, the IRS released Notice 2022-33, which extends the deadline for adopting any SECURE Act plan amendments until December 31, 2025, to provide relief for plan sponsors waiting for final IRS guidance on many of the SECURE Act's provisions. The IRS expects SECURE Act guidance to be issued with the 2023 Required Amendment list. The Notice also extends the deadline for the 2020 waiver in the CARES Act of required minimum distributions until December 31, 2025. These amendments can be retroactively adopted; therefore, the Plan can implement the amendments prior to amending the plan instrument. Similarly, plans may have voluntarily adopted provisions under the CARES Act by placing them in operation without amending the plan as long as the plan management makes the required amendments to plan documents by December 31, 2025.

### **SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the SECURE 2.0 Act generally need not be made until the end of the first plan year beginning on or after January 1, 2025; however, plans must be operated in accordance with the effective date of each new provision. There is no current impact to the Plan and these provisions did not have an impact on the financial statements. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

**3. Income Tax Status**

The IRS has determined and informed the Company by a letter dated August 1, 2023, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**4. Investments and Information Certified by the Custodian**

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, plan management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Charles Schwab Bank, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian with information included in the Plan’s financial statements and supplemental schedules:

**5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2     Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Related-Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are shares of funds managed by Charles Schwab Bank. Charles Schwab Bank is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Management believes that fees paid during the year for administrative and managerial services rendered by Charles Schwab Bank and Milliman, the recordkeeper as defined by the Plan, were based on customary and reasonable rates for such services. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Notes receivable from participants are also considered exempt party-in-interest transactions.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the company contribution portion of their account. The value of each participant's account shall be determined and thereafter distributed to each participant in accordance with the provisions of the Plan.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include risks related to pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Delinquent Participant Contributions**

During 2022, there were occurrences when the Plan remitted the salary deferral contributions beyond the required time frame. These transactions are considered nonexempt transactions. The Company has corrected these nonexempt transactions outside of the Voluntary Fiduciary Correction Program ("VFCP"). The Company calculated the lost earnings through the VFCP calculator and reimbursed the Plan for the lost earnings resulting from the untimely remittance of the funds.

**10. Subsequent Events**

At the beginning of 2024, the Plan's assets were transferred from Charles Schwab Bank and Milliman to Reliance Trust Company and ADP Retirement Services.

Effective January 1, 2024, the Plan merged into the Arxada 401(k) Plan.

The Plan has evaluated subsequent events through October 10, 2024, the date which the financial statements were available to be issued.
