We were engaged to perform audits of the financial statements of Dana Kepner Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Dana Kepner Company 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established on January 1, 1992. The plan adoption agreement was amended effective May 1, 2023. The Plan covers Dana Kepner Company and the following subsidiaries, Dana Kepner Company of Wyoming, Inc.; Putnam Pipe Corporation; and The Jack Farrelly Company, which are actively participating employers of the Plan. The Plan is available to employees who have completed one month of service. Plan entry dates are monthly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

Dana Kepner Company is the sponsor of the Plan. The investment committee and board of directors of Dana Kepner Company administer the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") functions as the trustee and custodian. The Trustee manages plan assets and maintains the Plan's records. The Trustee offers plan participants a variety of investment options. Individual accounts are invested in the various investment options at the direction of the participants.

#### **Contributions**

Participants may make before-tax and after-tax contributions up to 100 percent of their annual eligible compensation, as limited by the Internal Revenue Service (IRS), which is adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions.

The Plan provides an automatic enrollment feature deferring 5 percent of eligible compensation upon meeting eligibility requirements unless the participant elects to opt out.

The Plan provides for employer matching contributions of 100 percent of the participant's contribution, not to exceed 5 percent of the employee's deferred compensation.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at loan origination, and mature at various dates through May 2043. Loans have a maximum term of 5 years unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 20 years from the date of the loan origination. Principal and interest are paid ratably through monthly payroll deductions. Participant loans are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's loan shall continue to be payable in accordance with the provisions of the participant's loan or be due in full.

**Note 1 - Plan Description (Continued)**

***Participant Accounts***

Each participant's account is credited or debited with the participant's contributions and withdrawals, as applicable, and allocations of the Company's contributions, plan earnings or losses, forfeitures, and plan expenses. Allocations are based upon plan earnings or losses and account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately 100 percent vested in their voluntary contributions, allocated earnings or losses thereon, and any qualified matching contributions.

Any employer contributions (including forfeitures) and the earnings or losses thereon not fully vested when contributed will vest as follows:

***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump sum, a partial payment, or installment payments in the amount equal to the participant's vested account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. The Plan allows in-plan Roth conversions. Furthermore, the Plan allows for terminated participant vested account balances of \$5,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically distributed to an individual retirement account established for the benefit of the participant. The IRS has required minimum distributions once a participant reaches age 73 during the previous plan year and is no longer employed by the Company.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures are used to reduce future company contributions. Forfeitures in the amount of \$0 were applied to reduce employer contributions during the year ended December 31, 2023. At December 31, 2023 and 2022, forfeited account balances totaled \$35,607 and \$13,272, respectively.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by the Trustee or its affiliates. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

In addition, the Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

**Note 1 - Plan Description (Continued)**

***Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the Trustee shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 28, 2024, which is the date the financial statements were available to be issued.

Subsequent to December 31, 2023, the Plan was amended on March 1, 2024 to include H.R. Prescott & Sons, Inc. and increase the number of outstanding loans held by participants from two to three. The Plan was terminated on March 6, 2024.

**Note 3 - Assets Certified by the Custodian**

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company holds the Plan's investments and notes receivable from participants and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
