(1) **Description Of The Plan**

The following description of Vantage Mobility International, L.L.C. 401(k) and Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants and all others should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution prototype plan covering all eligible employees of Vantage Mobility International, L.L.C. (the "Company") who have attained the age of 21 and have completed 60 days of service within a twelve-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each participant may elect to contribute up to 100% of the participant's compensation, not to exceed IRS limits, and have such amounts contributed to the Plan as before-tax or Roth contributions. These limits amounted to \$22,500 and \$20,500 for the years 2023 and 2022, respectively.

Plan participants who are age 50 or more by the close of the Plan year, may elect to make catch-up elective deferrals up to \$7,500 and \$6,500 per year for the years 2023 and 2022, respectively. These elective deferrals are for eligible participants whose elective deferrals have been restricted by either a statutory ceiling or by a plan limit.

The Company has established a Profit Sharing plan. The rate of matching contributions is determined solely by the Company and any change in the rate is to be communicated to participants prior to the beginning of each Plan year. The amount of the employer contribution is determined by an allocation formula that is generally based on participant earnings, while annual contributions are generally based on the company's profits. No employer contributions were made during the years ending December 31, 2023 and 2022.

The Plan also allows rollover contributions, within IRS parameters, of part or all of a "qualified total distribution" received by a participant from a qualified plan of a previous employer. Rollover contributions into the Plan are 100% vested and non-forfeitable at all times.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollover contributions, plus actual earnings thereon, and rollover contributions.

Any employer contributions and the earnings or losses thereon are subject to the following vesting schedule:

Forfeitures

Forfeited accounts are used to reduce employer contributions and Plan expenses.

Payment Of Benefits

Upon death, disability, attaining normal retirement age (65), or termination of service, a participant will receive a lump-sum payment in the amount equal to the participant's vested account balance or payments in equal installments or a partial withdrawal of no less than \$1,000, within a reasonable period of time after termination of employment. Participants may not make withdrawals from their accounts prior to age 59 1/2, except in the event of death, disability, termination of employment, or notice of hardship, without being subject to certain restrictions and penalties. Upon a distribution event, if a participant's vested account balance is \$5,000 or less, the account will be distributed as soon as administratively possible. Benefits are recorded as distributions to participants when paid.

Hardship Withdrawal

In certain situations, as defined in the Plan agreement and with approval of the Plan administrator, participants may make hardship withdrawals.

Notes Receivable From Participants

The Plan provides that participants may borrow up to a maximum of \$50,000 or 50% of their total vested balance held in the Plan, with a minimum loan of \$1,000 by pledging their total vested account balance as security for the loan. Such loans will be repaid by employee payroll deductions

with a repayment term generally not in excess of five years. Participants are limited to one outstanding loan at any time, and one new loan per year. Principal and interest is paid ratably through bi-weekly payroll deductions. Interest incurred on loans and loan payments are credited to the participant's account.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Fees related to the administration of participants' activities are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

CARES Act

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was signed into law. The CARES Act allows retirement plans to provide participants who are impacted by the coronavirus (as defined in the CARES Act) with greater access to their savings. As permitted by the CARES Act, the Plan opted in to implement the following provisions.

Through December 31, 2020, qualified individuals were permitted to take a distribution in an amount up to \$100,000 from the Plan. Any such distributions were not subject to the 10% early distribution penalty or the mandatory 20% federal income tax withholding rate. Participants who took a qualified distribution had the option to have the distribution taxed over a three-year period, with the ability to re-contribute up to the full amount of the distribution within three years and not be subject to the federal income tax as a result.

(2) Summary Of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use Of Estimates

The preparation of financial statements in conformity with generally accepted accounting in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments Valuation And Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The Plan follows the *Fair Value Measurements And Disclosures* accounting standard, which among other things requires enhanced disclosures about investments that are measured and reported at fair value and establishes a framework for measuring fair value. That framework provides a fair value

hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at their price. The mutual funds held by the Plan are considered to be actively traded.

Common/collective trust funds: The fair value of these pooled groups of assets are based on the NAV (as a practical expedient) calculated by the underlying registered investment companies in which they are invested. The prices of the Collective Investment Trusts ("CITs") are provided and updated daily on Voya's website. Purchases and sales are generally only transacted with the CITs themselves through Voya with few to no restrictions. Each Trust invests in Voya registered investment companies using an assets allocation strategy designed for investors planning to retire and leave the workforce with a few years to the target year. The Plan measures fair values of these investments using the NAV provided by Voya.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Contributions Receivable

Employee contributions receivable arise from employee contributions that are withheld from employee's salary, but have yet to be remitted to the Plan by the Employer. Additionally, employer contributions receivable arise from discretionary matching or profit sharing contributions that are to be remitted to the Plan by the Employer for wages that have been previously paid to employees. The Plan charges off uncollectible receivables when future receipts are deemed probable.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded.

If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan’s management has performed an evaluation of subsequent events through October 14, 2024, which is the date the financial statements were available to be issued and considered any relevant matters in the preparation of the financial statements and footnotes.

(4) Investment Contracts with Insurance Company

The Plan has entered into a traditional fully benefit-responsive investment contract with Voya Institutional Trust Company. Voya Institutional Trust Company maintains the contributions in guaranteed portfolio funds. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya Institutional Trust Company, represent contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2023 and 2022, was \$328,964 and \$519,313, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. The average yield was 2.25% and 2.25% for 2023 and 2022, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Voya Institutional Trust Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or other required prohibited transactions exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan's administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The contract does not permit Voya Institutional Trust Company to terminate the agreement prior to the scheduled maturity date.

(5) Forfeited Non-Vested Amounts

During the years ended December 31, 2023 and 2022, \$15,939 and \$45,576 respectively, of forfeited amounts were used to reduce employer contributions and administrative expenses to the Plan. As of December 31, 2023 and 2022, the forfeited nonvested accounts amounted to \$7 and \$12,387, respectively.

(6) Plan Termination

Although the Company intends to continue the Plan and to make regular contributions, the Company reserves the right to terminate the Plan at any time, and its continuance is not guaranteed. The Company also has reserved the right to amend or otherwise modify the Plan, or to discontinue any further contributions or payments under the Plan, by a resolution of its members. In the event of the Plan's termination, participants would become fully vested in their employer contributions.

(7) Income Tax Status

The Plan has adopted a prototype plan under Voya Retirement Insurance and Annuity Company. The prototype plan received a notification letter from the Key District Director having jurisdiction with the Plan. The Revenue Service permits the employer to rely on the notification letter. Therefore, the employer will not submit the Plan to the Internal Revenue Service for an advance determination as to whether the Plan meets the qualification requirements of section 401 of the

Internal Revenue Code of 1986 with respect to the Plan's initial qualification.

The prototype plan has been amended since receiving the determination letter. However, the plan administrators believes the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC. The Plan follows *Accounting for Uncertainty in Income Taxes* accounting standard which requires the Plan to determine whether a tax position (and the related tax benefit) is more likely than not to be sustained upon examination by the applicable taxing authority, based solely on the technical merits of the position. The tax benefit to be recognized is measured as the largest amount of benefit that is greater than fifty percent likely of being realized upon settlement, presuming that the tax position is examined by the appropriate taxing authority that has full knowledge of all relevant information. During the years ended December 31, 2023 and 2022, the Employer evaluated its tax positions to determine the existence of uncertainties, and did not note any matters that would require recognition or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan is no longer subject to U.S. federal tax audits on its Form 5500 by taxing authorities for years ending prior to December 31, 2020. The years subsequent to this year contain matters that could be subject to differing interpretations of applicable tax laws and regulations. Although the outcome of tax audits is uncertain, the Plan believes no issues would arise.

(8) Financial Data Certified By The Investment Company Administered Trust Fund

The plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA for the year ended December 31, 2023. Accordingly, as permitted under such election, Voya Retirement Insurance and Annuity Company, the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2023 and 2022.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2023. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(9) **Party-in-Interest Transactions**

Plan investments are managed by Fiduciary Benefits Group, Inc. and NFP Retirement Inc.. Fees paid by the Plan to Fiduciary Benefits Group, Inc. and NFP Retirement Inc., for investment management services were included as a reduction of the return on each fund and additional management fees in the amount of \$7,309 and \$12,272, respectively. Voya Retirement Insurance and Annuity Company who is the custodian as defined by the Plan was paid \$19,932 for custodial and record keeping services. These transactions qualify as party-in-interest transactions.

These transactions qualify as party-in-interest transaction and are exempt from the prohibited transaction rules of ERISA.

(10) **Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in the U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.
