**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Axim Geospatial Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

On December 29, 2023, Plan assets were transferred to NV5, Inc. 401(k) Plan, consistent with the merger of the plans effective January 1, 2024. The Reliance Trust Company and ADP Retirement Services are the successor Trustee and administrative plan services record-keeper for the assets in the Plan merging into the NV5, Inc. 401(k) Plan. The Plan sponsor is a wholly owned subsidiary of NV5 Inc. upon its acquisition in 2023.

**Participating Companies**

The following Companies, which are related parties, are participating employers in the Plan:

Axim Geospatial LLC  
Geographic Information Services, Inc.

**General**

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Employees are eligible to participate in the Plan after completing 2 months of service and attaining the age of 18. Entry dates for employee contributions are the first of the month coinciding with or next following completion of eligibility requirements.

**Contributions**

Each year, participants may contribute amounts up to the allowable limits established by the Internal Revenue Service. Upon satisfying eligibility requirements, participants are automatically enrolled at 6% unless electing otherwise. Participants may also contribute rollover amounts from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company has also elected to make QACA safe harbor matching contributions based upon a percentage of each participant's eligible compensation, contributed to the Plan as deferral contributions. The safe harbor contribution was 100% of salary deferrals up to the first 1% of Plan compensation, plus 50% of salary deferrals up to the next 5% of Plan compensation. Company contributions also consisted of a discretionary profit-sharing contribution. No such discretionary contribution was made for the year ending December 31, 2023.

**Forfeitures**

Forfeitures attributable to matching and profit-sharing contributions can be used pay Plan expenses or to reduce future Company contributions. For 2023, \$130,000 of forfeitures were used to reduce employer contributions and \$9,390 of forfeitures were used to pay Plan expenses. Amounts available for future use as of December 31, 2023 and 2022, were \$0 and \$134,706, respectively.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based upon participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's QACA Safe Harbor contributions is based on years of service, and participants are 100% vested after two years. A participant is 100% vested in the Company's profit-sharing contribution after six years of credited service.

**Participant Notes Receivables**

Participants may borrow from employee sources only a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through payroll deductions.

**Benefit Payments**

Upon death, disability, termination of service or normal retirement date, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the value of the participant's vested balance. Participants who are 59 ½ years old may make withdrawals from their vested account balance prior to termination of employment. Participants who have an approved hardship need may withdrawal from their participant deferral account balance. Benefit payments are recorded when paid.

**Plan Termination**

On December 21, 2023, the Board of Trustees of the Plan, voted to merge the Plan effective January 1, 2024, into the NV5, Inc. Plan, which is the successor plan. In connection with the merger and immediately prior to the transfer of the plan assets to the successor plan, all participants' account balances became 100% vested.

**Recently Issued Pronouncements**

Recent accounting pronouncements issued by the Financial Accounting Standards Board (FASB) (including technical corrections to the FASB's Accounting Standards Codification), and the American Institute of Certified Public Accountants did not, or are not, expected to have a material effect on the Plan's net assets available for benefits or changes in net assets available for benefits.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's policy is to prepare its financial statements on the accrual method of accounting.

**Contributions**

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Valuation of Investments**

The Plan's investments are stated at fair value, except for the Voya Fixed Account which is stated at contract value. Purchase and sales of securities are recorded on the trade-date basis. Dividend income is recorded on the ex-dividend date.

**Investment Contracts**

The Voya Fixed Account is a benefit-responsive investment contract. Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions to Voya Institutional Trust Company (Trust) under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the Trust. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90 days' notice to the Trust prior to redemption of the contract.

**Investment Contracts**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**Fair Value Measurements**

ASC 820, *Fair Value Measurements and Disclosures*, defines fair value, establishes a framework for measuring fair value and enhances disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (or exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the inputs that market participants would use in pricing the asset or liability and are developed based on the best information available in the circumstances.

The fair value hierarchy input levels are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Management Evaluation of Subsequent Events**

The Company has evaluated subsequent events through October 14, 2024, the date on which the financial statements were available to be issued.

**NOTE 3 - PARTICIPANT DIRECTED INVESTMENTS**

Participant contributions held in the Plan are participant-directed accounts. That is, individual participants decide how funds held in trust for them are allocated among various investment options.

**NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements are complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**NOTE 5 - TAX STATUS**

The Plan has adopted a volume submitter plan and received an opinion letter dated November 30, 2020, stating the volume submitter plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code. Axim Geospatial Retirement Plan has not requested a separate determination letter. The Plan has been restated since receiving the opinion letter; however, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Authoritative accounting standards require the Plan to examine its tax positions for uncertain positions. Management is not aware of any tax positions that are more likely than not to change in the next 12 months or that would not sustain an examination by applicable taxing authorities.

The Plan's policy is to recognize penalties and interest as incurred in its statement of changes in assets available for benefits.

**NOTE 6 - ADMINISTRATIVE EXPENSES**

Administrative expenses paid from the Plan represent asset recordkeeping and professional fees, which amounted to \$57,321 for the year ended December 31, 2023. The Company pays all other significant Plan expenses.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. In 2022, the Plan held a guaranteed interest contract managed by Voya Retirement Insurance and Annuity Company (Voya). Voya is the Plan custodian and, therefore, these transactions and the Plan's payment of fees to Voya qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 8 - FAIR VALUE MEASUREMENTS**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

*Money market funds:* Valued at the net asset value of shares held by the Plan at year end.

*Registered investment companies:* Valued at the daily closing price as reported by the underlying fund, which is traded on a national exchange.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in valuation methodologies at December 31, 2023 compared to December 31, 2022. The Company's policy is to recognize transfers between levels at the end of each reporting period, if applicable.
