NOTE A.--DESCRIPTION OF PLAN

The following description of the Utility Trailer & Equipment Sales, NW, LLC (Company or Plan Sponsor) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) and profit sharing plan originally established by the Company effective January 1, 2003 and most recently restated January 1, 2022 as part of a cycle 3 restatement period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company except union employees and non-resident aliens. An employee is eligible to make elective deferrals after attaining age 18, to receive any flexible discretionary employer matching contributions after completing 1,000 hours of service and having attained age 18, and to receive qualified non-elective contributions after completing 1,000 hours of service, having attained age 18, as well as be employed on the last day of the Plan year. The entry date for purpose of elective deferrals is on the date eligibility requirements are met. The entry date for purpose of discretionary employer match and qualified non-elective contributions is the first day of each month following completion of eligibility requirements.

Contributions: The Plan is funded by eligible participant elective deferrals which may range from 1% to 100% of eligible compensation, discretionary employer matching contributions, and qualified non-elective contributions. Participants without an affirmative deferral election will be automatically enrolled with a 1% deferral.

Qualified non-elective contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Participants must be employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year to be eligible to receive any qualified non-elective contributions, unless the participant dies, becomes disabled or reaches the normal retirement age. There were no discretionary matching or qualified non-elective contributions in 2023.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their future deferrals as Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Contributions are subject to certain limitations.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, an allocation of plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants are immediately vested in their rollover contributions and elective deferrals plus actual earnings thereon. Vesting in any Company discretionary contributions is based on years with continuous service. A participant is 20% vested after 2 years of credited service, 40% after 3 years, 60% after 4 years, 80% after 5 years, with full vesting at six years. Participants also become fully vested upon death or disability.

Retirement: The normal retirement date is the date the participant turns 59 ½ and for qualified reservist distributions. Early retirement is not permitted.

Payment of Benefits: On termination of service due to disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or if such balance is greater than \$5,000, a participant may elect to receive a lump-sum amount or installments over their lifetime as soon as administratively feasible, or partial withdrawals of at least \$1,000. Upon death of a participant, if death benefit is less than \$5,000, payments made to a beneficiary shall be payable in a lump sum. If death benefit is more than \$5,000, payments made to a beneficiary shall be payable in a lump sum or partial withdrawals or installments over a period of not more than the assumed life expectancy of the beneficiary.

For terminated participants, if the balance of the vested accounts is \$1,000 or less, payment may be made in a lump-sum without the participant's consent. If such balance is greater than \$1,000 but less than \$5,000, the participant will receive a lump-sum amount. In-service distributions are allowed at age 59 ½. Hardship distributions are allowed in accordance with Plan provisions. Distributions may be taken from contributed rollover amounts at any time.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balances in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund.

Notes Receivable from Participants (Continued): All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed thirty years. The loans are to bear a rate of interest based prime rate plus one percent. A participant may only have one loan outstanding at any time. Principal and interest are paid through payroll deductions.

Forfeited Accounts: Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and shall be used to restore forfeitures or reduce Company contributions or pay plan expenses. At December 31, 2023 and 2022, forfeited accounts totaled \$0. There were no forfeitures in 2023.

Investment Options: Participants are allowed to direct their contributions and account balances in a variety of investment options including mutual funds and collective trust fund. The Plan Sponsor periodically reviews the investment options available to participants and changes them as warranted. Participants may change their investments at any time.

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid for directly by the Company and are not included in these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses, including revenue sharing fees and 12(b)(1) fees, as applicable, are deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by investment advisors, custodian and trustee. See Note D for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued): Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, dividend income and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Benefit Trust Company, the custodian of the Plan.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at NAV of units held by the Plan at year end. The NAV, as provided by the trustee and custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a collective investment is calculated based on a compilation of primarily observable market information. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by the trustee and custodian, Benefit Trust Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. Certain employees of the Company serve as trustees of the Plan. No such officer or employee receives compensation from the Plan.

NOTE F.--TAX STATUS

The Plan was amended and restated effective January 1, 2022 and adopted a non-standardized pre-approved profit-sharing/money purchase plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan, including employer contributions, shall become fully vested and non-forfeitable.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE I.--EXCESS CONTRIBUTIONS

Contributions received for 2023 and 2022 of \$7,784 and \$5,540 were distributed in 2024 and 2023, respectively, to a certain active participant to return excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan.
