INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Better Place Forests 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

Emphasis of Matter – Plan Merger

As described in Note 1 to the financial statements, the Plan sponsor's Board of Directors resolved on April 1, 2024 to merge the Plan into a multiple-employer plan offered by Sequoia One, PEO, LLC. On April 15, 2024, Plan assets totaling \$2,165,420 were transferred to the Sequoia One 401(k) Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Better Place Forests 401(k) Plan Notes to Financial Statements

1. Description of the Plan

Better Place Forests Co. (the Company) established the Better Place Forests 401(k) Plan (the Plan), effective July 1, 2020, to provide participants with a means to fund their retirement on a tax-deferred basis. The Plan was amended and restated most recently as of December 15, 2021.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under Sections 401(a) and 401(k) and related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees, who are responsible for selecting investment options offered under the Plan and monitoring investment performance. Ascensus Trust Company (Ascensus) is the Plan's trustee. Ascensus holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries. The Vanguard Group, Inc. (Vanguard) is the Plan's recordkeeper, and Vanguard, through Vanguard Retirement Plan Access, has contracted with Ascensus, LLC to provide the recordkeeping services.

Plan Merger:

The Company's Board of Directors resolved on April 1, 2024 to merge the Plan into a multiple-employer plan offered by Sequoia One, PEO, LLC. On April 15, 2024, Plan assets totaling \$2,165,420 were transferred to the Sequoia One 401(k) Plan.

Contributions:

Participants are permitted to make voluntary pre-tax and Roth post-tax contributions up to 100% of their annual eligible compensation, as defined in the Plan agreement. Participants that have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

Better Place Forests 401(k) Plan Notes to Financial Statements

1. Description of the Plan (continued)

Contributions: (continued)

The Plan provides for automatic enrollment on the date participants became eligible for the Plan. The automatic pre-tax salary deferral contribution is 5% of their eligible compensation, as defined by the Plan agreement, unless the participants request a different amount to be contributed or formally decline participation. If the participant is automatically enrolled, the deferral contribution rate will be increased by 1% each year until a maximum of 10% of compensation is reached, unless the participants elect otherwise. Participants can adjust the deferral rate or discontinue contributions at any time.

The Company may make discretionary nonelective contributions to the Plan, as determined by the Board of Directors. The Company has not made any discretionary contributions to the Plan through December 31, 2023.

Contributions are subject to certain limitations under the Code.

Eligible Participants:

Eligible employees, as defined by the Plan agreement, may begin participating in the Plan upon the first day of each month following employment.

Participant Accounts:

Participant accounts are credited with participant contributions, Company contributions (if any), and an allocation of Plan earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant account balances.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are fully (100%) vested in their account balances.

1. Description of the Plan (continued)

Notes Receivable from Participants:

Participants can borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to acquire a principal residence for which terms up to thirty years may be granted. Participants can only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the balance in the participant's account, and bear interest at the prime rate, as published in The Wall Street Journal, plus 1%. The interest rate on the note outstanding as of December 31, 2023 was 4.25%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Payment of Benefits:

Upon termination of employment, participants may elect to receive an amount equal to the value of their account balance. Benefits are paid in a lump-sum cash distribution equal to the value of the participant account balance. Upon termination, the Plan may immediately elect to distribute participant account balances without the participant's consent if the balance is \$5,000 or less. For distributions between \$1,000 and \$5,000, the account balances will be rolled into individual retirement accounts on behalf of the participants. Distributions for account balances less than \$1,000 will be in the form of a check. Benefits are recorded when paid.

Administrative Fees:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Advisory services, as well as certain investment, account maintenance, benefit payment, and note fees may be paid by the Plan and charged to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

The Plan offers a variety of investment options to participants. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

Investments consist of mutual funds and a money market fund. These funds are reported at fair value, which is the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement: (continued)

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's investments are classified as Level I within the fair value hierarchy as of December 31, 2023 and 2022.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

Liability for Corrective Distributions:

The liability for corrective distributions as of December 31, 2023 represents contributions made by several participants in 2023 that must be refunded in order for the Plan to be in compliance with applicable non-discrimination tests. The liability was \$20,810 as of December 31, 2023 and was refunded in 2024.

4. Income Tax Status

The Plan is a pre-approved plan offered by Ascensus, LLC. The Internal Revenue Service (IRS) has determined and informed Ascensus, LLC by a letter dated June 30, 2020, that the plan submitted for review was qualified under applicable provisions of the Code. The Plan has been amended since receipt of the letter. The Plan and the Plan sponsor believe the Plan is being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is subject to income tax examinations for all Plan years since inception.

5. Party-In-Interest Transactions

Certain Plan investments are managed by Vanguard. As Vanguard is the Plan's record keeper, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Subsequent Events

As discussed in Note 1, the Plan was merged into the Sequoia One 401(k) Plan on April 15, 2024.

Subsequent events have been evaluated through October 11, 2024, which is the date the financial statements were approved by the Plan and available to be issued.
