### Notes to Financial Statements

---

#### 1. Description of Plan

The following description of the Hampton Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### General

The Plan was a defined contribution plan covering all U.S. employees of the operating subsidiaries of Hampton Resources, Inc. (the “Company” and “Plan Sponsor”), who completed 90 days of service, other than hourly employees, whose principal work location was a sawmill. The Plan operated under the provisions of Section 401(a) of the Internal Revenue Code (the “IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan’s administrator was appointed by the chief executive officer of the Company and was responsible for administration of the Plan. Additionally, the Plan’s administrator made decisions on the addition or removal of the Plan’s investment offerings and monitors investment performance.

##### Plan merger

Effective December 31, 2023, the Plan was merged into the Hampton Lumber Mills Hourly Retirement Plan. Effective January 1, 2024, the merged plan was restated and became the Hampton Lumber Retirement Plan.

##### Plan amendment

The Securing a Strong Retirement Act (“SECURE 2.0 Act”) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. Written amendments to the Plan related to the SECURE 2.0 Act, as applicable, will be drafted in accordance with applicable law and regulatory guidance.

##### Contributions

Each year, participants were able to contribute up to the maximum set by the IRC, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were able to contribute after-tax ROTH elective deferrals to the Plan, as allowed by the IRC. Participants were also able to contribute amounts representing distributions from other qualified plans, as defined in the Plan agreement. Participants directed the investment of their contributions and any employer contributions into various investment options offered by the Plan. The Plan offered various registered investment companies and a stable value collective trust fund as investment options for participants. The Plan included an auto-enrollment provision, whereby all newly-eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan.

Automatically enrolled participants had their rates initially set at 5% of eligible compensation with annual increases of one percentage point until 15% is reached. Accounts of automatically enrolled participants were invested in a designated default fund. Deferral percentage or investment elections could be changed by participants at any time. The Company matched 100% of the first 1% contributed by the participant and 25% of the next 4% contributed to the Plan.

The Company also made fixed contributions to the Plan of 5% of each participant’s annual eligible compensation. The Plan also allowed for the Company to make additional discretionary contributions to be allocated based on participant's annual eligible compensation. There were no additional discretionary contributions for 2023 and 2022. All contributions were subject to certain limitations set by the IRC.

**1. Description of Plan (continued)**

**Contributions (continued)**

Eligible employees must be employed on the last day of the Plan year to receive a fixed or discretionary contribution, unless participation ends due to death, disability, normal retirement or plant/shift shutdowns. Additionally, employees must complete 1,000 hours of service during the Plan year to receive a fixed or discretionary contribution unless terminated due to a plant/shift shutdown.

**Participant accounts**

Each participant's account was credited with the participant's contributions and the Company's contributions, as well as an allocation of forfeitures and Plan earnings, and charged with an allocation of certain administrative expenses. Allocations were based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

**Vesting**

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participant accounts was based on years of service. A participant was 100% vested after three years of credited service or upon the occurrence of certain unusual or significant events as defined in the Plan agreement.

**Notes receivable from participants**

Participants who were active employees may borrow against their vested account balances a minimum of \$500 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, were secured by the vested balances in the participant's account and bore interest at reasonable rates ranging from 4.25% to 9.50%, which were commensurate with local prevailing rates. Principal and interest were paid ratably through payroll deductions and generally repaid within five years.

**Benefits paid to participants**

On termination of service due to disability or retirement, participants may elect to receive either a lump sum amount equal to the value of the participants' vested interest in their accounts or monthly, quarterly, annual or semi-annual installments over a number of years specified by the participants. For terminations of service due to death or for other reasons, participants may receive the value of the vested interest in their accounts as a lump sum distribution.

**Forfeited accounts**

In accordance with the Plan agreement, forfeitures were first applied to prior forfeiture restorations under the Plan's break-in-service rules and then the remaining forfeitures in a given plan year were allocated based on participant account balances at the end of the respective plan year and funds were credited to the participants' accounts subsequent to the end of such plan year. During 2023 and 2022, forfeitures allocated to participants, including restored forfeitures, were approximately \$13,000 and \$28,000.

## 2. Summary of significant accounting policies

### Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are included in the loan withdrawal and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make scheduled loan repayments and the Plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

### Payment of benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the origination of notes receivable from participants are charged directly to the participant's account and are included in the loan withdrawal. Fees for investment advisory services and annual administration of notes receivable from participants are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### Subsequent events

The Plan has evaluated subsequent events through October 11, 2024, which is the date these financial statements were available to be issued. Events, if any, are disclosed in the notes to these financial statements.

**4. Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

**Level 2:** Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**4. Fair value measurements (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2023 and 2022:

*Registered investment companies:* Valued at the net asset value (“NAV”) of shares held by the Plan at year end based on quoted market prices.

*Stable value collective trust fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at NAV, which is calculated by discounting the related cash flows and the fair values of the underlying investments and the wrapper contracts using a discounted cash flow model that considers recent fee bids as determined by recognized dealers, discount rate and the duration of the underlying portfolio securities and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Related party transactions and transactions with parties-in-interest**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (“TPA”), investment managers, investment advisors, legal counsel and Plan auditor.

During the years ended December 31, 2023 and 2022, the Plan made direct payments of approximately \$76,000 and \$65,000 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**6. Tax status**

The Plan Sponsor adopted a plan which received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated October 2, 2017, which states that the Plan, as then designed, was in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust was tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator analyzed the tax positions taken by the Plan and concluded, as of December 31, 2023, there are no uncertain positions taken. The Plan has recognized no interest or penalties related to uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.
