INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the HMH 401(k) Savings Plan – Health Ventures

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the HMH 401(k) Savings Plan – Health Ventures, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements of the HMH 401(k) Savings Plan – Health Ventures performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Plan management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that Plan management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the HMH 401(k) Savings Plan – Health Ventures and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the ability of the HMH 401(k) Savings Plan – Health Ventures to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal control of the HMH 401(k) Savings Plan – Health Ventures. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by Plan management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the ability of the HMH 401(k) Savings Plan – Health Ventures to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the HMH 401(k) Savings Plan – Health Ventures (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, which was created and became effective January 1, 2019, is a defined contribution plan operating under Section 401(k) of the Internal Revenue Code (“IRC”) and sponsored by Hackensack Meridian Health, Inc. (“HMH” or the “Network”). Effective January 1, 2021, the Plan was amended and restated. The Plan is subject to the provisions of ERISA, as amended.

Effective December 31, 2023, HMH adopted resolutions to, among other matters, merge the assets of the Plan with and into the HMH 401(k) Savings Plan.

As a result, net plan assets of \$47,437,954 were transferred from the Plan to the HMH 401(k) Savings Plan. Due to the nature and timing of the transfer, the assets were still held at December 31, 2023 and were physically transferred subsequent to December 31, 2023. However, due to the merger of the Plan, all assets, liabilities and participants ceased to be part of the Plan; were considered to be due to the HMH 401(k) Savings Plan on December 31, 2023; and are reflected in the accompanying financial statements as “Due to affiliated plan” as of December 31, 2023.

For Form 5500 purposes, all assets, liabilities and participants also ceased to be part of the Plan as of December 31, 2023 and such amounts are reported as zero on the December 31, 2023 Form 5500.

Eligibility

Eligible employees are able to participate in the Plan as soon as administratively possible following their hire date. Non-resident aliens who have no earned income from sources within the United States and leased employees are ineligible to participate in the Plan. Temporary employees are excluded unless they complete one year of service. Employees who are employed as a result of a Section 410(b)(6)(C) transaction (asset or stock acquisition) are included in the Plan for a transition period beginning on the date of acquisition and ending on the last day of the next Plan year.

Employees of the following entities are excluded from participation in the Plan: Carrier Clinic; Meridian Medical Group (Retail Clinic PC, Faculty Practice PC, Specialty Care PC, Meridian Trauma Associates, Primary Care PC, Pediatric Urology PC); HMH Hospitals Corporation; Hackensack Meridian Ambulatory Care, Inc., formerly known as HMH Residential Care Inc., (Wall, Shrewsbury/Union); Jersey Shore (“JS”) Medical Associates PC; Allergy & Pediatric Associates of New JS PC; Ear, Nose, Throat & Facial Plastic Surgery Associates PC; JS Bethany Pediatrics PC; JS Navesink Pediatrics PC; JS Associates in Internal Medicine of Marlboro PC; JS Monmouth County Associates, PC; Hackensack Meridian Health Foundation; Meridian Pediatric Surgical Associates PC; Hackensack Meridian Urgent Care PC; JS Monmouth Family Medicine Group PC; HUMC Cardiovascular Partners PC; Hackensack University Medical Group PC; HUMC Primary Care Associates PC; New Amsterdam Medical Associate PC; JS Monmouth Family Medicine Group PC; JFK Medical Associates PA; Palisades Child Care Center Inc; Shore Rehabilitation Institute Inc; HMH HUMC Grandfathered Pension; HMH PMC Grandfathered Pension; Quality Care Management LLC; Health Village Imaging LLC; and Alert Ambulance Services, Inc.

For purposes of clarity, employees of the following entities are eligible for participation in the Plan: Health Innovations Unlimited; Shore Care; Hackensack Meridian Ambulatory Care, Inc., formerly known as HMH Residential Care Inc., (Meridian Home Care, JFK Meridian Home Care Services, Ocean Grove, Willows, Bayshore, Brick, Shrewsbury, Harborage, Cedar Brook, Whispering Knolls); Hartwyck at Oak Tree Inc.; Hartwyck at Edison Estates; VHSNJ at Home LLC; HMH Ventures Inc.; and Majestic Rehabilitation and Nursing Center at Red Bank.

Contributions

Each year, participants may contribute a minimum of 1% up to a maximum of 70% of their pretax compensation, as defined in the Plan document. Participants may also designate contributions as Roth contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make additional “catch-up contributions”. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Network will make fixed, tiered matching contributions equal to a uniform percentage of each tier of each participant’s elective deferrals. Each tier represents the amount of the participant’s applicable contributions that equals the specified percentage of the participant’s compensation as follows: (i) the first tier matching percentage is 100% of elective deferrals equal to 3%, and (ii) the second tier matching percentage is 50% of elective deferrals equal to 2%. The employer match will be made each pay period for full-time and part-time team members scheduled to work more than twenty hours per week, and for per diem team members.

There is a subset of employees (Meridian Cash Balance Frozen DB Plan employees) who are eligible for an additional 3% transition credit employer nonelective contribution that is calculated and contributed annually and subject to 3-year cliff vesting. To be eligible for this additional employer contribution, a Meridian Cash Balance Pension Plan participant must be at least age 50 with at least 10 years of service as of December 31, 2018. The transition credit ends on January 1, 2029 or when an employee terminates, whichever happens first. To receive non-elective contributions, unless they retire, become disabled, or die during the Plan year, participants must be employed on the last day of the Plan year and work 1,000 hours during the Plan year.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Network matching contributions, Network nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefits to which a participant is entitled are the benefits that can be provided from the participant’s vested account.

Vesting

Participants are fully and immediately vested in their own contributions, rollover contributions and actual earnings thereon. Participants become fully vested in the Network’s matching and nonelective contributions after three years of service.

Notwithstanding the above vesting for the Network’s matching and nonelective contribution, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (65), early retirement age (55 with 10 years of service), death or disability while an employee, as defined in the Plan document.

Forfeited Accounts

When certain terminations of participants in the Plan occur, the nonvested portion of the participant’s account, as defined, represents a forfeiture. Forfeitures may be used to reinstate previously forfeited accounts, to pay Plan expenses or to reduce employer contributions. The unallocated forfeiture balance was approximately \$42,000 and \$38,000, as of December 31, 2023 and 2022, respectively. During 2023, forfeitures of approximately \$41,000 were used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account balance. Generally, the minimum loan amount is \$1,000. Loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1% as of the date of the loan initiation. All loans are directly from the participant’s accumulations of elective deferral contributions and rollover contributions. Note terms range from one to five years or up to twenty years for the purchase of a primary residence. A participant may

only have two loans outstanding at any time. Loans are repaid directly by the participant to the Plan trustee. As of December 31, 2023, 2023 (before being transferred to the HMH 401(k) Savings Plan) interest rates on notes receivable from participants were 4.25% to 9.50% with maturities through 2032.

Payment of Benefits

Participants may elect to receive the vested portion of their account starting at age 59-1/2 without any penalty or upon the date on which the participant terminates employment with the Network. Hardship withdrawals are permitted for circumstances defined in the Plan document. In addition, minimum payments must begin subject to Internal Revenue Service (“IRS”) guidelines.

Participants are entitled to receive the full amount credited to their individual retirement accounts primarily in the form of a lump sum or partial withdrawals. No more than five distributions may be made to a participant during a Plan year. Provisions are also made for death, disability and termination benefits.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contracts and their related activity on a contract value basis (see Note 5).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s investment committee determines the Plan’s valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Income generated from revenue sharing agreements is reported in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

The Plan is required to return contributions received during the Plan year in excess of the IRC limits. As of December 31, 2023 and 2022, the Plan had excess contributions. Such excess contributions are recorded as a liability with a corresponding reduction to contributions. The 2023 and 2022 excess contributions were distributed to the applicable participants during 2024 and 2023, respectively.

Contributions

Contributions from Plan participants and the matching contributions from the Network are recorded in the year in which the employee contributions are withheld from compensation. Employer nonelective contributions are recorded in the year in which the related participant compensation was earned.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

All reasonable administrative expenses and fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Network. Expenses of maintaining the Plan that are paid directly by the Network are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institutions

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)3(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Teachers Insurance and Annuity Association ("TIAA") and College Retirement Equities Fund, insurance companies and qualified institutions, which control TIAA Trust, N.A., successor to TIAA, FSB, trustee and qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contracts, at contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment activity, including net appreciation in fair value of investments, dividend and interest income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2023 and 2022.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Contracts with Insurance Companies

The Plan holds the Teachers Insurance and Annuity Association ("TIAA") Stable Value Fund, a traditional investment contract. This fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings less participant withdrawals, and administrative expenses.

The fund is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. As of December 31, 2023, the high credit ratings of Teachers Insurance and Annuity Association and College Retirement Equities Fund uphold its ability to meet obligations set forth in contracts.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. No events have occurred or are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

As part of the merger of the Plan with and into the HMH 401(k) Savings Plan, the fully benefit-responsive investment contracts, at contract value as of December 31, 2023 were transferred to the HMH 401(k) Savings Plan.

6. Risks and Uncertainties

The Plan provides for various investment options in any combination of registered investment companies (mutual funds) and a guaranteed annuity contract monitored by affiliates of the trustee. Investment securities are exposed to various risks; such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

7. Related Parties and Party-in-Interest Transactions

Certain Plan investments are managed by affiliates of the insurance companies and trustee, and therefore, these transactions qualify as party-in-interest transactions. The Plan also issues participant loans to its participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Network. No such officer or employee receives compensation from the Plan.

8. Plan Termination

The Network has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated or upon complete discontinuance of contributions, the rights of the participants in the Plan at the date of termination or discontinuance shall be nonforfeitable.

9. Tax Status

Effective January 1, 2021, the Network adopted TIAA's Non-Standardized Defined Contribution Pre-Approved Plan. The IRS issued an opinion letter, dated October 7, 2020, stating that the pre-approved plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

10. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued.
