Opinion

We have audited the financial statements of Phillips Precision Inc. Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), and the related notes to the financial statements.

Basis for Opinion

As a result, in accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF PLAN

The following description of Phillips Precision Inc. Pension Plan (the "Plan") provides only general information. For a more complete description of the Plan's provisions, refer to the Plan document.

General

The Plan is a nonparticipant-directed defined contribution plan covering all eligible employees of Phillips Precision Inc. and its wholly-owned subsidiary, Mediacraft, Inc. (collectively, the "Sponsor" or the "Company"), who are age 21 or older, have completed at least one year of service in which an employee worked 1,000 hours, and are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Termination

On October 27, 2023, the Plan has agreed to a merger agreement into another Plan of the same sponsor. The Plan merged into the other Plan Sponsor Plan by December 31, 2023. The Plan has transferred all remaining balances of the participants directly into the other Plan.

Effective with the Plan's termination, all participants with an account balance remaining in the Plan were given the option, based on their eligibility, to either a) roll over their balance to the Phillips Precision, Inc. 401(k) Plan, b) roll over their balance to another qualified retirement account or c) take a distribution in cash. All administrative expenses related to liquidation were paid directly by the Plan; therefore, no reserve for liquidation costs were recorded as of December 31, 2023 and 2022. At various times during 2023, investments were sold and proceeds were held as cash and cash equivalents to facilitate the payment of benefits to participants. Benefit payments of \$4,485,715 were paid at various dates during 2023. After all benefit payments and administrative expenses were paid by the Plan based on the participant's request, the remaining Plan assets of \$1,720,937 were transferred to the Phillips Precision, Inc. 401(k) Plan during December 2023.

Contributions

Sponsor contributions to the Plan are made at the discretion of the management of the Company subject to amounts allowable under the Internal Revenue Code (the "IRC"). Participants may also contribute amounts representing distributions from other qualified plans.

Participants' Accounts

Each participant's account is credited with an allocation of the Company's contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions from distributions from other qualified plans plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings thereon is based on years of continuous service. A participant is vested based on the following vesting schedule:

Participant Distributions

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than their assumed life expectancy as determined at the time of distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. As of August 1, 2023, participants who had reached the age of 55 years are eligible to receive an in-service distribution.

Forfeited Accounts

At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$11,125 and \$2,098, respectively. These amounts are redistributed to the remaining eligible participants at the same time as the employer contribution allocation.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the decision to terminate the Plan effective October 27, 2023, at which time liquidation was deemed to be imminent, and in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), the Plan's financial statements as of and for the year ended December 31, 2023, are presented using the liquidation basis of accounting. For the period prior to the decision to terminate the Plan, the financial statements were prepared using the ongoing basis of accounting.

Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no material changes to the 2023 financial statements as a result of the change under the liquidation basis of accounting.

All investments of the Plan are stated at fair value (the estimated net realizable cash value for investments as of December 31, 2023, are equivalent to fair value). Purchases and sales of investments are recorded on a trade-date basis. The cost of plan investments sold is determined by the average cost method. Distributions are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Company.

Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Under this standard, fair value is defined as the exit price, or the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2024, the date on which these financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under FASB ASC 855, *Subsequent Events*.

3. RISKS AND UNCERTAINTIES

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

4. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor's Rules and Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan Sponsor.

Certain Plan assets consist of cash and money market funds managed by Raymond James (the "Custodian"). Accordingly, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Custodian for investment management services provided to the Plan amounted to \$53,150 and \$39,323 for the years ended December 31, 2023 and 2022, respectively, and are included in administrative expenses.

5. TAX STATUS

The Plan uses a prototype plan document sponsored by CCH Incorporated D/B/A FTWilliam.com ("CCH"). CCH received an opinion letter from the Internal Revenue Service (the "IRS") dated June 30, 2020, stating that the prototype document satisfied the applicable provisions of the IRC. The Plan itself has not received an opinion letter from the IRS.

Although the Plan has been amended since adopting the prototype plan, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, the Plan administrator believes that the Plan qualifies under Section 401(a) of the IRC and is exempt from federal income taxes under Section 501(a) of such code and, accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. FAIR VALUE MEASUREMENTS

Assets and liabilities measured at fair value are based on one or more of three valuation techniques identified in the tables below. The valuation techniques are as follows:

- (a) *Market approach.* Prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities;
- (b) *Cost approach.* Amount that would be required to replace the service capacity of an asset (replacement cost); and
- (c) *Income approach.* Techniques to convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing and excess earnings models).

The following table summarizes the Plan's assets measured at fair value on a recurring basis, categorized by U.S. GAAP's valuation hierarchy as of December 31, 2023 and 2022:

During the years ended December 31, 2023 and 2022, there were no transfers between levels of the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2023 and 2022.

Money market funds: Mutual funds are valued at cost plus accrued interest, which approximates fair value due to the liquidity of the investment.

U.S. government securities: U.S. government securities are comprised of government and agency securities and U.S. Treasury bills and notes of varying maturities. These are all considered level 2 fair values which are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows.

Corporate debt instruments: Corporate debt instruments are comprised of corporate bonds. Fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows.

6. FAIR VALUE MEASUREMENTS (CONTINUED)

Mutual funds: Mutual funds are valued at the daily closing prices as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks: Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
