Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

We have performed an audit of the financial statements of Automated Media, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained a certification from a qualified institution as of December 31, 2023, and for the year then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Note 1. Description of Plan

The following description of Automated Media, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Automated Media, Inc. on January 1, 2009 and has since been restated effective February 18, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the designated plan administrator of the Plan. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the trustee of the Plan (Principal). Participation in the Plan is discretionary for all eligible employees who meet eligibility requirements as defined in the plan.

Contributions: The following types of contributions may be made to the Plan:

- The total amount of salary reduction (Pre-tax and Roth) each participant has elected to defer up to 100%, subject to annual limitations as defined by the Internal Revenue Code (IRC).
- Catch up contributions (Pre-tax and Roth) for those participants who have attained the age of 50 before the end of the Plan year, subject to annual limitations as permitted by the IRC.
- At the discretion of the Plan Administrator, a participant may be permitted to contribute amounts representing distributions from other qualified plans (rollover).
- An employer qualified nonelective contribution.
- An employer discretionary matching contribution.
- An employer discretionary profit-sharing contribution.

Participant accounts: Each participant's account is credited with the participant's contribution, the employer qualified nonelective contribution (when applicable), the employer's discretionary matching contribution (when applicable), allocation of the employer's discretionary profit-sharing contribution (when applicable), and plan earnings (losses). Investment income is allocated to the participant accounts regularly. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions, rollover contributions, and qualified non-elective contributions, including the earnings on these amounts. Vesting in discretionary employer matching contributions and discretionary employer profit sharing contributions is based on years of continuous services. The following is a summary of the Plan's vesting provisions:

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years. Longer durations may be allowed for the purpose of purchasing a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate determined upon application. At December 31, 2023, interest rates ranged from 3.25% to 8.50%. Participants may have two outstanding loans at any given time. Principal and interest is paid ratably through payroll deductions.

Investment options: Participants direct their contributions to a variety of funds within common/collective trusts, pooled separate accounts, registered investment companies (mutual funds), and a guaranteed option fund offered by the Plan with various objectives and degrees of financial risk.

Payment of benefits: Upon death, disability, retirement or termination of service, a participant is entitled to receive a lump sum distribution equal to the participant's vested interest in his or her account. The Plan allows for in service distributions for those participants who have attained age 59 1/2 or have a severe financial hardship (as defined in the plan document) from their accounts which are 100% vested.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable and other administration expenses are included in administrative expenses and charged directly to the participant's accounts.

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of Plan termination, participants would become 100% vested in their accounts.

Forfeited accounts: At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$44,256 and \$80,739, respectively. These accounts can be used to pay for plan operating expenses or to reduce future employer contributions. In 2023, employer contributions were reduced by \$36,483 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that could affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest from notes receivable is recognized when earned. Delinquent notes receivable are treated as distributions based on the terms of the Plan document.

Excess contributions payable: The Plan failed the Average Deferral Percentage (ADP) and the Actual Contribution Percentage (ACP) test for the plan year ended December 31, 2022. Excess contributions amounting to \$7,699 are recorded as a liability in the accompanying statements of net assets available for benefits. The plan has reimbursed these excess contributions to its participants during 2023.

Administrative expenses: The Plan's administrative expenses are paid either by the Plan or the Company as provided by the Plan agreement.

Payments of benefits: Benefits are recorded when paid.

Note 3. Investments

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal. The funds are held in the Principal Guaranteed Option account totaling \$1,177,530 and \$1,595,030 at December 31, 2023 and 2022, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credit rate is based on a formula established by the contract issuer. The credit rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. For the Plan year ended December 31, 2023 and 2022, contract value equaled fair market value as there was no adjustment to contract value reported by Principal.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) contributions, fees or data is not received in a timely manner, (2) submission of incorrect or outdated information that would require issuer to rebuild Plan records, (3) the plan is amended or changed and the amendment or change is not submitted to the issuer, (4) the Internal Revenue Service has notified the Plan sponsor of possible operational defects that must be corrected and such possible defects are not corrected within 180 days of such notification, (5) the Plan fails to abide by any written agreement(s) with the issuer, (6) the issuer chooses to no longer do business with the Plan.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides the framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, inputs other than quoted prices that are observable, and model-based valuations in which all significant inputs are observable in the market.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Investments in insurance company pooled separate accounts are stated at NAV, which approximates fair value, and represent the number of participation units owned by the Plan. Quoted market prices of the underlying investments are used to value each fund and are based on the net asset value of the units held by the Plan at the end of the year.

Common/collective trusts: Investments in common/collective trusts have the characteristics of a structure similar to a mutual fund and are valued based on the readily determinable quoted market price that each fund publishes at the end of each day. While the underlying assets of mutual funds are actively traded on an exchange, the common/collective trust funds are not. Redemption may be daily.

Note 4. Fair Value Measurements (Continued)

Principal guaranteed option: As a general account product offered through the group annuity contract, participant principal and interest are fully guaranteed by the entire general account assets of Principal. The rate credited to participant accounts is a composite weighted average of underlying guarantees provided in the contract. Each underlying guarantee is in effect for its full maturity. The maturity of each guarantee varies from 2 to 10 years at the establishment of the guarantee. Each guarantee matures at different times. The crediting rate is reset every six months based on the changing weighted average of the underlying guarantees and applies prospectively. The crediting rate is subject to a minimum guaranteed rate that is determined through a formula referenced in state insurance regulations which utilizes Treasury rates and is outlined in the group annuity contract.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6. Information Certified by the Principal Trust Company

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that were prepared by or derived from information provided by the Principal Trust Company (the Trustee) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

Note 7. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the non-standardized profit-sharing plan and trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts, common/collective trusts and a guaranteed investment account managed by Principal or its affiliates. Principal is the trustee and recordkeeper for the Plan and, these transactions qualify as party-in-interest transactions. The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions. Fees paid for the year ended related to party-in-interest transactions were \$50,255.
