All plan assets were transferred out of The Switch Enterprises, LLC 401(k) Plan on December 29, 2023. Our opinion has not been modified with respect to this matter.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of The Switch Enterprises, LLC 401(k) Plan (the Plan) of The Switch Enterprises LLC (the Company) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have attained at least 18 years of age and completed six months of credited service (excluding nonresident aliens), as defined in the plan document. The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance in conjunction with a third-party consultant contracted by the Company. The Company was acquired by Tata Communications on May 1, 2023. On December 29, 2023, the Plan transferred all of its assets out, totaling \$13,583,769, to the Tata Communications 401(k) Plan (the Tata Plan). The transfer was in connection with the Tata Plan being amended effective January 1, 2024, to merge the Plan into the Tata Plan. There has been no activity in the Plan after the transfer out.

The Plan is subject to the provisions of the Internal Revenue Code of 1986 (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was established on January 1, 2017 and most recently amended and restated in May 2022 as part of its Cycle 3 Restatement. There were no significant changes as a result of this restatement.

Contributions

Participants may elect to defer and contribute pre-tax and Roth contributions to the Plan up to 90% of each respective participant's eligible compensation, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for employer safe harbor matching contributions to the Plan equal to 100% of the first 4% of each respective participant's eligible compensation contributed to the Plan as pre-tax, Roth, and catch-up contributions. Employer safe harbor matching contributions totaled \$395,306 for the period ended December 29, 2023.

The Company may also make discretionary profit-sharing contributions as declared by its Board of Directors. Discretionary profit-sharing contributions made to eligible participants' accounts are allocated in the ratio that the participant's eligible compensation bears to the total eligible compensation paid to all eligible participants. Only participants that are employed at the end of the plan year share in the allocation of such contributions, unless they were terminated on or after normal retirement age (65) or were terminated due to death or total and permanent disability. No such contributions were declared for the period ended December 29, 2023.

Employees are permitted to participate in all such contributions on the first day of the month coinciding with or subsequent to attaining the respective eligibility requirements.

All contributions and compensation are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer safe harbor matching contributions, an allocation of discretionary profit-sharing contributions, an allocation of the Plan's earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. The allocation of earnings or losses are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the respective participant's vested account.

Notes Receivable from Participants

The Plan permits its participants to obtain loans against their account balances. A plan participant may only have one loan outstanding at any given time. A plan participant may borrow from his or her vested account a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 reduced by the highest outstanding loan balance within the last twelve months or 50% of his or her vested account balance. With the exception of loans used to purchase a primary residence that are limited to a maximum of thirty years, loan terms are limited to a maximum of five years. Notes receivable from participants are secured by the vested balance in the respective participant's account and shall bear interest at the Wall Street Journal prime rate published on the 14th day of the month plus 1%.

Principal and interest are generally to be paid ratably through regular payroll deductions for actively employed participants. A participant may prepay the loan, plus accrued interest, without penalty; however, any such prepayment must be paid in full. Extra payments or partial prepayments will not be permitted. Prior to the May 2022 restatement, loan refinancing was not permitted. Upon termination of employment, any remaining payments are immediately due unless directly rolled over to another employer's plan.

The Plan Administrator shall consider a loan in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due. As of December 29, 2023, there were no outstanding loans due to the transfer out of all assets in connection with the merger. As of December 31, 2022, the rates of interest on outstanding notes receivable from participants ranged from 4.25% to 7.25% with various maturity dates through November 2027.

Vesting

Participants are immediately vested in all contribution sources plus actual earnings thereon.

Forfeitures

Forfeitures represent the nonvested portion of terminated participant account balances or amounts removed from participant accounts due to funding errors plus related earnings, which may be used to reduce future employer contributions or pay plan expenses. As of December 29, 2023, there were no forfeited nonvested accounts due to the transfer out of all assets in connection with the merger. As of December 31, 2022, forfeited nonvested accounts totaled \$1,129. No forfeited nonvested accounts were used to reduce employer contributions or pay plan expenses during or for the period ended December 29, 2023.

Payment of Benefits

The participant's vested account may be distributed to the participant (or the participant's beneficiary in the event of the participant's death) at retirement, death, disability, or termination of employment in the form of cash as lump-sum, partial withdrawals, or substantially equal payments. If a participant terminates service, the entire vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant. Participants who are eligible for a hardship withdrawal or have attained age 59½ may elect to withdraw all or a portion of their vested accounts with a minimum of \$500.

The participant's entire vested account will be distributed, or begin to be distributed, to the participant no later than April 1 of the calendar year following the later of the calendar year in which the participant attains age 72 if the participant reaches 72 prior to January 1, 2023, or 73 if the participant reaches 72 after December 31, 2022. Distributions may be made from a participant's rollover account at any time. The Plan Administrator can elect to distribute funds out of the Plan when a participant terminates employment and has a vested balance in the Plan less than \$5,000.

Certain other restrictions apply to benefit payments as defined in the plan document.

Investment Elections

Each participant shall direct the investment of his or her account and shall select among various mutual funds and a common collective trust. Each participant has the ability to change his or her investment allocations at any time.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments. During the period ended December 29, 2023, the Company paid certain administrative expenses incurred by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan's financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Mutual funds and the common collective trust are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued, but unpaid interest. Interest from notes receivable from participants is recorded on an accrual basis. As of December 31, 2022, accrued, but unpaid, interest has been deemed insignificant to the Plan. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable from the participant to be a distribution, notes receivable from participants are reduced and a benefit payment is recorded within the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

The Plan discloses the fair value of investments in accordance with FASB ASC Topic No. 820 *Fair Value Measurements* (ASC 820). The framework under ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means; or
 - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 29, 2023 and December 31, 2022.

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust – The common collective trust is valued at the NAV of units of the common collective trust. The NAV, as certified by Reliance Trust Company (Reliance), the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions of investments or withdrawals may occur on a daily basis and there are no redemption restrictions on the fund. There are no unfunded commitments as of December 29, 2023 and December 31, 2022.

There were no investments measured at fair value held by the Plan as of December 29, 2023 due to the transfer out of all assets held by the Plan in connection with the merger (see Note 1).

4. Information Prepared and Certified by Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 29, 2023 and December 31, 2022 and the related investment and notes receivable from participants activity reflected in the statement of changes in net assets available for benefits for the period ended December 29, 2023.

5. Tax Status

The Plan uses a prototype non-standardized plan document, sponsored by Automatic Data Processing, Inc. (the Recordkeeper). The IRS has determined by an opinion letter dated October 6, 2020 (July 16, 2014 prior to the May 2022 Cycle 3 Restatement), that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

The Plan was not formally terminated in connection with the merger and transfer out of all assets; however, no activity has occurred in the Plan since the transfer out (see Note 1). The Plan is expected to be formally terminated in 2024.

7. Party-in-Interest Transactions

The Plan issues loans to participants, which are secured by the balances in each respective participant's account, which constitute party-in-interest transactions.

8. Risk and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events for potential disclosure or recognition through October 10, 2024, the date the financial statements were available to be issued.
