### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Golden State Retirement Plan MEP as Adopted by Vasindas Around the Clock ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### (1) Description of the Plan

The following description of the **Golden State Retirement Plan MEP as Adopted by Vasindas Around the Clock** (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions, which are available from the plan administrator.

#### *General*

The Plan, originally effective January 1, 2000, and restated August 1, 2017, is a multiple employer defined contribution plan established by **Golden State Retirement Plan MEP Board of Directors**, the principal participating employer (“the Principal Employer”).

Vasindas Around the Clock, Kern Around the Clock Foundation, and Properties & Investments by Vasinda Inc., have executed adoption agreements to become participating employers with the Principal Employer in the Plan (collectively referred to as the “Participating Employers”).

The Plan covers all employees (excluding certain groups) of the Participating Employers who are at least 21 years old and have completed 3 months of service. The excluded employee groups consist of union employees covered under a collective bargaining agreement and per diem employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### *Contributions*

Participants may contribute a portion of annual compensation in pre-tax or Roth deferrals into the Plan, as defined in the plan document and allowed by the Internal Revenue Code (“IRC”). The Plan provides for automatic election of deferrals at a rate of 6 percent of compensation for all new participants. Participants may affirmatively elect a different deferral percentage or elect not to defer into the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participating Employers’ contributions are discretionary. During 2023, the Participating Employers contributed 25% of the participants’ deferrals up to a maximum of \$500. The Employers’ may also make a discretionary profit-sharing contribution each plan year. Contributions are subject to certain limitations. There were no discretionary profit-sharing contributions for the year ended December 31, 2023.

#### *Participant accounts*

Each participant’s account is credited with the participant’s contribution, the Participating Employers’ matching contribution, and allocations of the Participating Employers’ profit-sharing contribution, if applicable, and the Plan’s earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct their account balance into various investment options offered by the Plan.

### (1) Description of the Plan, Cont'd

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in any Participating Employers' discretionary contributions is based on years of service. Participants become 10 percent vested after completing one year of service, 25 percent after two years of service, and 100 percent after three years of service.

#### *Forfeited accounts*

At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$12,340 and \$6,934, respectively. These accounts will be used to reduce future employer contributions and pay plan expenses. For the years ended December 31, 2023 and 2022, no forfeitures were used to reduce employer contributions or administrative expenses.

#### *Notes receivable from participants*

Participants may borrow the lesser of \$50,000 or 50 percent of their vested account balance with a minimum loan amount of \$1,000. Loan terms range up to five years, but may be extended if the proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at the Prime rate of interest plus 1%. Principal and interest are paid ratably through payroll deductions.

#### *Distribution of benefits*

Upon termination of employment due to termination of service, death, disability, or retirement, participants may elect to receive the value of their vested account balance in an installment or lump-sum distribution. Participants may also take a financial hardship withdrawal under certain circumstances.

### (2) Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements are as follows:

#### *Basis of accounting*

The Plan uses the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### (2) Summary of Significant Accounting Policies, Cont'd

#### *Use of estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimates.

#### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

#### *Payment of benefits*

Benefits are recorded when paid.

#### *Administrative expenses*

Certain administrative expenses incidental to the administration of the Plan, including fees of the administrative agent and independent public accountants, may be paid by the Plan. The Company, at its discretion, decided to pay for certain of these administrative expenses of behalf of the Plan. Most investment options have management fees, which reduce the overall return on assets. The net realized and unrealized appreciation in fair value of investments is reflected net of these fees.

### (3) Information Prepared and Certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and Empower Retirement, LLC, the Custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at Fair Value
- Investments at Net Asset Value (NAV)
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### (4) Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

### (4) Fair Value Measurement, Cont'd

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts:* Valued at the NAV of units held by the Plan at year-end, which is considered by plan management to be the best approximation of fair value. The unit values of common/collective trust funds with underlying equity investments are calculated based on the observable value of the underlying investments. Valued at the NAV of units of a bank collective trust, the NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

### (5) Tax Exempt Status

The Principal Employer has adopted a volume submitter plan document that received a favorable opinion letter, dated June 31, 2020, from the Internal Revenue Service (“IRS”). The plan administrator believes the Plan has been operated in accordance with the applicable provision of the IRC. The Principal Employer routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

### **(5) Tax Exempt Status, Cont'd**

U.S. GAAP require plan management to evaluate the tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for plan years ending on December 31, 2020, or prior.

### **(6) Party-In-Interest Transactions**

Empower Retirement LLC holds Plan investments as of December 31, 2023 and is the Custodian as defined by the Plan. Reliance Trust Company, as the former Trustee, as defined by the Plan, held the assets for the year ending December 31, 2022 and from January 1, 2023 through October 20, 2023. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through the revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to Pentegra Services, Inc, the Trustee as defined by the Plan, of \$47,596 and \$48,380 for the years ended December 31, 2023 and 2022, respectively, which was not covered by revenue sharing. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### **(7) Plan Termination**

The Principal Employer has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants are always 100 percent vested in their accounts.

### **(8) Risks, Uncertainties and Concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2023 and 2022, approximately 70% and 64% of the Plan's investments were invested in the Vanguard Wellesley Income Admiral Fund.
