Note 1. Description of Plan

The following is a brief description of Simply Beautiful Smiles Clinical 401(k) Plan (the Plan) and is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General

The Plan was established effective January 1, 2020 and is a defined contribution plan covering all full-time employees of Langhorne Dental Associates, LLC and its controlled affiliates (collectively, the Company) who have attained age twenty-one and completed one month of service.

Reliance Trust Company serves as trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan accepts participant deferral contributions up to 90% of eligible compensation. Through July 31, 2022, the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan, unless they affirmatively elected not to participate. Automatically enrolled participants had their deferral rate set at four percent of eligible compensation, unless otherwise elected by participants. Deferral contributions were subject to an annual automatic increase of one percent of eligible compensation, up to maximum automatic deferral rate of ten percent.

Effective August 1, 2022, the Plan was amended and restated to remove the auto-enrollment and auto-escalation provisions, such that eligible participants must affirmatively make a deferral election if they wish to make salary deferral contributions to the Plan. All other aspects of the Plan provisions remain unchanged.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

The Company may elect to make an annual discretionary matching contribution to the Plan. Participants are entitled to receive an allocation of discretionary matching contributions if they are employed by the Company on the last day of the plan year and have completed at least 1,000 hours of service during the plan year. This requirement is waived upon retirement, death, or disability during the plan year. There were no Company contributions during 2023.

Contributions are subject to certain limitations.

Participant accounts

Each participant account is credited with participant contributions, an allocation of the Company's discretionary contributions, and plan earnings; and is charged with benefit payments, plan losses, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations of plan earnings and losses by fund are made based on the ratio of an individual participant account balance to the total account balances of all participants on a daily basis, as defined in the plan documents.

Investment options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and a common / collective trust fund as investment options to plan participants.

Vesting

Participants are immediately vested in their elective deferrals, voluntary rollovers, and actual allocated earnings thereon. Participants become fully vested in the Company's discretionary matching contributions upon retirement at age 65, at death, upon total and permanent disability, or according to the following vesting schedule based on years of service:

<u>Years of Service</u>	<u>Vested Percentage</u>
One year	50%
Two years	100%

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum or installment options as provided by the Plan. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution upon termination of service due to other reasons, upon demonstration of financial hardship, or after the participant reaches the age of 59.5 years.

Forfeitures

Forfeited non-vested accounts may be used to reduce future Company contributions or pay plan expenses, as provided by the Plan. As of December 31, 2023, the Company has not made any contributions to the Plan and the forfeiture balance is zero.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments held during the year. See Note 5 for discussion of fair value measurements.

Administrative expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income related to notes receivable from participants is reported as interest income from notes receivable from participants in the statement of changes in net assets available for benefits.

Payment of benefits

Benefits are recorded upon distribution.

Subsequent events

Management has evaluated subsequent events through October 3, 2024, the date the financial statements were available to be issued. Subsequent to year end, the Company sold the vast majority of its operating clinical locations to an unrelated party and all clinical employees at these locations were terminated within the clinical operating entity. All funds within the plan are fully vested because no employer contributions have been made to date.

Note 3. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated October 6, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the IRS approval. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common / collective trust funds

These investments are valued based on the reported net asset value (NAV) of the collective fund as a practical expedient to estimate fair value.

Note 6. Exempt Party-in-Interest Transactions

Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Fees paid to the trustee and recordkeeper by the Plan for administrative services were \$7,023 for the year ended December 31, 2023.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in mutual funds and a common collective trust. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

Note 8. Plan Termination

The Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
