## Independent Auditor's Report

To the Plan Administrator and Participants of  
Glatfelter Insurance Group Associate Health and Welfare Plan

### Opinion

We have audited the financial statements of Glatfelter Insurance Group Associate Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits—modified cash basis as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits—modified cash basis for the year ended December 31, 2023, and the related notes to the financial statements.

The following description of the Glatfelter Insurance Group Associate Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan provides health and other benefits to substantially all employees of Glatfelter Insurance Group (the Group). Certain Plan assets are held in a voluntary employees' association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

The Plan provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

### Insured Benefits

The Plan fully insures vision benefits. The Group purchases an annual insurance contract for this insured benefit. Covered employees cover some of the costs for vision benefits through a premium and any remaining costs are paid to the insurance company from the general assets of the Group. These payments are included in payments for insurance premiums on the Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis.

### Self-Insured Benefits

The Plan self-insures dental, flexible spending accounts, hospital, major medical, medical, prescription drug and surgical benefits. The claims for self-insured benefits are processed by the Plan's third-party administrators under administrative services only arrangements. The claims processor pays claims directly to or on behalf of participants. The payments for these claims are paid by the VEBA trust which is funded by the general assets of the Group. The payments for the flexible spending accounts benefits are paid fully by the participant at their own cost. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager which periodically makes refunds to the Plan based on the Plan's utilization pattern of specific drugs. These refunds totaling \$156,450 are recorded when received and are reported as other revenue in the Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis.

### Contributions

The Group shall periodically deliver to the Plan such amounts of money as shall be necessary for timely payment of all claims and reasonable administrative expenses of the Plan.

The Group provides for stop-loss insurance over a specified amount as per agreement with the excess loss carrier, with the premiums being paid by funds deposited in the Plan. The Plan is contributory. Participants pay a flat rate toward their own coverage as well as that of their dependents. Retirees pay toward their own coverage and their dependents' coverage based on COBRA rates as determined by the Group.

### Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop-loss coverage are paid from the assets of the trust.

## 2. Summary of Accounting Policies

### Basis of Accounting

The accompanying financial statements have been prepared using the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, additions are included in the year in which they are received and deductions are included in the year in which they are paid; however, earnings on investments include adjustments to fair value. Accrued income and expenses, payables and deferred expenses, which includes stop loss receivables, formulary rebate receivables and administrative expenses payable, which may be material in amount, are not reflected on the accompanying financial statements. Certain material liabilities and obligations are disclosed in the notes to the financial statements.

### Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Payment of Benefits

Premiums paid by the Group or the VEBA trust are recorded as payments for insurance premiums in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis.

Health claim payments are recorded when paid by the third-party claims processor and are included in payments for claims, net in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis.

### Administrative Expenses

The Plan's expenses are paid by the Plan, as provided by the plan document. Expenses that are paid directly by the Group are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis.

### Stop-Loss Insurance

Premiums for stop-loss insurance are included in payments for excess loss premiums on the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis. Stop-loss refunds were \$832,703 and are recorded as a reduction in self-insured claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis during the year ended December 31, 2023.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received by the trustee.

## Claims Incurred but not Reported and Benefit Obligations

The Plan is self-insured for health claims up to \$300,000 per claim. Stop-loss insurance coverage is maintained for claims in excess of this amount. The Plan's liability for health claims incurred, but not reported is estimated by the Plan using historical data provided by the insurance providers who have been retained by the Group. The accumulated postretirement benefit obligation is determined by the actuary.

## Subsequent Events

Subsequent events were evaluated through October 14, 2024, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Money market fund:* Valued at the quoted net asset value of shares held by the Plan at year-end.

## 4. Plan Termination

Although it has not expressed any intent to do so, the Group has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Group or be used for purposes other than for the exclusive benefit of the Plan's participants.

## 5. Related-Party and Party in Interest Transactions

The Plan's investments are administered under a contract with Wilmington Trust Company, the trustee of the Plan. These transactions qualify as party in interest transactions which are exempt from the prohibited transactions rules of ERISA.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Group. No such officer or employee receives compensation from the Plan.

## 6. Tax Status

The VEBA trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the Trust's net investment income is exempt from income taxes. The VEBA trust has obtained a favorable tax determination letter from the Internal Revenue Service dated March 16, 1988. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax exempt.

Management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of the investment security such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits—Modified Cash Basis.

Claims incurred but not reported are calculated based on historical trends of claims reported but not settled and claims that have been incurred but not reported. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

As of December 31, 2023 and 2022, 100% of the Plan's investments were concentrated in one and two funds, respectively.

## 8. Benefit Obligations

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Company.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 7.00% weighted-average annual rate of increase in the average per capita cost of covered health care benefits was assumed for 2023; the rate was assumed to decrease gradually to 5.50% for 2027 and to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligation at December 31, 2023.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2023 and 2022, by \$66,890 and \$83,023, respectively.

The following were other significant assumptions used to determine the postretirement benefit obligations as of December 31, 2023 and 2022:

Weighted-average discount rate - 4.72% for 2023; 4.91% for 2022

Average retirement age rate - Various rates ranging from 2.50% at age 60 to 100% at age 65

Mortality and disability - Pri-2012 Total Dataset Generational Mortality Table with MP-2021 Scale
