Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Metro Plastics Technologies, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of January 31, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended January 31, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of the Plan

The following description of the Metro Plastics Technologies, Inc. 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General– The Plan, established effective November 1, 1981, is a defined contribution plan covering substantially all employees of Metro Plastics Technologies, Inc. (the “Plan Sponsor” or “Plan Administrator”). The Plan was amended and restated effective July 26, 2021 to bring the Plan into compliance with legislative and regulatory requirements. Employees must have completed 3 months of service in order to become a participant in the Plan and begin making elective deferrals and receiving Plan Sponsor contributions. In accordance with the Plan agreement, the following classes of employees are excluded from eligibility:

- Residents of Puerto Rico
- Employees covered by a collective bargaining agreement
- Leased employees
- Non-resident aliens; and
- REM – Indiana Community Services Employees/seasonal employees, unless they have attained age 21 and completed 1,000 hours of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In April 2022, the Plan Sponsor was acquired by Newbury Franklin Industrials, LLC. Contributions to the Plan continued until December 8, 2022, at which point the Plan Sponsor notified participants that future contributions would be made to the NFI 401(k) Plan. The Plan merged with the NFI 401(k) Plan effective January 1, 2023. Plan assets totaling \$2,222,952, consisting of investments in the amount of \$2,133,502 and notes receivable from participants in the amount of \$89,450, transferred to the NFI 401(k) Plan on January 31, 2023. Each participant in the Plan shall be entitled to receive future benefits from the NFI 401(k) Plan.

Contributions – Participants may elect to contribute a specific percentage or dollar amount of their annual compensation as a pre-tax or Roth contribution, up to 90% of compensation, limited by the amount imposed by law. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount imposed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e., rollovers).

1. Description of the Plan (continued)

The Plan Sponsor may make discretionary matching contributions equal to a percentage of salary deferrals. For the year ended December 31, 2022, the discretionary matching contribution was calculated as 35% of a participant's deferral, limited to 3% of Plan compensation, and totaled \$45,714.

The Plan Sponsor may also make nonelective contributions based on a discretionary formula, otherwise referred to as the profit-sharing contribution. For the year ended December 31, 2022, the profit-sharing contribution totaled \$98,560 and was allocated to eligible participants based on their individual compensation in relation to the total compensation of all eligible participants. Employees must be employed on the last day of the Plan year and have earned at least 501 hours of service during the Plan year in order to be eligible for the discretionary matching contribution and the nonelective contribution. The Plan Sponsor may also contribute all or a portion of any nonelective contributions for a Plan Year as qualified nonelective contributions and allocate them to certain employees to help the Plan pass its non-discrimination testing.

The discretionary matching contribution and nonelective contribution for 2022 were funded to the NFI 401(k) Plan in 2023, and as such, have not been recorded in the accompanying financial statements.

For the period ended January 31, 2023, there were no participant contributions to the Plan, as participant contributions were made to the NFI 401(k) Plan effective December 8, 2022. In addition, there was no Plan Sponsor contributions for the period ended January 31, 2023.

Participant Accounts – Individual accounts are participant-directed and are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions and each participant's share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their salary deferral, rollover contributions, Plan Sponsor qualified nonelective contributions and actual earnings thereon. Participants vest in Plan Sponsor discretionary matching contributions and Plan Sponsor nonelective contributions and actual earnings thereon at the rate of 20% per year after two years of service and become fully vested after six years.

Forfeitures – Forfeitures from non-vested Plan Sponsor contributions may be used first to reduce Plan expenses and then to reduce Plan Sponsor contributions.

1. Description of the Plan (continued)

Payment of Benefits – Upon termination of employment, retirement, death, disability, or as required by law, a participant may elect to receive installment distributions or a lump-sum distribution in an amount equal to the vested value of their account. The Plan allows for in-service distributions for participants older than age 59 ½. With regards to hardship withdrawals, a participant may elect financial hardship withdrawals for qualifying expenses before age 59 ½ while employed by the Plan Sponsor.

Notes Receivable from Participants – Participants may borrow a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at a time and the minimum loan amount is \$1,000. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest. Repayment terms may not exceed five years, with the exception of a note used to purchase a primary residence, in which case extended repayment terms up to 10 years are available. Principal and interest is paid ratably through each payroll deduction. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan agreement.

Income Taxes – The Plan delegated authority to FMR LLC (Fidelity) to adopt the Fidelity Basic Plan Document No. 17. The Plan relies on an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, stating that the Plan is qualified under section 401 of the Internal Revenue Code (the “Code”). Accordingly, no provision for income taxes has been included in the accompanying financial statements. The Plan has been amended since the effective date of the IRS letter. However, the Plan Administrator believes that the Plan is operating in compliance with the requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Plan Termination – As discussed above, effective January 1, 2023, the Plan merged with the NFI 401(k) Plan. Each participant in the Plan shall be entitled to receive future benefits from the NFI 401(k) Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements are prepared using the accrual method of accounting in accordance with GAAP.

Investment Valuation and Income Recognition – The Plan’s investments as of December 31, 2022 are stated at fair value, as determined by Fidelity Management Trust Company (the “Trustee”). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

2. Summary of Significant Accounting Policies (continued)

The Plan presents in the accompanying statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains and losses and the unrealized net appreciation or depreciation of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative Expenses – Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor, or paid by applying the forfeiture balance of the Plan. Expenses relating to investment activity are paid by the Plan.

Payment of Benefits – Benefits are recorded when paid.

Party-in-Interest Transactions – Certain Plan investments were managed by the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, that are exempt from the prohibited transaction rules. Fees paid to the Trustee for custodial and investment management services for the period ended January 31, 2023 and year ended December 31, 2022 totaled \$0 and \$1,801, respectively.

Risks and Uncertainties – Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Use of Estimates – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Subsequent Events – The Plan Administrator has evaluated the effects of all subsequent events, for recognition or disclosure, through October 10, 2024, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was required.

3. Information Certified by the Trustee (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the investments and participant loans included in the accompanying financial statements and supplementary information are complete and accurate at January 31, 2023 and December 31, 2022.

The Trustee also certified interest and dividend income totaling \$449 and \$181,308, and net appreciation (depreciation) in fair value of investments of \$152,285 and (\$807,959) for the period ended January 31, 2023 and year ended December 31, 2022, respectively.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that utilized Level 3 inputs as its primary measure of fair value as of January 31, 2023 and December 31, 2022.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for assets measured at fair value.

Money Market Fund – Shares of money market funds are valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

Mutual Funds – Shares of mutual funds are valued at quoted market prices of shares held by the Plan at year-end.

Collective Investment Fund (“CIF”) – The CIF is valued daily at net asset value (“NAV”) based on the market value of the underlying assets. NAV is determined by dividing the fair value of the CIF’s net assets by the total number of units owned. The CIF invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into wrap contracts issued by third-parties, and invests in cash equivalents represents by shares in money market funds. Fidelity seeks to minimize the exposure of the CIF to wrap credit risk through, among other means, diversification of the wrap contracts across an approved group of issuers. The CIF’s ability to receive amounts due pursuant to these contracts is dependent on the issuers’ ability to meet their financial obligations.

There were no unfunded commitments on the CIF as of December 31, 2022. Participant level transactions take place daily while plan level liquidations require notice to Fidelity prior to processing the transaction.
