### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Italmatch USA 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements December 31, 2023 and 2022

---

### Note 1: Plan Description

The following description of the Italmatch USA 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, initially established on July 1, 2003, by Compass Chemical International, LLC (the Plan Sponsor or Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Plan Sponsor and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

The following adopting employers are allowed to participate in the Plan:

- BWA Water Additives US, LLC
- Detrex Corporation
- Italmatch SC, LLC
- Italmatch USA Corporation
- The Elco Corporation
- Water Science Technologies, LLC

The Plan covers all employees except non-resident aliens and members of collective bargaining agreements. Employees are eligible to participate in the Plan upon completing one month of service and may enter the Plan immediately upon meeting eligibility requirements. Participants are eligible for employer contributions after one month of service.

#### Contributions

Participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. All contributions are subject to the Internal Revenue Code (IRC) limit, which was \$22,500 for the year ended December 31, 2023. Participants who are at least 50 are eligible to make a catch-up contribution, which was limited by the IRC to \$7,500 for the year ended December 31, 2023. Employees may also contribute amounts representing rollover contributions from other qualified plans, even if they have not satisfied the Plan's eligibility requirements. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has elected to operate the Plan as a safe harbor 401(k) plan, which makes the plan exempt from certain compliance testing requirements. The Plan Sponsor makes safe harbor matching contributions equal to 100% of the first 3%, plus 50% from the next 2% of compensation. In addition to the safe harbor matching contributions, the Plan Sponsor may make discretionary contributions to participants, under a non-integrated method, to participants employed on the last day of the Plan year. During 2023 and 2022, the Plan Sponsor elected not to make any discretionary contributions.

## **Administration**

The Company serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions, which may affect eligibility for benefits. Fidelity Management Trust Company (the Trustee) is the designated Trustee of the Plan. The Trustee receives all contributions made under the Plan, holds Plan assets, pays benefits to participants as directed by the Plan Administrator, and assists with the administration of the Plan. The Trustee also serves as the intermediary for all asset purchases and redemptions and manages certain investments options of the Plan (see Notes 3 and 7).

## **Participant Accounts**

Participants direct the investments of their contributions in various investment options offered by the Plan. Each participant's account is credited with the participant's contributions and allocation of the Plan Sponsor's contributions, and actual Plan earnings or losses thereon. The participant's account is also charged with withdrawals and administrative expenses. Allocations are based on the participant's Plan compensation, account balances or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

## **Vesting**

Participants are immediately 100% vested in their contributions plus earnings thereon and are always 100% vested in safe harbor matching contributions received.

## **Forfeitures**

Any non-vested account balances of terminated employees are forfeited upon the complete distribution of the vested portion of their account, subject to the possibility of reinstatement before the end of five consecutive breaks in service, as defined in the Plan Document. Any forfeitures of terminated employees' non-vested accounts are used to pay administrative expenses of the Plan, restore non-vested amounts to re-employed participants, or to reduce Plan Sponsor contributions, as defined in the Plan Document.

## **Administrative Expenses**

Administrative expenses are paid by the Plan as permitted by the Plan Document and to the extent that they are not paid by the Plan Sponsor. These expenses include, but are not limited to, legal, accounting and recordkeeping fees, and investment expenses. For expenses paid by the Plan, a proportionate share of fees and expenses is charged to each participant's account. In addition, certain investment related expenses are included in net appreciation in fair value of investments.

## **Investment Options**

Participants are required to make participant-directed allocations of their accounts in increments totaling 100% among various investment options, including certain options for which the Trustee or its affiliates serve as investment advisors (Note 7), selected by the Plan Administrator.

## **Notes Receivable from Participants**

Participants may borrow from their vested account balance, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repayable in periods not to exceed five years, unless loans were for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prevailing market interest rate on the date the loan is made. The interest rate on participant loans range from 4.25% to 9.50% per annum as of December 31, 2023. Principal and interest are repaid through payroll deductions, unless directly repaid to the Plan by the participant.

## **Benefits Paid to Participants**

Withdrawals from participant accounts may be made for the following reasons: hardship, attainment of age 59 ½, active military distribution, qualified reservist, normal retirement at age 65, death, totally disabled or termination of employment.

Hardship withdrawals are permitted if certain criteria are met, as defined by the Plan Document, and are subject to taxes in the year received.

Upon reaching the age of 59½, a participant is eligible to receive distributions without termination of employment and without penalty.

Participants withdrawing from the Plan due to termination of employment, other than due to retirement, death or disability, may receive the value of their vested account through a lump sum distribution or rollover. In general, if the participant's account balance, as defined in the Plan Document, is greater than \$5,000, the account may not be distributed without the participant's consent. If no alternative election has been made and the benefit is between \$1,000 (the involuntary cash-out amount) and \$5,000, the Plan may automatically transfer the funds into an individual retirement account (IRA) established on the participant's behalf. However, regardless of participant election as to payment, the Plan may, upon termination of service of a participant for any reason, pay the benefits owed in a lump sum distribution if the account balance is less than the involuntary cash-out amount.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service (IRS) penalties unless the distribution is transferred to another qualified plan or IRA.

## **Note 2: Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments including gains and losses, are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Benefits Paid to Participants**

Benefits to participants are recorded when paid.

### **Note 3: Information Certified by the Trustee (Unaudited)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, except for comparing such information to information included in the Plan's financial statements:

### **Note 4: Fair Value Measurements**

The accounting standard for fair value measurement provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in non-active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Stable value collective trust:* Valued at net asset value (NAV) as reported by fund managers. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus any liabilities, and then divided by the number of shares outstanding. This practical expedient would not be used if it is determined to be probable that the investment will sell for an amount different from the reported NAV. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals. Certain events such as plan termination or a plan merger initiated by the Company may limit the ability of the Plan to transact at contract value. The Plan Sponsor does not believe that any events that may limit the ability of the Plan to transact at contract value are probable. The fund is valued daily, can be redeemed daily without restrictions, and without prior notice. There are no unfunded commitments.

The methods described above may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5: Income Tax Status

The Plan Sponsor adopted a plan, which received a favorable opinion letter from the IRS, dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC; and therefore, is not subject to tax under present income tax law. The Plan has been amended since the receipt of the favorable opinion letter. However, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and tax exempt as of December 31, 2023. U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2020.

### Note 6: Reconciliation to Form 5500

The financial information of the Plan, as reported on Form 5500, does not include all amounts necessary for reporting on the accrual basis of accounting. A reconciliation of the amounts appearing on the Form 5500 to the accompanying financial statements is as follows:

## **Note 7: Party-in-Interest Transactions**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the Trustee, third-party administrator, investment managers, investment advisors, legal counsel, and the Plan auditor. While the Plan Sponsor pays a portion of the fees, a portion is paid by the Plan (see Note 2). Transactions with these providers qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$2,930 for the year ended December 31, 2023. In addition, notes receivable from participants also qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## **Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances, and the assets of the Plan will be distributed to the participants in accordance with the Plan's provisions.

## **Note 9: Prohibited Transactions**

During 2023 and 2022, the Plan Sponsor deducted, via payroll withholding, \$23,215 and \$20,088, respectively, (excluding lost earnings) from participants' gross wages that was not remitted in a timely manner to the Plan in accordance with DOL regulations. The Plan Sponsor intends to file Form 5330 and make the restorative contributions to the Plan during 2024 to restore lost earnings from 2023 participant wages that were not remitted in a timely manner to the Plan.

## **Note 10: Subsequent Events**

The Plan Sponsor has evaluated for subsequent events between December 31, 2023 and the report date, the date the financial statements were available for issuance, and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
