Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of HighFive OMFS 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Notes to Financial Statements

December 31, 2023

1. Description of the Plan

The following description of HighFive OMFS 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of HighFive OMFS Alabama, LLC and its affiliates (collectively, the Company) who are 21 years of age, have completed one year of service and are not union employees, nonresident aliens, leased employees or interns, or dentists with less than 10 percent equity. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

Effective December 31, 2023, the Company approved the legal merger of the Plan into the HighFive Healthcare 401(k) Plan (HighFive Plan). As a result of the merger, the Plan's assets held in trust by Matrix Trust Company were transferred to the HighFive Plan in January 2024.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation (as defined in the Plan document) and Roth contributions, not to exceed federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes a safe harbor nonelective contribution equal to three percent of eligible compensation. The Company may also make discretionary nonelective contributions, as determined annually by the Company. For the Plan year ended December 31, 2023, the Company contributed nonelective profit sharing amounts based on a percentage of compensation using the grouping method (as defined in the Plan document). Participants must be employed on the last day of the Plan year and have completed at least 1,000 hours of service to receive an allocation of the discretionary nonelective contribution. The Company contribution receivable (including true-up of the safe harbor nonelective contribution and the discretionary nonelective contribution) of \$1,318,323 was remitted to the HighFive Plan after the Plan merger date. Contributions are subject to certain limitations.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Contributions (continued)

Participants direct the investment of their contributions and the Company contributions into various investment options offered by the Plan.

Forfeitures

The Plan allows forfeitures of terminated, nonvested participant accounts to be used to reduce future Company contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor nonelective contribution, Plan earnings or losses from that account's investment activities and allocations of any Company discretionary nonelective contributions. Allocations are based on compensation, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefit Payments

On termination of service due to separation, death, disability, or retirement, a participant may receive a lump-sum amount or partial withdrawals or installments equal to the value of the participant's vested interest in his or her account (only for required minimum distributions). In-service withdrawals may be available as defined in the Plan document.

Vesting

Participants are vested immediately in their contributions and safe harbor nonelective contributions plus actual earnings thereon. Vesting in the Company discretionary nonelective contribution is based on years of service. A participant is 100 percent vested after six years of credited service.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company discretionary contributions.

1. Description of the Plan (continued)

Administrative Expenses

Certain administrative expenses, including recordkeeping, trustee and investment advisory fees, have been paid by the Company. Participant initiated distribution fees are charged directly to the participant's account. All other administrative expenses and investment transaction fees (including investment-related expenses which are included in net appreciation in fair value of investments) are paid by the Plan.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year as well as any investment-related expenses.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes to Financial Statements (continued)

3. Investment Information

All investment information disclosed in the accompanying financial statements, including net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Matrix Trust Company, the trustee.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:
Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

4. Fair Value Measurements (continued)

Collective trusts: valued at the net asset value (NAV) of units of other underlying collective funds or similar funds. The NAV, as provided by the issuer, is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Company adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

6. Subsequent Events

Management of the Company evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2024, which is the date the financial statements were available to be issued.
