NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Wings N' More Employees 401K Plan (the Plan) a multiple employer plan, provides only general information. Participants should refer to the Plan agreement for a more complete description of the plan's provision.

General

The plan is a defined contribution multiple employer plan covering eligible employees. The plan is subject to the provisions of ERISA. All regular full-time and part-time employees of Dennard Enterprises, Inc. are eligible to participate after one year of service and over the age of 21 years. Participation commences on the first day of the plan year or the first day of the seventh month of the plan year after meeting the eligibility requirements.

Contributions

Each Year participants may contribute up to 100% of their compensation not to exceed the maximum allowable IRC 402(g) limit of \$22,500 for 2023. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The employers contribute a safe harbor matching contribution equal to 100% of the first 3% of employee salary deferrals plus 50% of the employee salary deferrals from 3% to 5%. Additional matching contribution amounts may be contributed at the option of the employer subject to certain limitations.

The maximum IRC 415 limit for total contributions made on behalf of a participant (deferrals and employer contributions) is \$66,000 for 2023. Catch-up contributions can be made in excess of this limit.

Participants direct the investment of their contributions into various investment options offered by the plan. The plan currently offers various mutual funds and guaranteed funds as options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also immediately vested in employer safe harbor contributions. Participants are immediately vested in employer matching contribution at retirement, death or disability. All other participants are vested in employer matching contribution in accordance with the schedule below:

Forfeitures

Forfeitures attributable to employer contributions shall be used to offset plan expenses and fund the employer contribution for the Plan year following the year such forfeitures occur.

Participant Loans

The Plan does not allow loans.

Payment of Benefits

Upon termination of service a participant is required to receive the value of vested interest in his or her account as a lump sum distribution, if the vested interest is less than \$5,000. For vested interest greater than \$5,000, the participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installment over a period of time. The distributable amount is equal to the value of the participant's vested interest in his or her account. Employees who elect to have their benefit payments deferred continue to share in allocations of investment income and losses but do not share in subsequent allocations of discretionary contributions.

The plan also allows for in-service distributions of employee deferral amounts due to financial hardship, as defined in the plan document.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting. Employer contributions and income from investments are recorded when they are earned. Employee contributions are recorded when withheld from pay. Expenses are recorded in accounting period in which they are incurred.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded in the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investment bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Plan Expenses

Professional fees incurred to operate the Plan, such as attorney fees and audit fees are paid directly by the Plan Sponsor. Other fees and expenses related to the day to day operations of the Plan are paid by the Plan. These fees are recorded when paid.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Subsequent Events

The Plan has evaluated subsequent events through October 11, 2024, the date the financial statements were available to be issued.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103 (a)(3)(C) pursuant to 29 CFR 2520.103-08 for the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln National Life Insurance Company, a qualified Institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete accurate:

- (a) Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022;
- (b) Total investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023; and
- (c) All information included in the schedule H, Line 4i – Schedule of Assets (Held at End of Year), as shown in the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment included in the financial statements and ERISA-related supplemental schedule.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements)

The three levels of the fair value hierarchy under FASB ASC 820 as described as follows:

Level 1 *Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.*

Level 2 *Inputs to the valuation methodology include*

- *quoted prices for similar assets or liabilities in active markets;*
- *quoted prices for similar assets or liabilities in inactive markets;*
- *inputs other than quoted prices that are observable for the asset or liability;*
- *inputs that are derived principally from or corroborated by observable market data by correlation or other means.*

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 *Inputs to the valuation methodology are unobservable and significant to the fair value measurement.*

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of observable inputs.

The following is a description of the valuation methodologies used for asset measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Pooled Separate Accounts: The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two-unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day

NOTE 5. GUARANTEED CONTRACTS

The Plan has contracts with Lincoln Financial Group that invests contributions in the Guaranteed Account and the Stadion Managed Principal Protection Portfolio totaling \$223,515 at December 31, 2023 and \$323,483 for December 31, 2022. The Guaranteed Account is an investment option as part of the group variable annuity with Lincoln Financial Group that is guaranteed by the general assets of Lincoln National Life Insurance Company against loss of principal, minus withdrawals, including charges and adjustments. This investment option is considered to be fully benefit-responsive and provides a guaranteed interest crediting rate which is declared on a quarterly basis. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate 2.53% for 2023. The Stadion Managed Principal Protection Portfolio is an investment option as part of the group variable annuity with Lincoln National Life Insurance Company that is guaranteed by the general assets of Lincoln Financial Group against loss of principal, minus withdrawals, including charges and adjustments. This investment option is considered to be fully benefit-responsive and provides a guaranteed interest crediting rate which is declared on a quarterly basis. The average crediting rate and yield for the year ended December 31, 2023 was 1%. Because these investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract is included in the financial statements at fair value which approximates contract value. Contract value, as reported to the plan by Lincoln National Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4 percent. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the ability of the plan to transact a contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the plan's prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the plan's normal operations; (4) the failure of the plan to qualify under 401 (a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax exempt under Section 501 (a) of the IRC; or (5) premature termination of the contract. The plan administrator believes that no events are probable of occurring that might limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issue to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreements without the consent of the issuer.

NOTE 6. NONPARTICIPANTS-DIRECTED INVESTMENTS

The Plan's participants direct all investments. There are no non-participant directed investments as of December 31, 2023 and 2022.

NOTE 7. RELATED-PARTY TRANSACTIONS

The Plan Sponsor paid certain Plan expenses totaling approximately \$26,796 during the year ended December 31, 2023 for administrative fees and other charges from Plan Administrator.

The Plan Custodian receives fees from administration and investment management. The investments of the Plan are maintained in the pooled separate accounts of the Plan Custodian.

NOTE 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its operations at any time and to terminate the plan subject to the provisions of ERISA. In the event of the plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the company may determine.

NOTE 9. PLAN AMENDMENT AND TAX STATUS

The Plan obtained its latest determination letter in which the Internal Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10. RISK AND UNCERTAINTIES

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
