## INDEPENDENT AUDITORS' REPORT

To the Board of Trustees

## **Emphasis of Matter**

As discussed in Note 1 to the financial statements, on August 24, 2023, Pryor Cashman LLP, the Plan Sponsor, approved the merger and transfer of the Plan assets into the Pryor Cashman LLP Retirement Plan effective December 31, 2023. Our opinion is not modified with respect to this matter.

### **NOTE 1 - PLAN DESCRIPTION**

The following description of the Pryor Cashman LLP Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees (including partners) of Pryor Cashman LLP (the "Sponsor"/"Employer") who have attained age 21 and have completed one year of service. The Plan does not include associates and employers' Counsel. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On August 24, 2023, the Sponsor approved the merger and transfer of the Plan assets into the Pryor Cashman LLP Retirement Plan (the "Retirement Plan") effective December 31, 2023. The Plan ceased operations as of December 31, 2023 and transferred \$60,978,529 of Plan assets to the Retirement Plan. The self-directed brokerage accounts, in the amount of \$8,370,385, were transferred, but the funds settled on January 2, 2024 in the Retirement Plan. The transfer of all Plan assets to the Retirement Plan was completed on January 2, 2024.

#### **Contributions**

Each year, the Employer may decide to make a discretionary contribution to the Plan for all eligible employees as defined in the Plan document. The amount of contribution was 4% of pre-tax annual compensation for all eligible employees and 4% to 12% for partners for the year ended December 31, 2023.

#### **Participant Investment Account Options**

The Plan offers various mutual funds, stable value common collective trusts, and self-directed brokerage accounts as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

#### **Participant Accounts**

Participants are allowed to direct the investment in their individual account balances into the investment fund(s) offered under the Plan.

Each participant's account is credited with (a) the Employer's contribution, and (b) the Plan's earnings, and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account balance.

#### **Vesting**

A participant is not vested in any portion of the Sponsor's contribution until they have completed three years of service.

#### **NOTE 1 - PLAN DESCRIPTION (Continued)**

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the excess of the participant's highest outstanding participant loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding participant loan balance on the date of the loan. The loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates as determined quarterly by the Plan administrator, and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten years). Principal and interest are paid ratably through monthly payroll deductions. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.

##### **Payment of Benefits**

On termination of service due to death, disability or retirement, the participant's entire vested account balance is payable in the form of a lump-sum payment, over a period in monthly, quarterly, semi-annual or annual installments, or in the form of an annuity. If a participant is married on the benefit starting date and has a vested balance greater than \$5,000, then his or her qualifying spouse will be entitled to 50% of the monthly installments payable to the participant, for the lifetime of the spouse upon death of the participant, unless this form of benefit is waived with spousal consent.

##### **Forfeited Accounts**

At December 31, 2023 and 2022, forfeited nonvested accounts before reduction of employer contributions totaled \$11,612 and \$38,687, respectively. The amount was used to reduce employer contributions for the corresponding year.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and not included in the statement of changes in net assets available for benefits. Fees and expenses associated with participant requested transactions, including those related to the administration of investment management services are charged directly to the participant's account and are included in administrative expenses.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**NOTE 3 - INVESTMENTS - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN/TRUSTEE AS COMPLETE AND ACCURATE**

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Trust Company, LLC ("Empower") held the Plan's investment assets and executed investment transactions. The custodian/trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Notes receivable from participants of \$14,852 at December 31, 2022 and interest income on notes receivable from participants of \$688 for the year ended December 31, 2023 have also been certified by the custodian/trustee.

Interest income of \$31,673 and dividend income of \$66,480 in the self-directed retirement account are included in net appreciation in fair value of investments on the certification by Empower. These amounts have been reclassified on the statement of changes in net assets available for benefits.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

### **NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)**

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

#### **Mutual Funds:**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Stable Value Common Collective Trust:**

A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Self-Directed Retirement Account:**

The self-directed retirement account is a participant-directed brokerage account that consists of cash, common stock, real estate investment trusts, ETFs, U.S. government securities and corporate bonds through Empower. The common stock, real estate investment trusts and ETFs are valued at quoted market prices determined in an active market. U.S. government securities are valued using pricing models maximizing the use of observable inputs for similar securities. Corporate bonds are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing values on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, those corporate bonds are valued under a discounted cash flow approach that maximizes observable inputs, such as current yields or similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by the Plan custodian, Empower, and therefore, qualified as party-in-interest transactions. Fees paid by the Plan to the custodian for the administrative services amounted to \$24,449, for the year ended December 31, 2023. UBS Financial Services Inc. is the Plan's investment advisor. Fees paid by the Plan for investment advisory services amounted to \$43,333 for the year ended December 31, 2023. Total fees paid by the Plan for administrative services amounted to \$67,782 for the year ended December 31, 2023.

#### **NOTE 6 - PLAN TERMINATION**

The Sponsor has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all affected participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Sponsor may determine. On August 24, 2023, the Sponsor approved the merger and transfer of the Plan assets into the Pryor Cashman LLP Retirement Plan (the "Retirement Plan") effective December 31, 2023.

#### **NOTE 7 - TAX STATUS**

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the Non-standardized Pre-approved Profit Sharing/Money Purchase Plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401. The Plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
