We have performed audits of the financial statements of High Country Beverage Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

### 1. Plan Description

The following description of High Country Beverage Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established on February 1, 1997 and most recently amended August 1, 2022. The Plan is available to substantially all employees of High Country Beverage Corporation (the Company), and adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Administration of the Plan*

Management of the Company administers the Plan. Reliance Trust Company (RTC or the Trustee) serves as Trustee. T. Rowe Price (TRP or the Custodian) serves as custodian and recordkeeper.

#### *Eligibility*

Employees who have completed six consecutive months of service and are age 18 years or older are eligible to participate in the Plan. Excluded employees include union employees, nonresident aliens, residents of Puerto Rico or leased employees. The entry date for eligible participants is the first day of the month following obtaining eligibility.

#### *Contributions*

Participants may make pre-tax or Roth after-tax contributions up to 100% of their annual eligible compensation, as limited by the Internal Revenue Service (IRS). Eligible employees who have reached age 50 during the year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions. All newly eligible participants are automatically enrolled to participate in the Plan at a deferral rate equal to 5% of compensation, as specified in the Plan document, unless they elect not to participate or have specified a deferral percentage as an elective contribution to the Plan.

The Plan includes a safe harbor matching contribution provision. The Company will make a safe harbor matching contribution of 100% of elective deferrals up to 5% of eligible compensation. Matching contributions are funded each pay period. The Company may also make discretionary non-elective contributions to the Plan. The contributions will be based on a discretionary formula as a percentage of eligible compensation. The Company did not make any discretionary non-elective contributions for the year ended December 31, 2023.

### ***Participant Accounts***

Each participant's account is credited with the participant elective deferral (pre-tax and after-tax Roth) and rollover contributions, safe harbor matching contributions and discretionary non-elective contributions (if any), and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The investment earnings or losses are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment options. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Investment Options***

Upon enrollment in the Plan, a participant may direct employee and employer contributions to various mutual funds offered in the Plan. Participants may change their investment options or reallocate their account balances on a daily basis.

### ***Notes Receivable from Participants***

A participant may borrow from their account the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. Loans are secured by the participant's vested account and bear interest at a fixed rate as of the date of loan origination. The loans are to be repaid over a five-year period unless they are for the purchase of a principal residence, which allow for up to a 10-year period. Principal and interest are collected ratably through payroll deductions. A participant can have no more than one loan outstanding at any time.

### ***Payment of Benefits***

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump sum, a partial payment, or installment payments in the amount equal to the participant's vested account balance.

Immediate lump-sum distributions are to be made to terminated participants if the participant's vested balance is \$1,000 or less. Balances between \$1,001 and \$5,000 are rolled over to an Individual Retirement Account (IRA) for the benefit of the participant. These mandatory distributions are only applicable if the participant does not elect another form of distribution.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the Company. The Plan also provides for hardship withdrawals for defined hardship events.

### ***Vesting***

Participants are 100% vested in their elective deferral contributions, rollover contributions and safe harbor matching contributions, and allocated earnings or losses thereon. Any discretionary non-elective contributions vest ratably over five years of credited service. A participant's account becomes 100% vested upon death, attaining normal retirement age (the age of 65) while an employee, retirement due to disability, or termination of the Plan.

### ***Forfeitures***

Forfeited non-vested amounts can be used to reduce employer contributions or pay administrative expenses. As of December 31, 2023 and 2022, there were no forfeited accounts. No forfeitures were used during 2023 to pay administrative expenses or reduce employer contributions.

## 2. Significant Accounting Policies

### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are recorded at fair value as reported to the Plan by the Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected on the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the Plan document.

### *Contributions*

Participant contributions and any related safe harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Administrative expenses of the Plan are paid by the Company and the Plan. Fees, primarily loan origination, distribution fees, administrative fees and investment advisory fees are charged directly to the participant's account and are included in administrative expenses or net with investment earnings. All other expenses of the Plan were paid by the Company and are excluded from these financial statements.

### **3. Certified Investment Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual Funds* - These are public investment vehicles valued using net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted market price on an active market and classified within Level 1 of the valuation hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

## 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by T. Rowe Price or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to T. Rowe Price by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Tax Status

The Plan is a non-standardized pre-approved profit-sharing plan document sponsored by Ascensus LLC. The Internal Revenue Service (IRS) has determined and informed Standard, by an opinion letter dated June 30, 2020, that the plan document qualifies under Code Section 401. The Plan has since been amended; however, the plan administrator and Company management believes that the Plan, is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the relates trust was tax-exempt as of the financial statement date, and no provision for income taxes has been provided for in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants become 100% vested in their accounts and the net assets of the Plan, after payment of any expenses properly charged, would be distributed to the participants of the Plan according to the amount then credited to their account.

### 8. Risks and Uncertainties

The Plan provides for various investments in mutual funds. Investments, in general, are exposed to various risks such as interest rate, credit and overall market volatility risk. Additionally, the value, liquidity and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Subsequent Events

Management has evaluated subsequent events through October 14, 2024, which is the date the financial statements were available for issue. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements.
