## INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee and participants of the  
Agnes Scott College Tax-Deferred Annuity Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Agnes Scott College Tax-Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of March 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to March 31, 2023, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institutions in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of March 31, 2023 and December 31, 2022, and for the period from January 1, 2023 to March 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Emphasis of Matter - Plan Merger**

As discussed in Note 1 to the financial statements, Agnes Scott College (the Plan Sponsor) elected to merge the assets of the participants in the Plan into the Agnes Scott College Defined Contribution Retirement Plan in 2023. All assets of the Plan were transferred to the Agnes Scott College Defined Contribution Retirement Plan on March 31, 2023. Our opinion has not been modified with respect to this matter.

### 1. Description of Plan

The following description of the Agnes Scott College Tax-Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan was a defined contribution 403(b) plan covering all employees of Agnes Scott College (the Plan Sponsor) except those employees who were enrolled students attending classes offered by the Plan Sponsor. Employees were immediately eligible to participate in the Plan upon employment. The Plan Sponsor also sponsors the Agnes Scott College Defined Contribution Retirement Plan (the DC Plan), an additional defined contribution 403(b) plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Merger and Transfer of Plan Assets

In accordance with an amendment to the DC Plan, on March 31, 2023 (the Transfer Date), the Plan merged its participant accounts of \$19,100,488 into the DC Plan and its participants joined the DC Plan effective April 1, 2023.

#### Contributions

Prior to the Transfer Date, participants could elect to make pre-tax or Roth contributions of up to 100% of eligible compensation to the Plan during their first year of employment. Beginning with a participant's second year of employment, they could elect to make pre-tax or Roth contributions of up to 96.5% of their eligible compensation to the Plan.

Beginning with a participant's second year of employment, they were required to make pre-tax or Roth contributions of 3.5% of eligible compensation to the DC Plan.

Prior to the Transfer Date, all eligible participants, age 50 or older, of the Plan could elect to contribute catch-up contributions up to \$7,500 in 2023. Participants who had been employed by the Plan Sponsor for at least fifteen years could elect to make a special 403(b) contribution in the amount equal to the smallest of: \$3,000; \$15,000 minus the amount of special 403(b) contributions made in the prior year; or \$5,000 multiplied by the years of service minus total deferrals made while employed by the Plan Sponsor, as defined by the IRS 15-Year Rule. If participants were eligible for both catch-up and special 403(b) contributions, such participant contributions were first allocated as special 403(b) contributions. Total contributions, including participant and Plan Sponsor contributions, to both the Plan and the DC Plan could not exceed \$73,500, including catch-up contributions, per participant in 2023.

Prior to the Transfer Date, participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

### **Participant Accounts**

Each participant's account was credited with the participant's contributions, rollovers, and earnings or losses on the investments in their account and was charged with administrative fees. Participants directed the investment of their account into various options offered by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Participants could change their investment options on a daily basis; however, certain investments were subject to various restrictions. Participant's investment balances, or accumulations, could be transferred among the money market fund, mutual funds, variable annuity contracts, and the TIAA Real Estate Account (Real Estate) without restrictions. Interfund transfers from any fund had a minimum transfer amount of \$1,000 or 100% if the accumulation being transferred was less than \$1,000. Certain contracts in the TIAA Traditional Annuity (TIAA Traditional) were subject to various restrictions and required that transfers made into the TIAA Traditional meet a minimum transfer amount of \$1,000.

### **Vesting**

Participants were vested immediately in their contributions plus actual earnings thereon.

### **Plan Loans**

Prior to 2018, loans to participants were permitted from the assets of the qualified institutions, Teacher's Insurance and Annuity Association (TIAA) and College Retirement Equity Fund (CREF). For all outstanding Plan loans, participant account investments of 110% of the Plan loan balance was pledged as collateral. The collateral was held in the TIAA Traditional Annuity. All Plan loan repayments and interest were paid by participants to the qualified institutions on a monthly or quarterly basis. Management does not believe that these Plan loans were prohibited transactions. During the period January 1, 2023 to March 31 2023, the remaining Plan loan was deemed to be in default and is included in benefits paid to participants in the accompanying statement of changes in net assets. There was no remaining balance in Plan loans as of the Transfer Date. The total outstanding Plan loan balance as of December 31, 2022 was \$4,305. New Plan loans were not permitted in the Plan after December 31, 2017.

### **Notes Receivable from Participants**

Beginning January 1, 2018, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the balance of their account. Participants borrowing from their investment in the TIAA Traditional account or Real Estate account were further limited to a maximum borrowing of 45% of their combined account balance

in the two investments, or 90% of their balance in each investment. A participant could have up to three loans outstanding at any time. The loans were secured by the balance in the participant's account and bore a reasonable rate of interest as defined in the Plan document. For the period from January 1, 2023 to March 31, 2023, loans had a rate of 4.25% to 9.25% for the term of the loan, not to exceed 5 years, or 15 years if used for the purchase of a residence. Principal and interest were paid through payroll deductions.

### **Payment of Benefits**

At the time of death, disability, termination of service, or retirement, a participant, or their beneficiary, whose vested account balance exceeded \$5,000, could elect to receive a payment of the vested interest in their account in a lump-sum distribution, partial or installment payments, or from annuity contracts. A terminated participant no longer employed with the Plan Sponsor whose vested balance was \$5,000 or less could only receive payment as a lump-sum distribution equal to the participant's vested account balance.

Participants could withdraw vested accumulations at any time as a cash withdrawal after termination for all investments, excluding the TIAA Traditional. Participants were allowed to take lump-sum distributions of at least \$1,000 from the TIAA Traditional if they elected to do so within 120 days of the participant's termination date. Lump-sum payments from the TIAA Traditional were subject to a 2.50% surrender charge. All other withdrawals and transfers from the TIAA Traditional after 120 days from termination must be spread over ten annual installments over nine years and one day.

Under the Interest Payment Retirement Option (IPRO), participants between the ages of 55 and 69½ with balances of at least \$10,000 in the TIAA Traditional could elect to receive monthly payments equal to the guaranteed interest rate plus dividends that would otherwise be credited to their TIAA Traditional accumulations. Participants who selected the IRPO were required to receive monthly payments for a minimum of 12 months and also to continue such monthly payments until they requested a distribution from the TIAA Traditional.

### **Administrative Expenses**

Expenses for transactions which were specifically attributable to a participant's account, such as loan initiation fees, were deducted directly from that participant's account. The Plan document permits certain administrative expenses to be paid by the Plan. Participants were charged a fee based on the balance in their accounts for investment management and administrative services. These expenses were paid to a service provider of the Plan and therefore qualified as party-in-interest transactions. This fee is netted with investment returns in each participant's account. For the period from January 1, 2023 to March 31, 2023, the total fee netted in investment returns was \$8,402. The Plan Sponsor paid all other administrative expenses. The Plan Sponsor does not expect reimbursement from the Plan for these expenses.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck.

#### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for the non-fully benefit-responsive and fully benefit-responsive TIAA Traditional accounts which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value and contract value of investments includes interest, dividends, realized and unrealized gains and losses, and fees charged for investment management and administrative services on those investments. Interest income is recorded when received.

#### Notes Receivable from Participants

Notes receivable from participants were carried at their outstanding balance. Interest income was recognized when received. No allowance for credit losses was recorded as of March 31, 2023 or December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the note receivable to be in default, the note receivable balance was reduced, and a benefit payment was recorded. Notes receivable from participants qualified as party-in-interest transactions.

#### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 13, 2024, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institutions

All information in the accompanying financial statements, including investments held and notes receivable from participants at March 31, 2023 and December 31, 2022, and net change in fair value and contract value of investments and interest income for the period from January 1, 2023 to March 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by TIAA and CREF.

### 4. Investments

During 2022 and the period from January 1, 2023 to March 31, 2023, certain Plan investments, including the variable annuity contracts, the Real Estate account, and the TIAA Traditional investment, were managed by TIAA or CREF. TIAA and CREF were service providers of the Plan, and accordingly, transactions in these investments qualified as party-in-interest transactions.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2023 and December 31, 2022.

Investments as of December 31, 2022 in mutual funds and the money market fund are based on quoted market prices for the identical asset in an active market (Level 1).

Variable annuity contracts are investment products offered by insurance companies that operate similar to mutual funds. Investments in the variable annuity contracts as of December 31, 2022 are valued daily using their net asset value (NAV) (Level 1). The NAVs are based on fair value of the mutual funds, stocks, debt instruments and other securities in the accounts. The variable annuity contracts may be traded daily at their NAV.

Investments in the Real Estate account as of December 31, 2022 include real property, real estate joint ventures and marketable securities. The real properties are appraised and mortgage loans are valued at least once every calendar quarter. The Real Estate account obtains appraisals of its real estate properties throughout the quarter, which is intended to result in valuation adjustments that happen regularly throughout each quarter and not on one specific day in each period. In addition, an estimated daily equivalent of net operating income is taken into consideration and is adjusted for actual transactional activity. The remaining assets in the Real Estate account are primarily marketable securities that are valued on a daily basis. Participants can trade the Real Estate account daily at the published net asset value but because of the valuation methodologies the investment is considered to be Level 2.

The TIAA Traditional is an unallocated insurance contract with a guaranteed rate of return, which is the general obligation of TIAA. TIAA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the participants. A portion of the investment contract is considered to be non-fully benefit-responsive and therefore generally accepted accounting principles calls for it to be reported at fair value. A portion of the investment contract is considered to be fully benefit-responsive which is required to be reported at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Management of the Plan has reported both contracts at contract value as of December 31, 2022 and has not made a determination of the fair value of the investment, but does not believe the difference in fair value and contract value is material to the financial statements.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The stated interest rates on the TIAA Traditional investments ranged from 5.25% to 6.25% during the period from January 1, 2023 to March 31, 2023. From the period January 1, 2023 to March 31, 2023, no additional rate was paid to participants in the TIAA Traditional investments.

### 5. Income Tax Status

The Plan uses a volume submitter 403(b) plan created by TIAA, a service provider of the Plan. TIAA received an opinion letter from the Internal Revenue Service dated August 7, 2017, which states that the volume submitter 403(b) plan satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the TIAA opinion letter, the plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. The plan administrator believes the Plan has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
