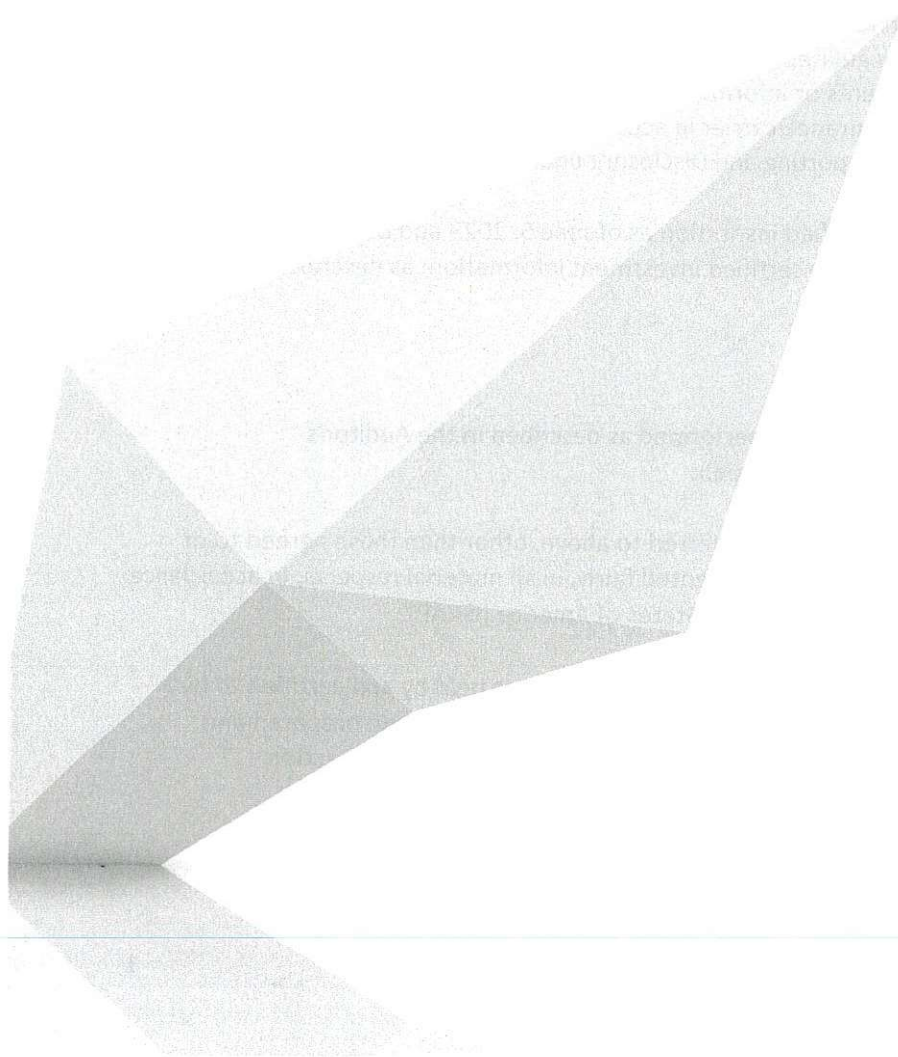

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Southwest Health Center, Inc. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 5, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended June 5, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Southwest Health Center, Inc. Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1: Description of Plan

The following description of the Southwest Health Center, Inc. Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Southwest Health Center, Inc. (the "Health Center") who are in a covered employment classification, have attained age 18, and have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. In 2019, an amendment was made to freeze the Plan effective December 31, 2019. In 2020 and forward, no employer contributions are allowed in the Plan. As of June 5, 2023, the Plan was merged and all funds held in the Plan were transferred to the Southwest Health Center, Inc. 403(b) TSA Plan.

#### Participant Accounts

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Vesting in the Health Center's discretionary matching contribution plus actual earnings (losses) thereon is based on years of service. Participants become fully vested after five years of service based on the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
1	20 %
2	40 %
3	60 %
4	80 %
5	100 %

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service during the Plan year.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount.

#### **Forfeitures**

At June 5, 2023 and December 31, 2022, forfeited nonvested accounts totaled zero and \$6,163, respectively. During the period ended June 5, 2023, administrative fees were reduced by \$21,576 from forfeited nonvested accounts.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts ("FBRICs"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Payment of Benefits**

Benefits are recorded when paid.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Health Center. Expenses that are paid by the Health Center are excluded from these financial statements. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in investment income (loss).

#### Subsequent Events

The Plan has evaluated subsequent events through October 14, 2023, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

### Note 3: Fair Value Measurements (Continued)

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no assets held by the Plan as of December 31, 2023.

### Note 4: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan invests in a FBRIC with Standard Insurance Company (The Standard) in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The rate was 1.26% at December 31, 2022. Such interest rates are reviewed quarterly for resetting.

Certain events limit the Plan's ability to transact at contract value with The Standard including Plan termination and other events as specified in the GIC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. A full liquidation of the GIC would require a 30 day written notice to the Health Center, for reasonable cause. Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply.

### **Note 5: Information Prepared and Certified by the Custodian**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments held at December 31, 2022, and net appreciation in fair value of investments, interest, and dividends for the period ended June 5, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company ("Reliance").

### **Note 6: Plan Termination**

The Health Center has discontinued its contributions to the Plan and has the right to terminate the Plan subject to the provisions of ERISA at any time. In the event of Plan termination, participants would become 100% vested in Health Center contributions. As of June 5, 2023, the Plan was merged and all funds held in the Plan were transferred to the Southwest Health Center, Inc. 403(b) TSA Plan.

### **Note 7: Tax Status**

The Health Center adopted a volume submitter document with an Internal Revenue Service opinion letter, which states the volume submitter document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Party-in-Interest Transactions**

Certain Plan investments are managed by Reliance, the custodian of the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees for the investment management services during the Plan period ended June 5, 2023, were offset against earnings. Specific detail for management fees is not available from the custodian.

Other service providers (e.g., third-party administration and broker) received compensation from the Plan. These providers receive all compensation indirectly from Plan investments and are offset against earnings.
