## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MidLantic Urology 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MidLantic Urology 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Opinion

**(1) DESCRIPTION OF PLAN**

The following description of the MidLantic Urology 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions. The Plan was formed on January 1, 2019.

In January, 2021, The Centers for Advanced Urology (“the Company”) was sold. As a result, the employees of the Company became participants of a successor plan effective January, 2022. A majority of the remaining Plan balance merged into a successor plan in May, 2023. A limited number of participants maintained a balance in the Plan as of December 31, 2023.

***General***

The Plan is a defined contribution plan covering all employees of the Company who have at least one year of service along with a minimum of 1,000 hours. The Plan excludes leased employees, employees governed by a collective bargaining agreement, unless such agreement expressly provides for participation in the Plan, and non-residential aliens who receive no income from sources within the United States. For purposes of the Plan’s service requirement, employees will receive credit for service performed with Urology Health Specialists, LLC, Academic Urology of PA, LLC, Urologic Consultants of Southeastern Pennsylvania, Bryn Mawr Urology Associates, Tri-County Urologic Associates, P.C., Urologic Associates of Montgomery County, Inc., Urology Center of Chester County, P.C., Associates in Urology, Urologic Health Associates, P.C., MacKinney Kohler & Kelsey, P.C., Abington Urological Associates, P.C., Meadowbrook Urological Associates, P.C., Patrick J. Lenahan, M.D., P.C., Center for Urologic Care of the Main Line, Independence Urology, Inc., Southeastern PA Urologic Surgery, P.C., AKSM Oncology Inc., Suburban Urological, P.C., Western Main Line Urology, P.C., Urologic Associates of Chester County and Richard H. Charney, M.D. Employees who are eligible to participate in the Plan may join the Plan on January 1, April 1, July 1, or October 1 following the date on which they become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Prior to 2022, participants may contribute pre-tax annual compensation up to the dollar limit set by law, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Prior to 2023, the Company made a safe harbor contribution of 3% of compensation for all eligible employees on an annual basis. Additional profit-sharing amounts were contributed at the option of the Company's board of managers and were invested in a portfolio of investments as directed by the participant. Employees were entitled to a portion of any additional safe harbor or profit sharing regardless of whether or not they make elective contributions to the Plan. Contributions were subject to certain limitations as prescribed by the Internal Revenue Service.

Effective in 2022, all participant contributions were made to a successor plan. Effective in 2023, all employer contributions were also made to this successor plan.

If an employee leaves employment for military service and is re-employed under the Uniformed Services and Re-employment Rights Act of 1994, special rules apply to his/her elective deferrals, benefits, Company contributions and service credits.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) the Plan earnings, and charged with an allocation of administrative expense. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's profit sharing contributions plus actual earnings thereon is based upon their completed years of service in accordance with the following schedule:

Completed years of service	Vested Percentage
Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

Vesting in the Company's contributions also becomes 100% at normal retirement age, upon becoming totally disabled, or upon death.

***Participant Notes Receivable***

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in installments over a period of time to be determined by the Plan Administrator. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a lump sum distribution.

***Hardship Withdrawals***

Participants are generally not permitted to make in-service withdrawals from their accounts prior to the attainment of age 59½; however, the employer may authorize withdrawals from a participant's account in the event of "proven financial hardship." Hardship withdrawals are subject to specific statutory and regulatory requirements.

***Forfeited Accounts***

At December 31, 2022, available forfeited non-vested accounts totaled \$23,974. Forfeitures shall be used first to offset plan expenses and any excess is used to reduce future employer contributions. During 2023, \$25,574 of forfeitures were used to pay plan expenses. The remaining forfeiture balance was transferred to the successor plan in May, 2023. There was no forfeited non-vested account balance at December 31, 2023.

***COVID-19 Changes***

In March, 2020, the World Health Organization characterized a novel strain of coronavirus (COVID-19) as a pandemic. In response to the COVID-19 pandemic, Congress passed the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) to provide financial aid for individuals and companies impacted by the coronavirus. The Plan has implemented certain provisions of the CARES Act in 2020.

***Basis of Accounting***

These financial statements have been prepared using a modified cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles. Under the modified cash basis of accounting, other than recognizing unrealized gains and losses on investments, revenue is recognized when received rather than when earned and expenses when paid rather than when incurred.

*Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Participant Notes Receivable*

Notes receivable from participants are measured at their unpaid balance. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Transactions and servicing fees are charged to the borrowing participants by the Plan's record-keeper.

*Payment of Benefits*

Benefits are recorded when paid.

*Investment Valuation and Income*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Record-keeping fees are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

**(3) SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIAN (UNAUDITED)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2023 and 2022, net appreciation/depreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Bank ("Charles Schwab") (the custodian of the Plan).

Investment income and interest income on notes receivable from participants certified by the custodian for the year ended December 31, 2023 were \$4,155,804 and \$5,090, respectively.

**(4) FAIR VALUE MEASUREMENTS**

Accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access

Level 2      Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Valued at quoted market prices that represent the net asset value of the securities held in such funds.

Common/collective trusts: Valued at the NAV of units of the common/collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value as of December 31, 2023 and 2022:

**(5) STABLE VALUE FUND**

The Morley Stable Value Fund is a collective investment trust whose objective is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile and liquidity for benefit responsive payments. The fund invests primarily in a variety of high quality stable value investment contracts as well as cash and cash equivalents. Unit holders may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value daily. Withdrawals other than benefit payments and transfers require twelve-month advance written notice. Certain Plan sponsor-directed actions also require written notice and may limit the ability of unit holders to transact at contract value. Such events include, but are not limited to: (i) trustee or Plan sponsor-directed reallocation of investments; (ii) company-sponsored layoffs/terminations of groups of employees; (iii) disposing of or selling a component of the business which involves the transfer of termination of employees; (iv) terminating the Morley Stable Value Fund as an investment option of the Plan; and (v) terminating the Plan.

**(6) PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts. As described in Note 1, the Company merged a majority of the Plan in 2023.

**(7) TAX STATUS**

The Internal Revenue has determined and informed MandMarblestone, as the designer of the prototype plan the Company has adopted, in a letter dated June 30, 2020 that the Plan and related trust under which it operates are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

**(8) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
