Note 1 – Description of the Plan

The following description of the Delt Services LLC (the "Company", "Plan Administrator", or "Plan Sponsor") 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan, which was established May 1, 2015, that is generally available to all employees of the Company and Participating Employers (collectively, the "Employer") who have completed 3 months of service. The Plan excludes leased employees and reclassified employees. Employees may enter the Plan on the first day of the month coincident with or after meeting the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Plan Merger. Effective December 31, 2023, the Delt Services LLC 401(k) Plan was merged into the PharmaCann Inc. 401(k) Plan and all assets and liabilities of the Plan became assets and liabilities of the PharmaCann Inc. 401(k) Plan.

Contributions. The following types of contributions are allowable under the Plan:

- Salary Deferral Contributions – Participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Additionally, participants may contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. A participant's total salary deferral contributions cannot exceed \$22,500 (\$30,000 if 50 or older) in calendar year 2023.
- Discretionary Employer Matching Contributions – The Company may make a discretionary Employer matching contribution to eligible participants each Plan year. For the year ended December 31, 2023, the Company made a discretionary matching contribution equal to 100% of a participant's salary deferral contributions that do not exceed 3% of their compensation, plus 50% of a participant's salary deferral contributions in excess of 3% but not in excess of 5% of the participant's compensation.
- Discretionary Nonelective Employer Contributions – The Company may make a discretionary nonelective Employer contribution to those eligible participants who are employed by the Employer on the last day of the Plan year. This contribution is allocated to each eligible participant's account in the ratio that each participant's compensation bears to the compensation of all eligible participants. For the Plan year ended December 31, 2023, the Company did not make a discretionary nonelective Employer contribution.
- Rollover Contributions – Certain amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants.

Participant Accounts. Each participant's account is credited with the participant's contributions (salary deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (discretionary matching and discretionary nonelective), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their salary deferral contributions, rollover contributions, prior safe harbor Employer contributions, discretionary nonelective Employer contributions, and related earnings thereon. Discretionary Employer matching contributions are subject to a six year graded vesting schedule. Participants become 20% vested after two years of service ("YOS") and in 20% increments per YOS thereafter such that participants become 100% vested in their discretionary Employer matching contribution accounts after completing six YOS. Additionally, participants who incur a severance from employment due to death or disability also become 100% vested in the Employer matching contribution portion of their accounts.

Forfeitures and Unallocated Asset Accounts. When certain terminations of Plan participation occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay administrative expenses of the Plan or are used to reduce discretionary Employer contributions. During 2023, forfeitures totaling \$187,575 were used to offset discretionary Employer matching contributions. The Plan also maintains unallocated asset accounts. The combined balance in the forfeitures and unallocated asset accounts was \$0 and \$106,056 as of December 31, 2023 and 2022,

Plan Expense Account. The Plan maintains a Plan Expense Account ("PEA") that is funded by revenue credits and used to pay administrative expenses of the Plan. During 2023, the PEA received \$23,745 in revenue credits, all of which was used to pay administrative expenses of the Plan. The balance in the PEA was \$0 as of December 31, 2023 and 2022.

Investment Options. Participants may direct their investments into various mutual funds and an investment contract with insurance company.

Payment of Benefits. Benefits to participants or beneficiaries generally are payable as a lump sum or rollover distribution equal to the value of their vested account balance upon retirement, disability, death, or termination of the participant. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Additionally, participants may request an in-service withdrawal of their rollover contributions account, upon attainment of age 59½, or upon a deemed severance distribution.

Note 2 – Summary of Significant Accounting Policies

Use of Estimates and Basis of Accounting. The financial statements of the Plan are prepared on the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value, except for the Plan's investment in an investment contract with insurance company which is stated at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for a discussion of

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

Benefits Payments. Benefits are recorded when paid.

Excess Contributions Payable. Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code ("IRC") are recorded as a liability and corresponding expense. The Plan distributes the excess contributions to applicable participants after the Plan's year end.

Expenses and Revenue Credits. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Included in administrative expenses are recordkeeping, withdrawal charges, and other fees. Certain investment related expenses are included in net appreciation in fair value of investments.

The Plan receives revenue credits from the Plan's service provider based on a percentage of assets in the Plan. Revenue credits are used to offset the Plan's administrative expenses. During 2023, total administrative expenses and revenue credits netted to \$86,525, which consisted of \$110,270 in administrative expenses and \$23,745 in revenue credits.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2023 (Plan Merger Date) and 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Investment Contract with Insurance Company

In 2015, the Plan entered into a traditional benefit-responsive investment contract, the Key Guaranteed Portfolio Fund, with Empower Annuity Insurance Company of America ("EAIC"). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2023 and 2022 was \$0 and \$159,622, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include:

- Declaration of a Contribution Cessation Date: Either EAIC or the Plan Sponsor may request a Contribution Cessation Date upon a 90 day written request to the other party. In the event a Contribution Cessation Date is declared by either party (i) no further contributions will be made under the terms of the investment contract and (ii) no new participant accounts will be established. Furthermore, on the Contribution Cessation Date, the Plan Sponsor may elect a Cessation Option in which (i) the Plan Sponsor may direct EAIC to maintain participant's accounts until it is applied to a Payment Option or distributed to a participant or beneficiary or (ii) EAIC will pay the Plan Sponsor the contract value of the investment contracts, however, EAIC reserves the right to defer the payment of this amount for a period up to 12 months from the Contribution Cessation Date.
- Contract Termination: Either EAIC or the Plan Sponsor may terminate the investment contract upon a 60 day written notice to the other party. In the event of contract termination, a Contract Termination Charge may apply in addition to other contract charges and fees. Contract Termination Charges will apply if the investment contract is terminated prior to EAIC's recovery of any and all Start-Up Costs incurred by EAIC.
- Plan Termination: In the event of Plan termination, a Contract Termination Charge, as described above, may apply in addition to other contract charges and fees.

The Plan administrator does not believe that the occurrence of any contract provisions which would limit the Plan's ability to transact at contract value with participants is probable.

Note 5 – Certified Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2023 (Plan Merger Date) and 2022;
- Investment amounts, as shown in Notes 3 and 4; and
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023 (Plan Merger Date).

Note 6 – Tax Status

The Company has adopted an Empower Retirement, LLC Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received a favorable opinion letter from the Internal Revenue Service (“IRS”) on November 14, 2022, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan and pre-approved plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 31, 2023 (Plan Merger Date) and December 31, 2022. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 (Plan Merger Date) and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments were shares of mutual funds and an unallocated insurance contract offered by Empower. As Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the custodians of the Plan, these transactions qualify as party-in-interest transactions. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 9 – Nonexempt Prohibited Transactions

During 2023, 2020, and 2019, the Company had nonexempt prohibited transactions related to participant contributions not remitted to the trust in a timely manner as listed on Schedule H, Line 4a: Schedule of Delinquent Participant Contributions. The Company corrected the 2020 and 2019 late contributions by remitting the principal amount of these late contributions into the Plan's trust in November 2022 and lost earnings into the PharmaCann Plan's trust in April 2024. The Company intends to correct the 2023 late contributions as soon as administratively feasible.

As of December 31, 2022, there were two investments which individually represented more than 10% of net assets available for Plan benefits.

Note 11– Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.
