Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **NOTE A -- Description of plan and significant accounting policies**

The following brief description of Women's International Pharmacy, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Women's International Pharmacy, Inc., (employer) has adopted the AT Retirement Services LLC Defined Contribution Pre-Approved Plan, under the name, Women's International Pharmacy, Inc. Profit Sharing Plan, originally effective April 1, 1992, with the most recent restatement effective January 1, 2022.

On June 1, 2023, the plan administrator approved the merger of this Plan into the Belmar Companies 401(k) Plan (Belmar Plan), effective January 1, 2024. As a result, all investments were transferred from the Plan into the Belmar Plan.

#### **General**

The Plan is a defined contribution profit sharing plan with elective deferral 401(k) features covering employees who have attained the age of 18 and have completed 250 hours of service within three months of hire or have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 39-1614520, and the Plan's number is 001.

#### **Contributions**

Each year, participants may elect to make pre-tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan is a safe harbor plan and is intended to meet the 401(k) discrimination limits. The employer will make a safe harbor contribution equal to 100% of participant elective deferrals not exceeding 3% of compensation, plus 50% of participant deferrals in excess of 3% but not in excess of 5% of compensation for each eligible participant. Discretionary matching contributions and profit-sharing contributions are not allowed by the Plan. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

#### **Participant accounts and "rollovers"**

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contribution, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of employer contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

#### Vesting

Participants are immediately vested in their contributions, employer contributions, and rollovers plus actual earnings thereon.

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as Prime Rate plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

#### Benefits

On termination of service due to death, disability, retirement (59½) or termination, participants (or beneficiary where applicable) are entitled to a distribution as a lump-sum amount or in approximately equal cash installments, payable at least annually, over periods specified in the Plan document. The Plan permits hardship distributions if certain criteria are met and are made from certain account balances. The Plan permits in-service distributions at age 59½. A participant with an account valued at less than \$1,000 shall receive a lump-sum distribution. For accounts exceeding \$1,000 the participant may elect a lump-sum distribution or may elect to defer such distribution to any valuation date subsequent to termination but no longer than the valuation date of normal retirement; or the participant may elect to rollover the distribution to another qualified Plan. If a timely election is not made with respect to a cash-out distribution of an amount less than or equal to \$5,000, a direct rollover is made for the participant's vested account balance to an Individual Retirement Account or Annuity (IRA).

A summary of significant accounting policies follows:

#### Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note D for discussion of fair value measurements. All Plan assets were transferred to the Belmar Plan before the close of business on December 31, 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Administrative expenses**

The employer pays certain expenses on behalf of the Plan which are excluded from these financial statements. The major administrative expenses are trustee and custodial fees.

#### **Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded.

#### **Subsequent events**

These financial statements have not been updated for subsequent events occurring after October 14, 2024, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

### **NOTE B -- Information certified by the trustee and asset custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023 and 2022, and interest, dividends, net appreciation, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Johnson Bank, the asset custodian and trustee of the Plan.

### NOTE C -- Party-in-interest transactions

Certain Plan investments are managed by Johnson Bank. Johnson Bank is the trustee, asset custodian and recordkeeper of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Johnson Bank provides certain administrative services to the Plan pursuant to an agreement between Women's International Pharmacy, Inc. (Plan Sponsor) and Johnson Bank. Johnson Bank receives revenue from mutual fund service providers for services Johnson Bank provides to the funds. This revenue is used to offset certain amounts owed to Johnson Bank for its administrative services to the Plan.

If the revenue received by Johnson Bank from such mutual fund service providers exceeds the amount owed, Johnson Bank remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Johnson Bank for administrative expenses not covered by revenue sharing.

### NOTE D -- Fair value measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

### NOTE D -- Fair value measurements (Continued)

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

- Money market fund: Valued based on quoted net asset values of the shares held by the Plan at year-end.
- Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023, are reported in net appreciation in fair value of investments.

### NOTE E -- Tax status

The AT Retirement Services LLC Defined Contribution Pre-Approved Plan, referred to in Note A, that the Plan has adopted effective January 1, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### NOTE F -- Plan termination

The company had the right under the Plan, to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company discretionary contributions.

### NOTE F -- Plan termination (Continued)

Effective June 1, 2023, the company executed agreements to merge the Plan with the Belmar Companies 401(k) Plan. The effective date of the plan merger is January 1, 2024 (Note A). Due to this being a Plan merger and not a plan termination, Plan obligations were not settled with the participants and the assets and obligations of the Plan were transferred to Belmar Companies 401(k) Plan.

### NOTE G -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE I -- Plan restatement**

Effective January 1, 2022, the Plan was restated to bring the Plan into compliance with the requirements of the 2017 Cumulative List (Notice 2017-37). In addition, the restatement included amendments to (1) include an automatic deferral provision at a fixed 5% rate, (2) allow participants to borrow from their fund a minimum of \$1,000 up to a maximum equal to 50% of their vested account balance, (3) allow participants to change their deferral amount at any time, and (4) update the employer safe harbor contribution to apply only to those participating in the Plan
