Management, having determined it is permissible in the circumstances, has elected to have the audit of the Kuehne + Nagel 401(k) Plan's 2023 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2023, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kuehne + Nagel 401(k) Plan’s ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Notes to Financial Statements – Modified Cash Basis Years Ended December 31, 2023 and 2022

1. Description of Plan

The following description of the Kuehne + Nagel 401 (k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's terms and provisions.

General

The Plan is a defined contribution plan and was established by Kuehne + Nagel, Inc. (the Company or Plan Sponsor) effective under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees (Union and Non-Union) of the Company. Eligible employees can enroll into the Plan upon employment or as soon as practicable thereafter. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective January 1, 2023, the Plan was amended to allow for the merger of the Commodity Forwarders Inc. 401(k) Plan. As a result of the merger, net assets totaling \$3,897,074 were transferred into the Plan during the year ended December 31, 2023, of which included outstanding balances of the notes receivable from participants totaling \$129,115.

Contributions

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan currently offers various investment options for participants. The Company contributes 100 percent of the first five percent of base compensation that a participant contributes to the Plan. Contributions are subject to certain limitations, as defined in the plan document.

Effective as of January 1, 2017, any non-collectively bargained participant, Local 560 participant, collectively bargained K participant, Local 337 participant, and Local 25 participant who has made election to make before-tax contributions to the Plan (whether an affirmative election or pursuant to an automatic compensation reduction) shall be deemed to have elected to increase by 1% (from 3% to 4%) the amount of his or her before tax reduction effective each April 1 (automatic increase). A participant who has elected to contribute 0% of his or her compensation to the Plan or who has elected to contribute 10% or more of his or her compensation to the Plan will not be subject to the automatic increase.

Rollovers

Participants may rollover amounts representing distributions from other qualified plans into the Plan. Participant rollover contributions made to the Plan amounted to \$7,576,276, during the year ended December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and allocations of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested, in full, in their contributions and the earnings thereon. All safe-harbor employer contributions are immediately vested and are non-forfeitable.

Notes Receivable from Participants

Participants may borrow from their participant-directed account balance, with a minimum loan amount of \$1,000, up to a maximum equal to the lesser of: (a) \$50,000 or (b) 50% of their vested account balance. On December 3, 2015, the Plan adopted an amendment effective as of January 4, 2016 to allow a maximum of one loan per participant to be outstanding at any time. All loans shall be evidenced by a promissory note and interest accrues at a defined rate at the inception of the loan. The interest charged on the outstanding loan balances ranged from 3.25% to 8.50% with maturities ranging from 2024 through 2033. Principal plus interest on participant loans is repaid in equal installments through payroll deductions each pay period. A loan will be considered to be in default if payment is not made within 90 days following the end of the month in which the missed payment was due. If a participant defaults on a loan, the participant will be treated as having received a taxable distribution of the entire outstanding value of the loan, plus accrued interest.

Payments of Benefits

Participants or their beneficiaries are entitled to their full account balance upon (a) retirement on or, after age 55 with five years of service; (b) attainment of age 65; (c) death; or (d) disability. Participants are entitled to their vested account balance upon termination for any reason other than retirement, death or disability. Prior to age 65, in-service withdrawals from the Plan are allowed for defined unusual hardships. Distributions are paid directly to an eligible retirement plan specified by the participant (or designated beneficiary) in a direct rollover or to an Individual Retirement Account. Distributions can also be a direct lump sum distribution, if so elected.

Participant accounts of \$1,000 or less will be paid automatically upon separation. In addition, accounts will automatically be paid in full to the beneficiary upon death. In the event that a participant with an account balance between \$1,000 and \$5,000 becomes eligible to receive a distribution before retirement and does not elect to receive the distribution in a lump sum distribution or roll it over to an eligible qualified plan, the administrator of the Plan will distribute the participant account balance to an individual retirement plan designated by the administrator.

Forfeitures

Nonvested profit-sharing contributions shall be forfeited by a participant who terminates employment and shall be used to reduce subsequent employer match and declared discretionary contributions under the Plan. As of both December 31, 2023 and 2022, forfeited non-vested were \$0.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on a modified cash basis. Therefore, with the exception of appreciation or depreciation in the fair value of investments, income and expense items are recognized only as cash is received or paid; therefore, contributions and interest receivables and accrued expenses are not reflected.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment income and appreciation (depreciation) for each participant-directed investment fund is allocated to each participant in the same ratio that the participant's account balance in the fund bears to the total account balance, for all participants in that fund.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the date received. Realized gains and losses are recognized on the transaction date, as reported by T. Rowe Price, the directed trustee of the Plan. Interest income on notes receivable from participants is recorded as received, and there were no significant amounts of investment income due to the Plan at December 31, 2023 and 2022.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and are expensed as paid. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default if payment is not made within 90 days, the participant loan balance is reduced, and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. In addition, personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no cost to the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 11, 2024, the date these financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company ("T. Rowe"), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value:

- Mutual funds: Shares held by the Plan at year-end are valued at unadjusted quoted prices in active markets.
- Common collective trusts (CCT): The fair value of the common collective trusts is determined by the custodian of the common collective trust fund based on the underlying assets which represent NAV.

Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

- (a) In accordance with Subtopic 820-10, certain investments that were measured at Net Asset Value per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefit.

5. Income Tax Status

The Plan received a favorable determination letter from the Internal Revenue Service (IRS) on March 28, 2018 for the amended and restated Plan, effective January 1, 2017. Plan management believes that the Plan is currently designed and being operated in material compliance with the applicable requirements of the IRC, except for certain operational and administrative issues as discussed in Note 9. The Plan Sponsor believes the Plan has maintained its tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Kuehne + Nagel 401(k) Plan

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state tax authorities. The Plan Administrator has analyzed the positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant's accounts and distributed in accordance with the Plan provisions.

7. Risks and Uncertainties

The Plan's investments are concentrated in funds that invest in various investment securities. Such securities are subject to various risks, such as interest rate, market and credit risks, that determine the value of the investments. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

8. Related Party Transactions and Parties-In-Interest

The Plan investments were managed by T.Rowe and, therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2023, the Plan paid \$542,102 to T.Rowe for administrative fees.

9. Voluntary Correction Program

During 2021, the Company discovered certain coding errors relating to excess employer matching contributions related to the conversion to a new payroll system. These errors occurred from January 1, 2021 through August 20, 2021. The Company identified and quantified the financial impact to the individual participant accounts. As of the date of these financial statements, the excess employer matching contributions have been transferred from the individual participant accounts to a Plan Sponsor controlled account within the Plan. A Voluntary Correction Program (VCP) application was submitted to the IRS under the Employee Plans Compliance Resolution System ("EPCRS") in December 2022, outlining the foregoing operational issues and proposed resolution and corrective action. Subsequent to the filing of the VCP, additional matching errors were found. These additional matching errors have not been identified, quantified or corrected as of the date of these financial statements. Although the VCP submission is still pending with the IRS, all corrective action, as required by the IRS will be taken by the Plan Sponsor. No provision for income taxes has been included in the Plan's financial statements related to the foregoing matters because the Plan Sponsor believes that the Plan continues to be qualified, and the tax status of the related trust continues to be tax exempt.
