**REPORT OF INDEPENDENT CERTIFIED PUBLIC ACCOUNTANTS**

To the Trustees and Plan Administrator  
World Learning, Inc. Retirement Plan

We were engaged to perform audits of the financial statements of the World Learning, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Disclaimer of opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

**Basis for disclaimer of opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

**Other matter – supplemental schedule required by ERISA**

**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2023 and 2022**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of World Learning, Inc. ("World Learning") Retirement Plan (the "Plan") provides only general information. For a complete description of the Plan's provisions, participants should refer to the Plan agreement.

***General***

The Plan was established as of September 27, 1957, as a defined contribution plan. The Plan is subject to the provisions of section 403(b) of the Internal Revenue Code ("IRC") and the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan was amended on January 1, 2014, to adopt a safe harbor design.

***Eligibility***

Employees of World Learning who are at least 18 years of age are eligible to participate in the Plan upon employment. Students enrolled and regularly attending classes and who are employed by World Learning as part of a work study program are not eligible to contribute to the Plan.

***Contributions***

All eligible employees may make voluntary pre-tax deferrals up to 100% of their wages, not to exceed the maximum annual contribution allowed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. World Learning makes safe harbor match contributions equal to 100% of an employee's contribution amount up to 5% of his or her annual pay.

***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and World Learning's matching contributions, and an allocation of investment earnings and expenses. Participants direct the investment of their account balance into various investment options offered by the Plan, including an option to invest in a guaranteed fixed annuity contract, and may change their investment options at any time, subject to the terms of the investment options.

***Vesting***

Participants are immediately vested in all contributions, plus earnings thereon.

***Plan Loans***

Plan loans were available to participants through Teachers Insurance and Annuity Association and College Retirement Equities Fund ("TIAA"), subject to certain limitations. Plan loans were issued directly from the funds owned by TIAA and loan proceeds were not removed from a participant's account balance and, as such, are not assets of the Plan. Adequate security was required, and a portion of the participant's account was reserved, or held as collateral, to cover 110% of the outstanding loan in case of default. The collateral is held in the TIAA Traditional Annuity. For all Plan loans, principal and interest is paid directly by the participant to TIAA. Investments underlying defaulted loan balances are reflected in the Statements of Net Assets Available for Benefits until a distribution event (e.g., defaulted collateral) occurs.

At December 31, 2023 and 2022, participants had Plan loans outstanding of \$198,595 and \$257,919, respectively. As of December 31, 2023 and 2022, loans in default amount to \$101,074 and \$108,918, respectively. Such amounts include the principal and accumulated interest. During 2021, new plan loans were no longer permitted, and participants may borrow directly from their own participant account balance.

### **NOTES TO FINANCIAL STATEMENTS - CONTINUED**

**December 31, 2023 and 2022**

#### ***Notes Receivable from Participants***

Beginning in 2021, participants may borrow from their participant accounts at a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can have five loans outstanding at any given time. Loans are repayable within a period of five years unless for the purchase of a primary residence, in which case the loan must be repaid in a period not exceeding 30 years. The loans are secured by the balance in the participant's account and bear interest at rates which are equal to the Federal Reserve Board Bank prime loan rate plus 1% at the time of loan origination 4.25% - 9.5% for loans outstanding as of December 31, 2023). Principal and interest are either paid by the participants directly not to exceed a quarterly basis or through payroll deductions.

#### ***Payment of Benefits***

On termination of service, participants may elect to receive their distributions equal to the value of their account in either a lump-sum amount or in installments. In addition, participants may elect to roll their account into another qualified plan.

#### ***Early Withdrawal***

Under certain conditions, participants, while still employed by World Learning, are permitted to withdraw up to the employee contribution portion of their account balance. These conditions include, among others, un-reimbursed medical expenses, the purchase of a principal residence, the payment of post-secondary education tuition, or to prevent eviction from or foreclosure on a principal residence. A participant may also make a withdrawal from his or her account when the participant attains age 59½.

#### ***Plan Termination***

Although it has not expressed any intent to do so, World Learning has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### ***Participant Rollovers***

Participants may contribute distributions from other qualified plans. These rollover contributions are always 100% vested.

#### ***Administrative Expenses***

Administrative expenses incurred by the Plan are paid by World Learning. World Learning also provides certain accounting and management services to the Plan at no charge. A portion of the administrative expenses are paid by the Plan using service credits. The service credits received are recorded as other income and administrative expenses in the statement of changes in net assets available for benefits.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Presentation***

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

In November 2007, the Department of Labor ("DOL") issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting, disclosure, and audit requirements under Part 1 of Subtitle B of Title I of ERISA. The Plan, however, was established in 1957, and historically the Plan was viewed as a collection of individual contracts with which participants could engage in a range of

actions with limited involvement, if any, by the Plan sponsor. Accordingly, various accounting and payroll records related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, were not maintained by the Plan. Consequently, the financial statements have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, there can be no assurance as to the completeness or accuracy of the Plan's reported financial information.

#### ***Investment Valuation and Income Recognition***

Except for fully benefit responsive investment contracts, the Plan's investments are stated at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments sold, as well as unrealized gains/losses on investments held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023.

#### ***Payments of Benefits***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions. These estimates and assumptions affect the reported amounts of net assets available for plan benefits as of the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from those estimates.

#### ***Mutual Fund Fees***

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earning activity and thus are not separately identifiable as a plan expense.

### **NOTE 3 - SUMMARY OF FINANCIAL DATA CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and College Retirement Equities Fund ("CREF") (together, "TIAA and CREF"), the custodians of the Plan, have certified the following data included in the financial statements and supplemental schedule is complete and accurate. This certification also extends to those investments, if any, which TIAA, FSB, a federal saving association, held as a directed trustee or custodian that were record kept by TIAA:

- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.
- The schedule of assets (held at end of year) as of December 31, 2023.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### NOTE 4 - TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA CREF. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities ("RA"), Group Retirement Annuities ("GRA"), Supplemental Retirement Annuities ("SRA"), and Group Supplemental Retirement Annuities ("GSRA"). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA CREF's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA CREF's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the 3.00% guaranteed minimum and additional amounts make up the crediting interest rate.

The RA contract does not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. For GRA contracts, lump-sum withdrawals are available within 120 days of termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from RA and GRA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). The SRA and GSRA contracts provide for full participant-directed liquidity. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

#### NOTE 5 - FAIR VALUE MEASUREMENTS

US GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. Investments in TIAA Traditional Annuity contracts (RA and GRA) are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

The Plan's mutual funds invest principally in equity securities, fixed income instruments, and short-term instruments, in accordance with each fund's investment objectives. Plan holdings are valued based on their published net asset value of shares held by the Plan at year end.

TIAA CREF offers eight CREF variable annuities. Unlike the TIAA Traditional Annuity contracts, the variable annuities do not provide guaranteed returns. Participant returns depend entirely on the investment performance of each annuity. The annuities invest principally in equity securities, fixed income instruments, and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments, including matrix pricing. The CREF variable annuities reflect a structure similar to mutual funds and have a readily determinable fair value as reported by TIAA each day that current transactions are recorded.

In addition, TIAA CREF offers the Real Estate account, which is a pooled separate account of TIAA. This account is a variable account similar to the CREF variable annuities, as such, its returns are not guaranteed and its accumulations and returns fluctuate based on the performance of the underlying investments. The TIAA Real Estate account reflects a structure similar to mutual funds and has a readily determinable fair value as reported by NASDAQ and by TIAA each day that current transactions are recorded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) are reported in net depreciation in fair value of investments in the statement of changes in net assets available for benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Purchases of Level 3 investments were \$1,272,846 for year ended December 31, 2023. There were no transfers into or out of Level 3 investments for the Plan years.

Transfers out of the TIAA Real Estate Account to a TIAA or CREF account or into another investment option can be executed at any time but are limited to once per calendar quarter. Transfers out of the TIAA Traditional Annuity contracts can only be affected over a period of time (up to 10 years) and may be subject to other limitations. Transfers out of CREF funds and TIAA-CREF mutual funds into another investment option may be executed on a daily basis.

There are no unrealized gains or losses from the TIAA Traditional Annuity guaranteed investment contracts included in the statement of changes in net assets available for benefits as the contracts are recorded at contract value, which approximates fair value for purposes of the net assets available for benefits.

Significant increases or decreases in the above unobservable inputs in isolation would result in a significantly lower or higher fair value measurement for such assets.

**NOTE 6 - TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to reflect the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The Plan administrator and management believes the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and therefore the related custodial accounts are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by TIAA and CREF, an insurance entity and record-keeper for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Transactions within the revenue sharing account also qualify as party-in-interest transactions.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides various investments that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably

possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

In connection with the preparation of these financial statements, the Plan has evaluated events and transactions through October 11, 2024, which is the date the financial statements were available to be issued. Management is not aware of any other subsequent event which would require recognition or disclosure in the financial statements.
