Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Don McGill Toyota 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Don McGill Toyota 401(k) Plan's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - Don McGill Toyota 401(k) Plan (the Plan) was adopted effective January 1, 1992 and restated May 1, 2014 to establish a savings and investment plan for the exclusive benefit of the eligible employees of Don McGill of West Houston, Ltd. (the Company) and their beneficiaries. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting, which is acceptable under the Department of Labor Rules and Regulations. Interest and dividend income are recognized when earned. Purchases and sales of securities are recorded on a trade date basis.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States (GAAP) requires the Company as Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Participant Loans Receivable - Loans to participants are reported as a receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits.

Income Tax Status - The Company adopted a Prototype Non-Standardized Profit Sharing Plan (Prototype Plan) with a deferral arrangement. The Prototype Plan received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Prototype Plan and related trust, as amended, are designed in accordance with applicable sections of the Internal Revenue Code (Code). The Prototype Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Accordingly, the Plan administrator believes the Prototype Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2023, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2020 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events through October XX, 2024, the date the financial statements were available to be issued.

During September 2024, the Company submitted a termination letter to Ascensus and intends to transfer payroll, recordkeeping, and trustee services to ADP.

No other subsequent events occurred, which require adjustment or disclosure to the financial statements at December 31, 2023.

NOTE B PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - An employee is eligible to become a participant in the Plan on the first day of the month coincident of two consecutive months after the date of hire and having attained the age of 21.

Contributions - Participants may elect to make contributions (pre-tax and after tax) to the Plan in an annual amount ranging from 1% to 100% of their compensation. Contributions are made through authorized payroll deductions. These contributions by individual employees were limited to \$22,500 (participants under 50 years of age) and \$30,000 (participants 50 years of age or older) in 2023. This limitation is adjusted periodically to reflect cost-of-living increases.

For each Plan year, the Company may elect to contribute a qualified matching contribution or qualified non-elective contribution to the Plan in an amount to satisfy special nondiscrimination rules applicable to the Plan. The Company elected not to make a qualified matching contribution for 2023.

All new hires and employees not contributing to the Plan who meet eligibility requirements and have not declined participation are automatically enrolled to contribute 3% of eligible wages as pre-tax contributions.

Vesting - Participants are immediately vested in their salary deferrals, rollover contributions, and any Company contributions and related earnings.

NOTE B PLAN DESCRIPTION (CONTINUED)

Forms of Benefits - The normal form of benefit payable under this Plan is a lump sum. If the amount payable is \$1,000 or less, the participant may receive a lump sum distribution as soon as feasible following the date of termination. If the amount payable is \$5,000 or less and greater than \$1,000, the participant may receive a lump sum distribution or roll over the balance to an individual retirement account as soon as feasible following the date of termination. If the amount payable is greater than \$5,000, the participant must give written consent before the distribution can be made. Another available option is a single-sum payment of a portion of the account. Benefits are recorded when paid.

Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years or up to a reasonable period of time exceeding five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. Interest rates on loans outstanding at December 31, 2023 range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Investments - Each participant directs the investment of their account into any of the investment options designated by the Plan Administrator.

Each participant account is credited with the participant's contribution, the Company's contributions, and a pro rata share of the earnings of each fund in which the participant has invested.

Administration - The Company, as the Plan Administrator, may, at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Company will be paid by the Plan. Substantially all Plan expenses other than each fund's administration expenses were paid by the Company for 2023.

Plan Termination - The Company has the right under the Plan to terminate the Plan subject to provisions set forth in ERISA.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Unadjusted quoted prices for identical financial instruments in active markets that the Plan has the ability to access. All registered investment companies and interest-bearing cash are valued using Level 1 inputs.

Level 2 – Other significant observable inputs (including quoted prices in active and inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the financial instruments.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the financial instruments. The fair value of Level 3 financial instruments is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

NOTE D FAIR VALUE DISCLOSURES (CONTINUED)

Following is a description of the valuation technique used for assets measured at fair value. There have been no changes in the technique used during 2023 and 2022.

Registered investment companies and interest-bearing cash are valued at the market value of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation technique is appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no transfers in and/or out of the fair value levels during the years ended December 31, 2023 and 2022.

NOTE E PARTY-IN-INTEREST

The Plan invests in various funds offered by The Vanguard Group. These investments are considered party-in-interest transactions because The Vanguard Group serves as the asset custodian of the Plan, and its affiliate, Ascensus Trust Company, serves as the trustee of the Plan. The Plan Administrator has approved of these investment options.
