Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Bison Peak LLC (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 – Description of Plan

The following description of Bison Peak LLC (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution profit-sharing and 401(k) plan covering eligible employees of Bison Peak LLC (the “Company”). Employees are eligible to participate upon completion of one year of service and attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan is funded by voluntary contributions of participants, discretionary matching, and profit-sharing contributions of the Company. Participants may contribute to the Plan, through regular payroll deductions, an amount subject to limitations imposed by the Internal Revenue Code. Participants may also make catch-up contributions and roll over amounts representing distributions from other qualified employee benefit plans. All newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions are invested in a designated default investment. The Company made no discretionary matching contributions to the Plan for the year ending December 31, 2023.

Investment Options: Participants must direct their salary deferral contributions and the Company's contributions into a variety of investment funds made available and determined by the Plan Administrator. Participants may change their investment options at any time.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's flexible discretionary matching and profit-sharing contributions, and an allocation of plan earnings. The Company's flexible discretionary matching contribution is allocated based on the Company’s discretion. The Company uses the “Flexible Discretionary Matching Formula”, which consists of the discretionary matching contribution rate or amount, the limits on elective deferrals or employee contributions subject to match, participant match allocation limits, participants or categories of participants who will receive the allocation and the applicable time period. The Company's flexible discretionary profit-sharing contribution is allocated annually, as of the last day of the plan year.

Plan earnings are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Note 1 – Description of Plan (Continued)

Vesting: Participants are immediately fully vested in participant and rollover contributions plus the actual earnings thereon. Participants are 100% vested in employer nonelective contributions upon entering the Plan.

Payment of Benefits: On termination of service, death, disability or retirement, a participant may elect to receive a single, lump-sum payment equal to the value of his or her vested account balance, installments over a specified period of time, or a direct rollover distribution. Hardship withdrawals are also permitted by the Plan.

Hardship Withdrawals: Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the Plan document. The Company must approve any such hardship withdrawals.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants are permitted to take out one loan at a time from the Plan, a minimum of \$500 up to their vested account balances. The loans are collateralized by the borrowers' respective vested account balances and bear interest at Prime rate + 2%. Principal and interest are paid through payroll deductions over a period not to exceed five years, unless it is used to purchase a primary residence. Related interest income totaled \$15 for the year ended December 31, 2023.

Forfeitures: Participants who terminate their employment and are less than 100% vested in their employer's contributions forfeit their non-vested portion and must be disposed of as of the earlier of the last day of the Plan year in which the former participant incurs five consecutive 1-year breaks in service, or the distribution of the entire vested portion of the participant's account. Forfeitures can be used to pay for administrative expenses and reduce Company contributions on a per payroll period basis. There were no unallocated plan assets resulting from forfeited non-vested accounts, reduction to Company contributions, and payment for the Plan's administrative expenses during the year ended December 31, 2023.

Note 2 – Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of net assets, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Payments of Benefits: Benefits are recorded when paid.

Accounting for Uncertainty in Income Taxes: Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses: The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Certain plan expenses incurred, that can be attributable to a particular participant may be charged to that particular participant's account. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 – Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their respective account balances.

Note 6 – Tax Status

Effective January 1, 2022, the Plan adopted a standardized form of a prototype plan sponsored by Automatic Data Processing, Inc. The IRS has opined and informed the Company by an updated letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Note 7 – Party-in-Interest Transactions

Plan investments are managed by Reliance Trust Company. Reliance Trust Company, is the trustee as defined by the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment. Another party-in-interest is Tighe, Kress & Orr, P.C., who serves as the auditor of the plan. These transactions qualify as party-in-interest transactions.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Date of Management's Review

The Plan has evaluated subsequent events through the date of this report, the date the financial statements were available to be issued. It was concluded that there are no subsequent events that are required to be disclosed.
