Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of the Plan

The following description of the Terminix Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Terminix Company, LLC and its subsidiaries (the “Company” or the “Employer”) who have attained the age 18 with 30 days of service and are not covered by the collective bargaining agreement that does not allow for Plan participation, a nonresident alien, or a leased employee. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”) serves as the Plan’s trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In October 2022, the Company was acquired by Rentokil North America Inc. The Plan merged into the Rentokil Initial USA 401(k) Plan (“Rentokil Plan”) effective January 1, 2024. On December 29, 2023, Plan assets were transferred to the Rentokil Plan.

Contributions

Each year, a participant could contribute a portion of his or her compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations, in the form of a salary deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company’s matching contribution was 100% of pretax contributions up to 1% of compensation, up to \$330,000, and a 50% matching contribution of the next 5% of pretax contributions to the Plan.

Investment Options

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered common collective trusts funds, a stable value collective trust fund, and mutual funds as investment options for participants.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of the Company’s discretionary contributions, and plan earnings (losses), and charged with benefit payments, distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Participants are 100% vested in the Company’s contribution portion of their accounts plus actual earnings thereon after 2 years of continuous service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. On December 29, 2023, outstanding loans bearing interest rates ranging from 4.25% to 9.50% were transferred to the Rentokil Plan.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installments and annuity options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age normal or early retirement age, upon the date the participant becomes fully disabled, or upon death.

Forfeitures

Forfeitures are either used to pay Plan expenses or used to reduce Company contributions. Forfeited non-vested accounts amounted to \$0 and \$251,588 at December 31, 2023 and 2022, respectively. During the year ended December 31, 2023, forfeited non-vested accounts of \$348 were used to pay Plan expenses and \$1,586,758 were used to reduce Company contributions. On December 29, 2023, forfeited non-vested accounts of \$414,643 were transferred to the Rentokil Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when received. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2024, the date the financial statements were available to be issued.

Note 3. Unaudited Information Certified by Trustee

The accompanying financial statements include the following unaudited information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, that was obtained from data prepared and certified to be complete and accurate by the Plan's trustee.

Note 4. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2023 and 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common Collective Trusts

These funds are valued at the net asset value (“NAV”) of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The common collective trust fund is not required to be classified within a level on the fair value hierarchy.

Stable Value Collective Trust Fund

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV per share provided by Principal as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

On December 29, 2023, Plan investments were transferred to the Rentokil Plan trustee, pending the effective date of the merger into the Rentokil Plan. Pending completion of transfer, Plan assets were held as temporary cash as of December 31, 2023.

Note 5. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated November 17, 2017, that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Exempt Party-In-Interest Transactions

Certain Plan investments were funds managed by the Trustees as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Total administrative fees paid to the Trustees by the Plan were \$1,020,852 for the year ended December 31, 2023.

Note 8. Non-Exempt Party-in-Interest Transaction

During the 2023 plan year, there were unintentional delays by the Company in submitting participant contributions in the amount of \$1,216,692 to the trustee. These delinquent contributions constitute prohibited transactions, and the Company has made contributions to the affected participants’ accounts to compensate those participants an aggregate of approximately \$2,528 for potential lost income due to the delays.
