Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of ***onsemi Union Savings and Retirement Plan*** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

(1) Description of the Plan

The following description of the onsemi Union Savings and Retirement Plan, (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

- A. **General** – The Plan was adopted and became effective for participation on September 19, 2016 and was restated on February 1, 2021. The Plan is a defined contribution plan covering all eligible union employees of ON Semiconductor Corporation and its subsidiaries (the "Company"). The Plan is the successor plan to the Fairchild Union Savings and Retirement Plan (the "Fairchild Plan") with respect to those employees of the Company who were participants in the Fairchild Plan. Prior to August 15, 2023, Vanguard Fiduciary Trust Company ("VFTC") served as trustee and custodian of the Plan's assets. Effective August 15, 2023, Fidelity Management Trust Company ("FMTC") became the trustee and custodian of the Plan's assets. Fidelity Workplace Services, LLC ("Fidelity") provides recordkeeping and administrative services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company serves as the Plan Administrator.
- B. **Eligibility** – Under the provisions of the Plan, an 18 year or older employee of the Company is eligible for participation in the Plan on the date which the employee commences employment with the Company as long as the employee is included in a unit covered by a collective bargaining agreement which authorizes participation in the Plan, unless the employee is a nonresident alien or leased employee.
- C. **Contributions** – Upon satisfying the eligibility requirements, employees of the Company are automatically enrolled in the Plan, with a default deferral rate of 4% of his or her compensation. Deferral rates automatically increase 1% each year until they reach 15%. Employees not desiring to participate in the Plan, or who desire to contribute at a different rate must elect so affirmatively. Plan participants make changes to their deferral percentage by contacting the trustees. Deferral amounts are limited by the Internal Revenue Service ("IRS") in each Plan year. Participants in the Plan who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For the year ended December 31, 2023 participants that qualified for the catch-up provision could make an additional contribution of up to \$7,500.

The Plan provides for the Company to make a discretionary matching contribution. For the year ended December 31, 2023, the matching contribution is an amount equal to the employee's elective deferrals that do not exceed 4% of the employee's compensation for the Plan year.

The Plan also provides that the Company may contribute to the Plan in the form of discretionary profit sharing contributions. This amount, if any, will be determined by the Company. The Company did not make discretionary profit sharing contributions for 2023.

- D. **Vesting** – Participants are immediately vested in their contributions, the Company's matching and profit sharing contributions, plus actual earnings thereon.
- E. **Participant accounts** – All investment options are participant-directed. A separate account is maintained for each investment option of a participant by type of contribution. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses. Plan earnings are allocated and credited to the account daily based on the adjusted balance of each participant's account. The benefit to which a participant is entitled is the benefit from the participant's vested account.

(1) Description of the Plan (continued)

- F. **Investment options** – Participants may direct their contributions and the Company’s contributions into various investment choices provided by the Plan. Additionally, participants may transfer funds between investments.
- G. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the previous 12 months, or 50% of their account balance. Loan terms can be no longer than five years, or up to ten years subject to the Plan Administrator’s discretion, for the purchase of a primary residence. The loans are collateralized by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates in accordance with the Plan’s provisions. Principal and interest are paid ratably through payroll deductions. Interest rates for participant loans outstanding at December 31, 2023 ranged from 3.25% to 9.5%.
- H. **Payment of benefits** – In the case of a normal retirement, retirement due to permanent disability or termination of employment, participants may elect to receive the value of their account balance in a lump sum, in accordance with the provisions of the Plan. In the event that a participant dies before retirement, his or her beneficiary will receive the value of the participant’s account balance in a lump-sum distribution, less the value of outstanding loans made to the participant. Participants qualifying for a hardship withdrawal may receive all or a portion of their contributions, plus investment return earned thereon, but not more than the amount necessary to meet the financial hardship. The Plan has adopted a cash out policy for participants with balances of \$5,000 or less to be distributed within a reasonable amount of time after the participant’s termination from the Company’s employment. The monies will be rolled over into a fund designated by the Plan until the participant chooses to take a distribution.
- I. **Forfeitures** – At December 31, 2023 and 2022, there were no forfeited accounts. All accounts are immediately vested.
- J. **Administrative expenses** – Plan participants pay costs associated with record keeping and certain investment expenses such as fund withdrawal fees, which are deducted from the respective participant’s account. Also, fees are paid by the account of the participant taking the loan. The Company pays all other Plan administration costs.
- K. **Termination of the Plan** – Although it has not expressed as an intention to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA.

(2) Summary of significant accounting policies

A summary of the Plan’s significant accounting policies follows.

Basis of accounting – The accompanying financial statements of the Plan have been prepared using the accrual method of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

(2) Summary of significant accounting policies (continued)

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Management is also required to make estimates associated with the disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments in shares of mutual funds are stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. The self-directed brokerage account investments in mutual funds are also stated at net asset values. Net asset values are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. Common stock, corporate bonds, preferred stock, warrants, and interest-bearing cash in the self-directed brokerage accounts are valued at the closing price reported on the active market on which the securities are traded. The common collective trusts are valued based upon the quoted redemption value of units, or the equivalent of net asset value, which is a practical expedient for estimating fair value. These investments have no unfunded commitments as of December 31, 2023 and 2022, and can be redeemed daily with no redemption notice period or other redemption restrictions.

These methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties – The Plan provides for various investment fund options, which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest.

Payment of benefits – Benefits are recorded when paid.

Subsequent events – The Plan has evaluated subsequent events through October 11, 2024, which is the date the financial statements were available to be issued.

(3) Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) Tax status

The Plan has adopted a prototype plan document. The prototype plan document adopted by the Plan received an opinion letter from the IRS dated June 30, 2020, stating that the prototype plan was designed in accordance with applicable sections of the IRC. Management has not obtained an individual determination letter for the Plan. The prototype plan has been amended since receipt of the opinion letter consisting primarily of changes to ERISA. Management and the Plan Administrator believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust remains tax-exempt at December 31, 2023 and 2022. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

(5) Party-in-interest transactions

Certain Plan investments are shares of mutual funds and common collective trusts managed by VFTC, who is the former trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain investments are shares of mutual funds managed by FMTC, the current trustee of the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management service and administration of notes receivable from participants amounted to \$8,872 for the year ended December 31, 2023. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(6) Information certified by the Plan's trustees
