Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Key Surgical, LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of August 22, 2023 and December 2022, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2023 to August 22, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 22, 2023 and December 31, 2022, and for the period from January 1, 2023 to August 22, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Notes 1, 2 and 7 to the financial statements, the Plan Sponsor approved a plan of liquidation on November 17, 2020, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting on November 17, 2020 from the going concern basis to a liquidation basis. All Plan assets were distributed on August 22, 2023, as discussed in Note 7. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of the Plan

The following description of the Key Surgical, LLC 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established by Key Surgical, LLC (the "Company"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 17, 2020, the Plan was frozen to new participation and all future contributions, and the Plan was terminated. Participants became 100 percent vested in all contributions at this time. Additional information regarding the frozen contributions and the elected plan termination is discussed in Note 7.

Plan Operations

The Company was the sponsor and administrator of the Plan and had selected Minnesota Life Insurance Company ("Minnesota Life") to invest the Plan's assets. Minnesota Life sponsored pooled separate accounts responsible for holding the investment assets of the Plan, carrying out participant-directed investment transactions, and making distributions to participants. Securian Financial, which merged into Standard Insurance Company effective August 9, 2024, provides recordkeeping services for the Plan.

Eligibility

Prior to the plan being terminated, all non-union, qualified employees of the Company were eligible to participate in the Plan upon reaching the age of 21 and after completing two months of employment. Participants were able to enter the Plan following satisfaction of the Plan's eligibility requirements. Upon enrollment in the Plan, a participant directed their contributions to any combination of investment options offered by the Plan.

Contributions

Prior to the Plan being terminated, participants were able to contribute up to 100 percent of their eligible compensation, as defined in the Plan document, but not to exceed the dollar limit set by law, including Roth contributions. Participants 50 years of age or older were able to elect to defer additional catch-up amounts not to exceed the dollar limit set by law. Participants also were able to contribute amounts representing distributions from other qualified plans (rollovers). Eligible employees were automatically enrolled in the Plan as soon as administratively feasible after their entry date at an employee pre-tax contribution rate of three percent of their eligible pay, unless they declined to participate with a prescribed time limit or they elected a different pre-tax and/or Roth contribution rate.

The Company made safe harbor nonelective contributions equal to three percent of eligible compensation. The Company could also elect to make an additional discretionary profit sharing contribution.

Participant Accounts

Each participant's account was credited with the participant's elective deferral, catch-up and rollover contributions, allocations of the Company's safe harbor nonelective contribution, discretionary profit sharing contributions, if any, and Plan earnings, and was charged with an allocation of administrative expenses. Allocations were based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their elective deferrals, rollover, and safe harbor nonelective contributions, plus actual earnings thereon. Participants were fully vested in discretionary profit sharing contributions upon death or, total and permanent disability. All accounts were fully vested when the plan was terminated. For vesting purposes, a year of service occurred when a participant works at least 1,000 hours during the Plan year. Vesting for discretionary profit sharing contributions was based on the following table:

Forfeitures

Prior to the Plan being terminated, forfeited non-vested accounts were used to reduce Company contributions at the discretion of the Company. The Company did not use any forfeitures to reduce the Company's contributions for the period from January 1, 2023 to August 22, 2023. No balance remained in the forfeited non-vested accounts as of August 22, 2023 and December 31, 2022.

Payment of Benefits

Upon termination or retirement, a participant, or in the case of death, the participant's beneficiary, received the balance in the participant's account. Participants experiencing financial hardship could withdraw a portion of their account balance related to previous participant contributions, or upon attaining age 59-1/2 as defined in the Plan. If the participant's account balance was \$1,000 or less and the participant had not made an election, a lump sum distribution was made. There are no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of August 22, 2023.

Notes Receivable from Participants

Prior to the Plan being terminated, participants were able to borrow from their fund accounts in minimum loan amounts of \$1,000, up to a maximum amount limited to the lesser of \$50,000 or 50 percent of the related participant's account balance. These notes were secured by the balance in the participant's account. Interest on note balances was charged at rates commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest was paid through ACH automatic payments from the participant's bank account over a period not to exceed five years, unless the loan was related to the purchase of a principal residence. The maximum number of Plan loans that could be outstanding at any one time was one for the purchase of a participant's primary residence and one for any other purpose.

2. Summary of Significant Accounting Policies

Liquidation Basis of Accounting

As a result of the termination of the Plan, management considered liquidation to be imminent and therefore, the financial statements of the Plan are presented on the liquidation basis of accounting. Under liquidation accounting, assets are stated at their estimated net realizable value and liabilities are stated at their estimated settlement amounts. The fair value of the Plan's assets is considered to approximate liquidation value, as the Plan completed an orderly liquidation of investments as participant accounts were paid out, see Note 7.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at liquidation value (except for fully-benefit responsive investment contracts, which are reported at contract value). Fair value of the Plan's assets is considered to approximate liquidation value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the asset custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of August 22, 2023 and December 31, 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees incurred by the Plan for investment related services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Subsequent Events

The plan has evaluated subsequent events occurring through October 11, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of August 22, 2023 and December 31, 2022.

Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. The plan held no investments as of August 22, 2023.

4. Fully Benefit-Responsive Investment Contract

The Plan's fully benefit-responsive investment contract held a portfolio of investment contracts (guaranteed return account) that comprises a traditional investment contract. These contracts met the fully benefit-responsive investment contract criteria and therefore were reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- a. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- b. Premature termination of the contracts
- c. Plan termination or merger
- d. Changes to the Plan's prohibition on competing investment options
- e. Bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan's normal operations.

The Plan administrator does not believe that any events are probable of occurring, including the recent termination of the Plan, that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- a. An uncured violation of the Plan's investment guidelines
- b. A breach of material obligation under the contract
- c. A material misrepresentation
- d. A material amendment to the agreements without the consent of the issuer.

5. Administration of Plan Assets

The Plan's assets were invested through an annuity contract issued by Minnesota Life. Minnesota Life invests funds received from contributions, investment sales, interest, and dividend income and makes distribution payments to participants.

6. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments were managed by Securian, the asset custodian, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment related services were included in net appreciation in the fair value of the investments, as they were paid through revenue sharing, rather than a direct payment. Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualify as exempt party-in-interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

7. Plan Termination

On November 18, 2020, STERIS Corporation ("STERIS") completed the acquisition of the Company, including all of the outstanding units and equity of the Company. As a requirement of the purchase agreement the Company had to terminate the Plan, prior to consummating the acquisition. As a result, contributions were frozen on November 17, 2020. On August 22, 2023, Participants in the Plan were able to roll over funds to the STERIS Corporation 401(k) Plan, to another employer's eligible plan, to an individual IRA, or to receive a taxable distribution as the Plan completed distributions following its termination.

8. Information Certified by the Asset Custodian

The Plan administrator had elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, the asset custodians, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of August 22, 2023 and December 31, 2022, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits in Liquidation for the period from January 1, 2023 to August 22, 2023.

9. Tax Status

The prototype on which the Plan is based obtained its latest opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "IRC"). On June 23, 2022, the Plan received its final favorable determination letter confirming its tax-exempt status related to the proposed termination date of November 17, 2020 as well as recent amendments. The Plan administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt at the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits in Liquidation.

As of December 31, 2022, the Plan had investments of \$3,957,466 that were concentrated in four pooled separate accounts.
