Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cedar Fair Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cedar Fair Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, Fidelity Management Trust Company, as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cedar Fair Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit

evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Cedar Fair Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Cedar Fair Retirement Savings Plan

1 Description of Plan

The following description of Cedar Fair Retirement Savings Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering certain full-time and part-time employees of Cedar Fair, L.P. and its wholly-owned affiliates ("Partnership") who meet the service and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective July 1, 2024, Cedar Fair, L.P. merged with Six Flags Theme Parks, Inc. to form Six Flags Entertainment Corporation. At the time of the completed merger, Six Flags Entertainment Corporation became Plan Sponsor of the Plan.

Eligibility:

Employees hired on or after January 1, 2008 will be eligible to participate in the employee deferral contributions after attaining age 21. Employees will be eligible for the employer discretionary contribution after completing one year of service and attaining age 21, as defined. A participant must be employed on the last day of the Plan year to receive the employer discretionary contribution. As of December 21, 2018, there is no eligibility service requirement for the employer match contributions, however, participants must have attained age 21 in order to be eligible.

Effective December 1, 2007, employees who are part of Local Union No. 392 and are employed at Kings Island are not considered eligible employees to the Plan, pursuant to the collective bargaining agreement.

Contributions:

401(k) Deferral - All eligible employees are automatically enrolled in the Plan at a pre-tax contribution rate of 3% of compensation, unless otherwise elected. Participants may elect between 1% and 75% of their compensation to be contributed to the Plan. Deferral contributions for each Active Participant having Automatic Enrollment Contributions made on their behalf shall be increased annually by 1%, limited to 10% of eligible compensation. Participants may make Roth 401(k) contributions.

Employer Matching Contributions - The Partnership makes matching contributions of 50 cents for every dollar up to a maximum of 8% of the employee's eligible income. Prior to March 27, 2023, the employer matching contributions was 50 cents for every dollar up to a maximum of 6% of the employee's eligible income.

Employee and Employer matching contributions are determined and recorded at the time compensation is paid.

Employer Discretionary Contributions - Profit sharing contributions are made annually at the discretion of the Partnership. Contributions are allocated to each participant based on a two-tier permitted disparity allocation. Employer discretionary contributions were \$0 (2023) and \$3,969,125 (2022). Effective March 27, 2023, the profit sharing contributions were discontinued.

Rollover contributions from other Plans are also accepted, provided certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

Vesting:

All participants are 100% vested in elective before tax and after-tax deferrals and rollover contributions made to the Plan. Effective June 30, 2022, participants are vested as follows for employer contributions:

Forfeitures:

Any forfeitures attributable to participants' employer contributions shall be used as follows: to fund any allocations as a result of an error in employer contributions, then to restore the benefit of the participant, then reinstate any prior forfeitures. Any remaining forfeitures shall first be used to offset either matching contributions or profit-sharing contributions. Forfeitures used for the years ended December 31, 2023 and 2022 were \$412,198 and \$260,208, respectively.

Forfeited non-vested accounts totaled \$3,410 and \$7,923 as of December 31, 2023 and 2022, respectively. Future employer contributions will be reduced by these amounts.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their rollover, 401(k) deferral and matching fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repaid over a period not to exceed five years, with exceptions for the purchase of a primary residence. The minimum loan amount is \$1,000. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear reasonable rates of interest. Principal and interest are paid ratably through payroll deductions.

Other Plan Provisions:

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59 1/2.

Payment of Benefits:

Upon termination of service by reason of termination of employment, retirement, death or total and permanent disability, a participant receives a lump sum, partial withdrawal or annual installment equal to the value of his or her account. Benefit payments are recorded when paid.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines, as defined by the Plan.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The stable value fund is valued based on the Net Asset Value as the practical expedient as determined by the asset custodian on a daily basis.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Fees of the Plan auditors are paid by the Plan. Fees charged by Fidelity ("Trustee") for recurring participant administrative (recordkeeping) services are paid by the Plan sponsor. Administrative fees are structured in the form of a fixed annual amount (per participant with an account balance) and are invoiced quarterly. Fees associated with participant loans and withdrawals are paid by Plan participants.

Certain investments held by the Plan provide revenue sharing payments. Revenue sharing payments are credited directly to the accounts of plan participants that invest in a fund that provides revenue sharing payments.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2 Summary of Significant Accounting Policies, Continued

Risks and Uncertainties:

The Plan's investments include investments in mutual funds, a self-directed brokerage account, and a stable value funds with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 14, 2024, which is the date the financial statements were available to be issued.

3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets;
- * Quoted prices for identical assets or similar assets or liabilities in inactive markets;
- * Inputs other than quoted prices that are observable for the asset or liability;
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds: The fair value of the mutual funds is based on quoted market prices and are classified in Level 1 of the valuation hierarchy.

Stable Value Fund: The stable value fund is valued at the net asset value as a practical expedient (“NAV”) of shares held by the Plan at year-end.

Self-Directed Brokerage Account: The Self-Directed Brokerage Account is a retirement account which allows participants to invest in individual securities outside of the Plan's funds. Investments include common stocks, mutual funds, preferred stocks, unit investment trusts and money market funds. All investments fall into Level 1 of the hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2023 and 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

4 Tax Status

The Plan adopted a pre-approved defined contribution plan through FMR LLC (“Fidelity”). On June 30, 2020, the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2023, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.
