### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of T-G Enterprises, Inc. 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedules Required by ERISA**

The supplemental Schedule H, line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2023 and Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2023 are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the T-G Enterprises, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective January 1, 2014 and was restated effective January 1, 2022. The Plan covers all eligible employees of T-G Enterprises, Inc. (the Plan Sponsor, Administrator and its Affiliates).

#### Eligibility

Employees become eligible after reaching age 21 and completing one year of service with at least 1,000 hours worked. Eligible participants can enter the Plan on either the first day of the first month or the first day of the seventh month of the Plan Year following fulfillment of the eligibility requirements noted above. At that time, participants can begin deferring compensation into the Plan, and become eligible for both the employer matching and employer profit sharing contributions.

#### Contributions

Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Plan Sponsor may, at its discretion, make a matching contribution each Plan year on behalf of eligible participants equal to a discretionary percentage of the participant's elective deferrals. The Plan Sponsor may also elect to contribute a discretionary profit sharing contribution, to be determined by the Plan Sponsor, not limited to current or accumulated net profits. During 2023, the Plan Sponsor contributed matching contributions equal to 50% of the each participant's contribution not to exceed 2% of each participant's eligible compensation. The Plan Sponsor did not contribute a profit sharing contribution for the year ended December 31, 2023.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Plan Sponsor's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. Administrative expenses are charged to each participant's account when a benefit distribution or loan is processed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of the Plan, continued

#### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

#### Vesting

Participants become 20% vested in the Plan Sponsor's contributions and related earnings thereon after two years of service, and vest 20% each additional year of service up to 100% after six years. Participants are immediately vested in their contributions and related earnings. The nonvested portion of a participant's employer matching account is forfeited upon the distribution of the vested portion of the participant's account. Vesting years are considered a 12-month span in which 1,000 hours of service is completed. Only vesting years after the participant age of 18 are counted.

#### Participant Loans

Participants may request a loan of up to 50% of the vested account balance under the plan, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at 1% over the Prime rate on the first business day of the month when the funds are borrowed. Principal and interest are paid ratably through payroll deductions. The maximum number of loans outstanding is three. The minimum loan amount is \$1,000.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance is greater than \$1,000 (excluding amounts attributable to rollover contributions) will be paid as a single lump sum payment.

#### Forfeited Accounts

All forfeitures are applied to Plan Sponsor contributions and Plan expenses. For the year ended December 31, 2023, participant forfeitures totaling \$13,739 were added to the forfeiture account. No participant forfeitures were used to reduce employer contributions nor pay plan expenses during the year ended December 31, 2023. The forfeiture account had a balance of \$15,224 and \$1,393 as of December 31, 2023 and 2022, respectively.

#### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

#### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

The custodian did not break out interest and dividends from net appreciation. The Plan's management does not believe the impact of this departure from GAAP is material.

#### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of distributions and notes receivables from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments

### 2. Summary of Significant Accounting Policies, continued

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 14, 2024, the date that the financial statements were available to be issued.

### 3. Information Certified and Provided by Custodian

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedules were prepared by or derived from information provided by Transamerica Life Insurance Company (Transamerica), the custodian. The Plan Administrator has obtained certifications from the custodian that investment information provided to the Plan Administrator by the custodian related to the investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the supplemental schedules.

Transamerica also certified to the completeness and accuracy of \$257,235 of net realized and unrealized appreciation in the fair value of investments and accuracy of \$9,861 in interest on notes receivable from participants for the year ended December 31, 2023.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### 4. Fair Value Measurements, continued

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value option:* Valued at NAV as it is a readily determinable fair value and the basis for current transactions.

There have been no changes in the valuation methodologies used at December 31, 2023 and 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

### **5. Related Party and Party-in-Interest Transactions**

Certain Plan investments are administered or managed by Transamerica. Transamerica is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions under ERISA. Administrative expenses of \$7,335 for the year ended December 31, 2023 were paid by the Plan to Transamerica for investment management services.

Indirect fees are paid to Transamerica and Future Plan by Ascensus, the recordkeeper for the Plan, based on investment account values. These fees range from 0.93% to 1.59% of the investment account value. The fees are included with net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Additionally, administrative expenses of \$4,472 for the year ended December 31, 2023 were paid by the Plan to Future Plan by Ascensus for record keeping services. These transactions qualify as party-in-interest transactions under ERISA.

### **6. Tax Status**

The Plan uses a prototype Plan document sponsored by CCH Incorporated, DBA FTWilliam.com (CCH). CCH received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### **8. Prohibited Transactions**

During the year ended December 31, 2023, participant withholdings and loan repayments in the amount of \$8,786 were not remitted within the appropriate time period by the Plan Sponsor, which constitutes a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrences and has taken the appropriate steps to correct the situation. Lost earnings of \$130 on the late deposits were calculated and deposited to the Plan by the Plan Sponsor in 2023.
