RE: 2023 FORM 5500 SUBMISSION WITHOUT INDEPENDENT AUDIT

As the Independent Fiduciary of the above-referenced multiemployer welfare plan, I am submitting the 2023 Form 5500 for this plan without an Independent Audit. Under the circumstances presented in connection with Fleet Owners Insurance Fund, an independent audit would not be justified.

Background

Fleet Owners Insurance Trust Fund was a Taft-Hartley Welfare Benefit Trust ("Trust"). The Trust stopped operating in March 2019 and had no participating Collective Bargaining Employees after March 2019.

On April 30, 2019, the Secretary of Labor filed a Complaint against Robert Kavalec, Charles Alferio, Victor Collova, the Board of Trustees of the Fleet Owners Insurance Fund, and the Fund in the U.S. District Court for the Northern District of Ohio, setting forth claims for violations of the Employee Retirement Income Security Act of 1974. The Secretary alleges that Kavalec, Alferio, Collova, and the Board, as fiduciaries of the Fund, violated several provisions of ERISA by, among other things, authorizing the payment of their own compensation and personal expenses by the Fund, allowing an ineligible person to participate in the Fund, and administering the Fund in violation of the Health Insurance Portability and Accountability Act ("HIPAA") and the Patient Protection and Affordable Care Act ("ACA"). During the course of the litigation, the fund did not collect contributions as all previous participating employers had ceased to participate after March 2019. Monies held in the Fund were reported to the court. A large

percentage of these funds were used for fees and expenses of the former trustees and the Funds counsel while a substantial amount of unpaid medical claims went unaddressed.

As a result of these actions, in late 2021, the Court removed the former trustees and fund counsel and appointed Receivership Management Inc. to determine the amount of remaining claims against remaining assets. Total assets at that time were just under \$358,550; Receivership Management Inc. determined there to be unpaid medical claims in excess of \$985,550. Subsequent actions by the Secretary of Labor have resulted in additional assets to the Fund so as to pay towards the unpaid medical claims.

Unfortunately, the amount of funds available is not sufficient to pay all outstanding medical claims. In this circumstance, it would not be prudent to fund the expense of \$25,000 for an audit for the plan year 2023, further reducing the funds available to address the medical claims of participants. I would request relief from the independent audit requirement for the plan year 2023.
