Retirement Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 18, 2023, and the related statement of changes in net assets available for benefits for the period then ended, and the related notes to the financial statements (2023 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2023, and for the year ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of its knowledge and belief.

Opinion on the 2023 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2023 Financial Statements section:

- The amounts and disclosures in the accompanying 2023 Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying 2023 Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2023 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2023 Financial Statements section of our report. We are required to be independent of Kimmel Center, Inc. Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, Kimmel Center, Inc., the Plan's sponsor, approved the termination of the Plan effective June 1, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2023 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2023 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Kimmel Center, Inc. Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2023 Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Auditor's Report on the 2022 Financial Statements

Predecessor auditors performed an audit of the 2022 financial statements of Kimmel Center, Inc. Retirement Savings Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 16, 2023 indicated that (a) the amounts and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2022 supplemental schedule, other than the information in the 2022 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2022 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

December 18, 2023 (In Liquidation) and December 31, 2022 (Ongoing Basis)

1. Description of Plan

The following description of the Kimmel Center, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established January 1, 1998, covering all employees of the Kimmel Center, Inc. (the “Center”), except for labor union members, unless their Collective Bargaining Agreement or contract provides for coverage under the Plan, who have completed two months of service at the Center and are 21 years of age. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (“ERISA”).

Plan Termination

The Center approved the termination of the Plan effective June 1, 2023. Due to plan termination, participants became fully vested in their accounts. Participants had until December 1, 2023, to distribute funds from the Plan; any balances that remained in the Plan on December 1, 2023 were automatically converted to an individual retirement account.

Participant Contributions

Participants may contribute eligible earnings, as defined in the Plan, on a tax deferred basis, subject to annual limits determined by the Internal Revenue Code (“IRC”) each year, which was \$22,500 for the period ended December 18, 2023. Participants age 50 or older are allowed to make additional catch-up contributions up to \$7,500. Participants also may make Roth deferrals and contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Any participant who did not make an affirmative election to the contrary shall be deemed to have elected participation under the Plan’s automatic deferral provision whereby each eligible employee who has not made an elective deferral shall be deemed to have elected to make a deferral of compensation, as defined by the Plan. Beginning January 1, 2016, participants become auto-enrolled into the Plan at 4%; participants that were auto enrolled in prior years auto-escalate 1% each year until they reach 4%.

Employer Matching Contributions

The Center may choose to make a discretionary employer matching contribution to the Plan covering all participants. For the period ended December 18, 2023, the Center made a discretionary employer matching contribution to participants equal to 50% of the first 6% of salary deferral by each participant. For certain full-time box office members, (eligible employees who are members of a certain collective bargaining unit) the Center made a discretionary employer matching contribution equal to 50% of the first 16% of salary deferral by each participant.

Employer Discretionary Profit-Sharing Contributions

The Center may make a discretionary profit-sharing contribution to (1) active employees at the plan year-end and (2) terminated employees who completed 500 hours of service, as defined, during the plan year. There were no discretionary profit-sharing contributions made in 2023.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offered registered investment company mutual funds and a group annuity contract as investment options for participants.

Participant Accounts

Individual participant accounts are credited with applicable participant contributions, employer matching contributions, an allocation of the employer's discretionary profit-sharing contributions and investment earnings or losses and charged with an allocation of administrative expenses. Participant accounts are valued as of each business day based upon the performance of the investment alternatives in the participant's accounts. Allocations are based upon participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Prior to the plan termination, Center matching and discretionary profit-sharing contributions, plus actual earnings thereon, vested as follows:

Forfeitures

Forfeitures are used to reduce employer contributions. During 2023, amounts forfeited totaled \$8,750. At December 18, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$22,495, respectively. In 2023, forfeited nonvested accounts of \$6,200 were used to pay plan expenses.

Payment of Benefits

Distributions from the Plan are permitted under the following circumstances: (i) attainment of age 59 ½, (ii) termination of employment, (iii) death or disability, (iv) a proven hardship and (v) in-service distributions. Distributions of a participant's account are made in the form of lump-sum or installment payments.

Excess Contributions Payable

Amount payable to participants for contributions in excess of amounts allowed by the Internal Revenue Services ("IRS") or plan provisions are recorded as a liability with corresponding reduction to contributions.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 minus the highest outstanding balance of the notes receivable during the preceding twelve months. As of December 31, 2023, there were no outstanding loans. The notes are secured by the balance in the participant's account, must be repaid within five years and bear interest at rates established by the plan administrator. The term of the note may extend up to a 10-year period when the purchase of a primary residence is made by the participant. The plan administrator determines the interest rate after reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions.

Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Center remitted all employee contributions to the Plan, contributions of \$91,110 were not remitted within the required time period for the period ended December 18, 2023.

Subsequent Events

Management evaluated subsequent events for the Plan through October 14, 2024, the date the financial statements were available to be issued.

2. Summary of Significant Accounting Policies

Basis of Accounting

As described in Note 1, in 2023 the Center approved a resolution to terminate the Plan. As a result, the Plan changed its basis of accounting from accrual basis to liquidation basis. The change from accrual basis to liquidation basis did not have a material effect on the financial statements. The financial statements of the Plan for 2022 are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the group annuity contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Administrative Expenses

For the period ended December 18, 2023, administrative fees of \$39,198 were incurred by the Plan. All other administrative fees were paid by the Center on behalf of the Plan.

3. Information Certified by the Plan's Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the plan administrator obtained or derived from information supplied to the Plan from Reliance Trust Company, the custodian, the following data included in the accompanying financial statements which was certified by the custodian as complete and accurate to the best of its knowledge and belief:

- Investment balances included in the statements of net assets available for benefits as of December 18, 2023 and December 31, 2022.
- Net appreciation in fair value of investments and dividends and interest income included in the statement of changes in net assets available for benefits for the period ended December 18, 2023.
- Notes receivable from participants as of December 18, 2023 and December 31, 2022 and interest income on notes receivable from participants for the period ended December 18, 2023.

While Reliance Trust Company's certification was as of and for the year ended December 31, 2023, the Plan terminated December 18, 2023. There was no activity after December 18, 2023 on the certified statements.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

4. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in registered investment companies are valued at quoted market prices, which represent the net asset value of the shares held as of the reporting date. There have been no changes in the methodologies used at December 18, 2023 and December 31, 2022.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets at fair value as of December 18, 2023 and December 31, 2022, which are included in the fair value hierarchy as Level 1, are registered investment companies totaling \$0 and \$8,323,743, respectively.

5. Group Annuity Contract

The Plan maintains a benefit-responsive group annuity contract with Transamerica (Stable Value Core Option). Contributions are maintained in general accounts. The accounts are credited with interest based on declared interest crediting rates for a specified guarantee period and charged for participant withdrawals and administrative expenses. The group annuity contract issuers are contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by the custodians, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses which approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. For the Transamerica Stable Value Core Option, an effective annual rate of interest is established for the corresponding six-month period. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation.

6. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Reliance Trust Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 18, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that it is no longer subject to income tax examinations for years prior to 2020

7. Party-in-Interest Transactions

The Plan invests in shares of investments managed by an affiliate of the custodian. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Total fees paid by the Plan for investment management and record-keeping fees were \$39,198 for the period ended December 18, 2023. The Center provides certain administrative services at no cost to the Plan.
