1. Plan Description

General

The following description of the Lakeland Bancorp, Inc. Salary Savings 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions and should refer to the latest available information covering Group Allocated Variable and Fixed Annuity Contracts and related investment vehicles, and Fixed Annuity Contracts and related investment vehicles offered by John Hancock Trust Company and The Guardian Insurance & Annuity Company, Inc. (“GIAC”) for more complete information on Plan investments and investment options.

The Plan, which became effective on January 1, 1994, is a defined contribution plan covering substantially all employees of Lakeland Bancorp, Inc. and its subsidiary, Lakeland Bank (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In July 2008, the Board of Trustees approved the merger of Lakeland Bancorp, Inc. Profit-Sharing Plan and Trust into Lakeland Bancorp, Inc. Salary Savings 401(k) Plan and Trust. The merger was completed by October 31, 2008.

During 2018, the Company voted to change their recordkeeper Consulting Actuaries Inc. and investment fund provider Guardian Life Insurance Company, Inc. to John Hancock Trust Company LLC.

During 2019, the Board of Trustees approved the merger of Highlands Bancorp, Inc. Salary Savings 401(k) into Lakeland Bancorp, Inc. Salary Savings 401(k) Plan and Trust. The merger was completed by January 4, 2019.

During 2021, the Board of Trustees approved the merger of 1<sup>st</sup> Constitution Bank 401(k) Retirement Savings Plan into the Lakeland Bancorp, Inc. Salary Savings 401(k) Plan and Trust (see note 8).

During 2022, the Board of Trustees approved the merger of Lakeland Bancorp Inc., with Provident Bank (see note 9).

Eligibility

Employees of the Company are generally eligible to participate in the Plan on the first of the month following thirty days of service and have reached the age of twenty-one (21).

Contributions

Effective April 1, 2018, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan to a maximum of \$22,500 and \$20,500 for the years ended December 31, 2023 and 2022, respectively. In addition, if a participant was at least 50 years old, they could contribute an additional “catch up” contribution of \$6,500 for the years ended December 31, 2023 and 2022. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company, at the election of its Board of Trustees, may make additional discretionary contributions, subject to certain limitations.

During the years ended December 31, 2023 and 2022, the Company elected to make a matching contribution in the amount of 50% of the first 6% of a participant’s elective deferral. Each year, the Company, at the option of the Company’s Board of Trustees, may make profit sharing contributions to the Plan. Such contributions are subject to certain limitations, including a maximum of 15% of each employee’s applicable compensation. During the years ended December 31, 2023 and 2022, there were no discretionary profit-sharing contributions made to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, an allocation of the Company’s discretionary contribution, if any, and Plan earnings. Allocations of Company contributions are based upon each participant’s compensation, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Each participant’s account, for the Company profit sharing, is credited with the participant’s rollover/transfer contribution, if any, and an allocation of: (a) the Company’s contribution; (b) Plan earnings; and (c) forfeitures of terminated participants’ nonvested accounts. Plan earnings are allocated on the basis of individual employee account balances at the beginning of the Plan year. The Company’s contribution is allocated to eight groups of participants, as defined by the plan document. The contribution is first allocated to groups one through seven as determined by the Company. The remainder of the Company’s contributions and forfeitures of terminated participants’ nonvested account balances are allocated to all participants based on a point system, with each participant receiving an allocation based on the ratio of his or her points to the total of all points credited to all participants. All contributions are subject to ERISA and IRS limitations. Points are awarded as follows:

- One (1) point for each full \$100 of total compensation not in excess of \$25,000, plus three (3) points for each full \$100 of compensation in excess of \$25,000 to a maximum of \$245,000.
- Ten (10) points for each year of service up to ten (10) years of service plus twenty (20) points for each year of service in excess of ten (10) years.

Benefits

Distributions from the Plan are disallowed until participants retire, become disabled, die (in which case, payments are made to their beneficiary or if none, their legal representative), can demonstrate a financial hardship, or otherwise terminate employment with the Company. Additionally, in-service distributions are allowed for employees that have reached the age 59 ½. Participants are immediately vested in their account plus the actual earnings thereon upon retirement, as defined by the plan, disability, or death.

Participants, who otherwise terminate employment with the Company, are immediately vested in their pay conversion contributions and voluntary contributions plus the actual earnings thereon. Benefit payments to participants are recorded upon distribution.

Vesting

Vesting in the remainder of their accounts attributable to employer's optional and matching contributions is based on years of continuous service as follows:

Forfeited Accounts

Forfeitures originating from the Company's matching contribution are used to reduce future Company matching contributions and for Plan expenses. Forfeitures originating from the Company's profit-sharing contribution are reallocated annually to participants on the same basis as Company profit sharing allocations. Unallocated forfeitures amounted to \$119,337 and \$85,148 at December 31, 2023 and 2022, respectively, and are used to reduce Company contributions and/or pay for plan expenses. During the years ended December 31, 2023 and 2022, Company contributions were reduced by \$61,246 and \$40,341 respectively, from forfeited nonvested accounts and plan expenses of \$71,250 and \$2,775, respectively were paid from forfeited nonvested accounts. During the years ended December 31, 2023 and 2022, there were no profit sharing forfeitures reallocated to participants. As of December 31, 2023 and 2022, the forfeiture account balance amounted to \$75,619 and \$86,147, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest rates commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions. The interest rates range from 4.25% to 9.50% at December 31, 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and contingent liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance due, any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Plan Administration Expense

Certain expenses of maintaining the Plan are paid by the Company and excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan administrator has evaluated subsequent events and transactions that occurred after December 31, 2023 through the date of the independent auditors' report and the date of the financial statements were available to be issued October 8, 2024. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. The Plan administrator has determined that there are no unrecognized subsequent events that require additional disclosure (see note 9).

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust funds:* Valued at the NAV of units of a bank or insurance company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be profitable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Money market funds:* The carrying amounts approximate fair value because of the short-term maturity of these instruments.

*Common Stock - Employer Securities:* Valued at the closing price reported in the active market in which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

4. Related-Party Transactions and Party-In Interest Transactions

Certain Plan investments are managed by John Hancock Trust Company LLC, the Trustee, as defined by the Plan and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services are included in investment income.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

6. Tax Status

The Internal Revenue Service has determined by letter dated April 26, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's Trustee believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Transfer of Plan Assets

On January 6, 2022, Lakeland Bancorp, Inc. entered into a definitive agreement and plan merger with 1st Constitution Bancorp. As a result, all investments were transferred from 1st Constitution Bank 401(k) Retirement Savings Plan into the plan on February 17, 2022. The total amount of the participants' account balances transferred was \$20,740,010 and loan balances of \$409,609.

9. Subsequent event - Merger

On September 26, 2022, the Board of Directors of Lakeland Bancorp, Inc. had approved the agreement and plan of merger of the Company with Provident Financial Services, Inc. The Company was officially merged on May 16, 2024 and the Plan will continue through December 31, 2024.
