We started our 401(k) Plan with Paychex late in 2022, our contract included a 3(16) Administration Service through 401(k) Generation and we were told they handled 5500 review and filing. Due to a misrepresentation on how the Secure Act tax credits work which we discovered in early 2023 we were left with an overpriced plan and forced to transfer. During that time, we expected the 5500 for 2022 to still be filed, it has come to our attention this was not the case despite the contract being in place as of 12/31/2022, upon transferring this was not followed through on. Now noticing the error we are submitting the form.

401(k) plans are not my specialty, I was relying on a prominent vendor, please waive any late fees associated with the filing.
