NOTE 1 • DESCRIPTION OF THE PLAN

The following description of United Furniture Industries, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of United Furniture Industries, Inc. (the "Company"). The Bankruptcy Trustee of the Company controls and manages the operation and administration of the Plan. Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company serve as the custodian and the Plan trustee, respectively, of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Termination

On November 29, 2022, the Bankruptcy Trustee of the Company elected to terminate the Plan effective immediately. Upon termination, all participants became fully vested and had the right to a force out cash or rollover distribution as soon as administratively feasible. The participants of the Plan received the fair market value of the investments held within the participants' accounts at the time of distribution.

In November 2022, the Bankruptcy Trustee directed the Plan Trustee to mail plan participants notification regarding the termination of the Plan, forced distribution dates and distribution options no less than 30 days prior to the forced distribution date.

Contributions

Participants were allowed to contribute up to 100% of eligible compensation, as defined, each year, subject to limits established by law. The participants' elective deferrals were not taxed as compensation in the year of deferral. Participants were also allowed to contribute rollover contributions representing distributions from other qualified plans. Participants who reached age 50 could elect to make catch-up contributions. The Company could also elect to make discretionary matching contributions which were allocated to participants based on annual pay determined by the Plan. For the years ended December 31, 2023 and 2022, the Company made \$-0- and \$201,844 of discretionary employer matching contributions net of reductions for forfeited accounts.

Investment Options

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered mutual funds, pooled separate accounts and a common collective trust fund.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of the Company's contributions and plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions and allocations of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled were the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions and earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon was based on years of service. A participant was 100% vested after six years of credited service.

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bear interest at rates which were commensurate with local prevailing rates as determined by the Plan administrator. During 2023 and 2022, outstanding loans bore interest rates ranging from 3.25% to 6.5%. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant could elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts contributed on a before-tax basis could only be withdrawn upon demonstration of financial hardship, disability or after the participant reaches the age of 59.5 years.

Forfeitures

There were no forfeited nonvested accounts as of December 31, 2023 and 2022. During 2023 and 2022, forfeitures of \$-0- and \$73,874, respectively, were used to reduce employer contributions. These accounts were used to pay administrative fees, reduce future profit sharing contributions or reduce future employer matching contributions.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Due to the termination of the Plan, the financial statements of the Plan were prepared using the liquidation basis of accounting for the year ended December 31, 2023 and 2022.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan trustee and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Loans were deemed distributed as of December 31, 2023.

Payment of benefits

Benefits are recorded upon distribution.

Administrative expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan Document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

Subsequent events

The Plan has evaluated subsequent events through September 25, 2024, which is the date the financial statements were available to be issued.

NOTE 3 • FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, Fair Value Measurements, (formerly FASB Statement No. 157) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the Plan trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. The trusts publish their daily NAV and transact at that price. Redemptions of the common collective trust held by the Plan are allowed daily for participants; however, the Plan is subject to a 60-day redemption notice period. There are no unfunded commitments. In case of a full liquidation of funds prior to all securities being liquidated, the order will be held, all securities will be liquidated and the order will be executed using the resulting cash balance in the funds. Settlement of unit purchases and redemptions shall occur on the business day following the trade date, or as soon thereafter when sufficient liquidity exists in the funds to cover such a settlement. When liquidity in the funds is insufficient to cover the settlement of redemptions, settlement for that order will be delayed until there is sufficient liquidity in the funds. The investment strategy for funds within the trust seeks to provide significant diversified exposure to equities for long-term capital appreciation.

Pooled separate accounts: The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV of units, as determined by the account manager, as the estimated fair value. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 • EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of pooled separate accounts and a common collective trust fund managed by affiliates of the custodian and Plan trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan for administrative services amounted to \$113,514 and \$177,941 for the years ended December 31, 2023 and 2022, respectively. The Company paid certain administrative fees on behalf of the Plan for the years ended December 31, 2023 and 2022.

NOTE 6 • INCOME TAX STATUS

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the Plan trustee by a letter dated March 31, 2014, that the prototype plan document was designed in accordance with applicable sections of the IRC. During the Plan year, the Plan had certain operational or administrative issues occur. In order to prevent the Plan from incurring a qualification defect, the Company will take the necessary corrective action. The Company is in the process of taking the necessary corrective steps. The Company believes the Plan has maintained its tax-exempt status. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. Some of the retirement plan changes in SECURE 2.0 that may affect the Plan include:

- changes to required minimum distribution age and penalties;
- higher catch up contributions;
- emergency withdrawal flexibility; and
- matching of student loan payments.

Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.
