As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the qualified institution as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As further discussed in Note 1a, the Costas Provisions 401(k) & Profit Sharing Plan was merged into the Twelve Points Pooled Employer Plan (successor plan) effective December 14, 2023, whereby all assets of the Costas Provisions 401(k) & Profit Sharing Plan were transferred to the successor plan. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **1. DESCRIPTION OF PLAN**

The following description of Costas Provisions 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **a. General**

The Plan was a defined contribution 401(k) plan covering all eligible employees of Costas Provisions Corporation (the Plan Sponsor) (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator was responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Effective December 14, 2023, all eligible employees of the Plan became eligible to participate in the Twelve Points Pooled Employer Plan (Successor Plan) and the Plan was frozen for all contributions. On December 14, 2023, the Plan merged and transferred \$12,456,186 of plan assets to the Successor Plan.

#### **b. Eligibility**

Prior to the merger, all employees, excluding leased employees and residents of Puerto Rico, were eligible to participate in the Plan and were eligible for the safe harbor matching contributions, employer discretionary matching contributions and employer discretionary non-elective contributions upon attaining the age of twenty-one and completing one year of service with a minimum of 1,000 hours worked. In addition, to remain eligible for the discretionary non-elective contributions, participants had to be employed on the last day of the plan year unless terminated due to disability, death, or attainment of early or normal retirement date.

#### **c. Contributions**

Prior to the merger, eligible participants may have contributed up to 100% of pre-tax or post-tax (Roth) annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants may have also contributed amounts distributed from other qualified plans (rollover contributions). Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company made safe harbor matching contributions of 100% of the participant's elective deferrals, not to exceed 4% of the participant's eligible compensation, as defined in the plan document. The Company contributed \$143,370 in safe harbor matching contributions for the period ended December 31, 2023. The Company may have also made discretionary non-elective contributions, as determined by the Plan Sponsor's Board of Directors, allocated based on a formula comparing an employee's compensation to the compensation of all employees within the same category of employment. The Company may have also made discretionary matching contributions, as determined by the Plan Sponsor's Board of Directors. There were no discretionary non-elective contributions or discretionary matching contributions remitted prior to the merger.

#### d. Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of the Company's contributions and plan earnings and was charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### e. Vesting

Participants were immediately vested in their contributions and the safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary non-elective contributions plus actual earnings thereon were based on years of continuous service. A participant was 100% vested in the Company's matching and discretionary non-elective contributions after six years of credited service based upon a 20% graded schedule after the one-year anniversary date. Participants were immediately vested upon early retirement, death or disability.

#### f. Forfeitures

Forfeitures represented the non-vested employer contributions forfeited by participants who terminated their employment and withdrew from the Plan. Forfeitures of terminated participants' non-vested accounts were retained by the Plan and were used to reduce discretionary employer matching and discretionary non-elective contributions. The forfeited non-vested accounts totaled \$52,198 at December 31, 2022. There were no forfeited non-vested accounts at December 31, 2023.

#### g. Payment of Benefits

The Plan provided for a normal retirement benefit to be paid to participants who had reached the age of 65. The Plan allowed for early retirement for participants who had reached the age of 55 and had obtained at least five years of vesting service. Upon termination of service, a participant may have received a lump-sum amount equal to the value of their account. There were also retirement benefits available upon disability and death. Beneficiaries were entitled to receive benefit payments on behalf of the participant upon the death of the participant. The Plan required balances of \$1,000 or less to be paid out to participants upon termination.

The Plan allowed in-service withdrawals upon attainment of age 59½. In-service withdrawals were allowed from employer matching and non-elective contribution after five years of participation in the Plan. A participant may have also requested a withdrawal upon demonstration to the Plan Administrator that they were suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### **h. Notes Receivable from Participants**

Participants may have borrowed from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Participants could only have one outstanding loan at a time. Repayment terms ranged from one to five years, unless for the purchase of a primary residence, in which the term of the loan could not exceed fifteen years. The loans were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates. Principal and interest were paid ratably through payroll deductions.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Presentation**

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments consist of mutual and money market funds as of December 31, 2023 and 2022, and are stated at fair value which is computed using the shares of registered mutual and money market funds at quoted market prices on public exchanges, which represent the net asset value (NAV) of shares held by the Plan at year-end. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institution. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. During the year ended December 31, 2023, there were \$1,302 of defaulted loans that were deemed distributed, and are included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

#### **Contributions**

Contributions from plan participants, the safe harbor matching contributions, and discretionary matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. The discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

#### **Due to a Qualified Pooled Employer Plan**

The Plan's qualified institution reported \$451,572 of assets remaining as of December 31, 2023 after participant accounts were transferred to the Successor Plan (see Note 1a). The remaining assets are recorded as a liability due to the Pooled Employer Plan. All remaining assets were transferred as of February 26, 2024.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of administering the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of participant loans and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### **Subsequent Events**

Subsequent events have been evaluated through October 11, 2024, which is the date the financial statements were available to be issued. Except as noted in Note 2, there were no other events that met the criteria for recognition or disclosure in the financial statements.

### **3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AdvisorTrust, Inc., a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2023, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2023.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date. *Fair Value Measurement* establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The following summarizes the fair value hierarchy:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The determination of where assets and liabilities fall within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual and money market funds:* Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2023 and 2022.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Company believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All of the Plan's assets at fair value as of December 31, 2023 and 2022, are valued using Level 1 inputs.

### **5. PLAN MERGER**

As disclosed in Note 1a, the Plan was merged into a Pooled Employer Plan effective December 14, 2023. Concurrent with the merger, the Costas Provisions 401(k) & Profit Sharing Plan was terminated.

### **6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution, expenses paid to the Plan's third-party administrator out of plan assets, and notes receivable from participants are considered party-in-interest transactions. During 2023, the Plan paid the qualified institution and investment advisor administrative expenses totaling \$62,842.

### **7. TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### **8. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in a number of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the accompanying statements of net assets available for benefits.

### **9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the plan year ended December 31, 2021, the Plan Sponsor failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) and loan repayments from its assets within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan Sponsor remitted lost earnings associated with the late remittances in February 2023. There were no prohibited transactions during the plan year ended December 31, 2023.
