### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Resolute Technologies, LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following description of the Resolute Technologies, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution profit sharing plan established January 1, 2013, pursuant to the provisions of section 401(k) of the Internal Revenue Code (IRC), covering substantially all employees of Resolute Technologies, LLC (the Company or the Plan Sponsor), as defined below. The Plan was most recently restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act, as amended (ERISA).

On February 1, 2023, Resolute Technologies, LLC, the Plan Sponsor, was acquired by Eclipse Technologies, LLC. Effective January 1, 2024, the Plan was merged into the SuccessWise Pooled Employer Plan. The net assets of the Plan totaling \$23,003,704 were transferred, which included \$175,139 of outstanding loans.

#### *Trustee, custodian and administration of the Plan*

John Hancock Life Insurance (U.S.A.) (John Hancock) is the trustee, custodian and recordkeeper of the Plan. The administrator of the Plan is the Company. John Hancock holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

All employees of the Company age 19 or older are considered eligible for participation, except for union employees, non-resident aliens, and interns. Seasonal and temporary employees who have completed 1,000 hours of service are eligible to participate. Effective January 1, 2021, long-term, part-time employees working at least 500 hours of service during each of the three consecutive 12-month periods are considered eligible to participate. All eligible employees must have attained the age of 19.

All eligible participants can enter the plan immediately upon hire.

#### *Contributions*

Eligible participants may contribute up to the maximum amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Roth contributions are also permitted. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has elected the provisions of a Safe Harbor plan whereby the Company will contribute an amount equal to 100% of the participant's employee contributions that are not in excess of 5% of

the participants eligible compensation. During the year ended December 31, 2023, the Company made safe harbor matching contributions totaling \$967,281.

The Company may also make a discretionary employer matching contribution to the Plan. During the year ended December 31, 2023, the Company made no discretionary employer matching contributions.

The Company may also make non-elective discretionary contributions (profit-sharing) to the Plan. Participants must be employed on the last day of the Plan year, except in the event of death, disability or retirement during the year, in order to be eligible for the profit-sharing contribution. Profit-sharing contributions may be no less than 5% of a participant's eligible compensation. The Company made profit-sharing contributions of \$935,463 to the Plan during the year ended December 31, 2023, which are receivable as of December 31, 2023. The discretionary non-elective contributions for 2023 were 5% of compensation for all eligible participants.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant accounts***

Each participant's account is credited with the participant's contribution, including amounts rolled over from other qualified plans, and allocations of the Company's safe harbor, matching and profit-sharing contributions, if any, and Plan earnings, less any charges, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the profit-sharing contributions and discretionary employer matching contributions is based on years of continuous service (one-year of service is defined as 500 hours). A participant is 50% vested after completion of one year of credited service and 100% vested after 2 years of service, or in the event of death or total and permanent disability. The Plan provides for one exception to the vesting policy for employees who do not work at least 1 hour of service on or after January 1, 2018. Such participants will continue to vest in accordance with the prior 4-year graded vesting schedule in their profit-sharing and non-safe harbor matching contributions.

### ***Payment of benefits***

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age (the later of age 65 or the fourth anniversary of Plan participation), becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or partial withdrawals. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Withdrawals from the Plan upon circumstances of financial hardship are not allowed under the Plan. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

### *Notes receivable from participants*

Participants may borrow from their accounts up to a maximum equal to (i) the lesser of \$50,000 reduced by the excess (if any) of the highest outstanding balance of any prior loans from the Plan during the prior one-year period, or (ii) 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Participants may not have more than one loan outstanding at any time. Principal and interest are paid ratably through monthly payroll deductions. The notes are repaid ratably through payroll deductions over a period of five years or less, including loans used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

### *Forfeitures*

The Company maintains separate forfeiture accounts with John Hancock. When an employee terminates prior to full vesting, the Plan's cumulative, unvested discretionary matching and discretionary contributions made on behalf of the participant, as well as earnings and losses thereon, are transferred to the Company's forfeiture accounts. Forfeitures on unvested participant balances are credited against future Company contributions or to pay Plan expenses. There were no forfeitures recorded as of December 31, 2023 and 2022. During the year ended December 31, 2023 no forfeitures were utilized to reduce employer contributions or pay Plan expenses.

## **2. Summary of Accounting Policies**

### *Basis of accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### *Use of estimates*

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, custodian and insurance company. See Note 4 for additional information related to fair value measurements.

The Plan's investments in pooled separate accounts are valued based on the publicly quoted pricing input which is used in determining the net asset value of the pooled separate account, which is not publicly quoted. The value of each pooled separate account is determined at the close of each

business day based on fair value of the underlying assets, which can consist of a single mutual fund or multiple securities. The NAV, as provided by the issuer, is used as the practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The redemption frequency is daily and there are no restrictions as to redemption of these investments, nor does the Plan have any contractual obligations to further invest in any of the individual funds. There were no unfunded commitments as of December 31, 2023.

The Plan invests in pooled separate accounts through a Group Annuity Contract with John Hancock which consists of subaccounts of separate accounts. The investment contract seeks to guarantee principal and accumulated interest to participating plans. The Plan's investments in the separate accounts seek to invest in high-quality securities to provide a stable return on investment. The pooled separate accounts consist of investments in mutual funds, a collective investment trust and exchange traded funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions receivable***

Participant contributions and any related discretionary employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Notes receivable from participants***

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### ***Payment of benefits***

Benefits are recorded when paid.

### ***Administrative expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), related to investments held as of December 31, 2023 and 2022, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, a qualified institution.

Notes receivable from participants in the amount of \$175,139 and \$203,495, as of December 31, 2023 and 2022, respectively, and the related interest income from notes receivable from participants totaling \$13,747 for the year ended December 31, 2023, are not certified.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental schedule of assets (held at end of year), including assessing whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The investments in pooled separate accounts, which are valued at NAV, have not been leveled in the fair value hierarchy in accordance with Financial Accounting Standards Board Accounting Standards Update 2015-07, *Disclosures for Investments in Certain Entities That Calculate Net Asset Value Per Share (or Its Equivalent)*. There have been no changes in the methodologies used at December 31, 2023 or 2022.

### 5. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by John Hancock. Participant loan and distribution processing fees are paid to John Hancock by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 8. Income Tax Status

The Plan uses a pre-approved plan document sponsored by CCH Incorporated, DBA ftwilliam.com (CCH). CCH received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 15, 2024 the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements except as disclosed in Note 1.
