## Independent Auditor's Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Lahey Clinic 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor’s Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of Plan

The following description of the Lahey Clinic 403(b) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description and the plan document for a complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan, established October 1, 2002, and restated effective October 1, 2010, covering eligible employees of the Lahey Clinic Foundation, Inc. (“Foundation” or “Plan Sponsor”), Lahey Clinic, Inc. (“Clinic”), Lahey Clinic Hospital, Inc. (“Hospital”), and other designated employers, as defined in the Plan.

Effective September 1, 2014, an employee of Lahey Health Shared Services, Inc. (“Shared Services”) who transferred from Northeast Health System, Inc. (or any affiliate of Northeast Health System, Inc.) or from Winchester Hospital (or any affiliate of Winchester Hospital) shall not be an employee with respect to the Plan until the later of (a) January 1, 2015, or (b) the date the employee has ceased active participation in the retirement plans of Northeast Health System, Inc. or Winchester Hospital, or their respective affiliates, as confirmed by the plan administrator.

Effective August 1, 2015, employees of Lahey Physician Community Organization 1, Inc. (“LPCO”) are eligible to participate in the Plan.

Effective January 1, 2018, employees of Lahey Clinical Performance Network (“LCPN”) are eligible to participate in the Plan.

The Plan Sponsor and plan administrator is the Lahey Clinic Foundation, Inc. Upon the formation of Beth Israel Lahey Health (“BILH”) on March 1, 2019, the Foundation became an affiliate of BILH, its sole corporate member. BILH was formed through the combination of hospitals and other affiliates of three legacy health care systems based primarily in the Eastern Massachusetts market, including the former CareGroup system, the former Lahey Health System, and the Seacoast Health System. The Board of Directors has delegated responsibility for oversight of the Plan to BILH, who has delegated to the BILH Retirement Plans Committee the responsibility to oversee the Plan, including administrative matters, and to determine the appropriateness of the Plan’s investment offerings as well as to monitor investment performance.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 31, 2023, the Plan was restated and merged into the Beth Israel Lahey Health 403(b) Retirement Savings Plan and the sponsorship of the plan was transferred to BILH. Concurrent with the merger, the assets of the Plan were transferred to the Beth Israel Lahey Health 403(b) plan as noted in the accompanying statement of changes in net assets available for benefits.

#### *Eligibility*

Any employee, who is an employee of the Foundation, Clinic, Hospital, Shared Services, LPCO, or LCPN may become a participant in the Plan on his or her start date or thereafter, or as defined in the Plan.

On April 26, 2010, the Plan Sponsor approved changes to the eligibility requirements for the Lahey Clinic Foundation, Inc. Pension Plan (“Pension Plan”). Pension plan eligibility is closed to new employees hired August 1, 2010, or later. In conjunction with those changes to the Pension Plan, the Plan Sponsor introduced employer matching funds, annual core employer contributions, and an automatic enrollment feature to the Plan. Active employees eligible for the Pension Plan had a limited time election opportunity to either remain in the Pension Plan or to stop accruing pension service and participate in the enhanced plan, with their choice becoming effective January 1, 2011.

Participants in the enhanced plan, who are scheduled for 20 hours or more per week or work at least 1,000 hours in a calendar year, are eligible for employer contributions.

Effective January 1, 2015, eligible employees who previously were participants in the Pension Plan, and not participants in the Plan were automatically enrolled in the Plan in connection with the freeze of the Pension Plan.

### ***Contributions***

Each year, participants may contribute up to 100% of their respective pretax annual compensation, as defined in the Plan, subject to limitations established by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Individuals hired by one of the four employers who do not affirmatively elect not to participate in the Plan are automatically enrolled in the Plan and will have their compensation reduced by 4% and invested in Fidelity Freedom Funds having a target retirement date closest to the year the participant will obtain age 65.

Participants who are eligible for the employer match receive \$.50 for every dollar contributed, up to the first 4% of eligible compensation, per pay period.

In addition, an annual core contribution is made based on age and salary ranging from 2% to 10.5% of eligible compensation. Participants must be employed on the last day of the plan year to receive a core contribution.

Effective January 1, 2015, certain employees will receive transition contributions to their account in the Plan over a five-year period from 2015 to 2019. These transition contributions are provided to those participants who were closer to retirement after the freeze of their pension benefits on January 1, 2015. Transition contributions are based on a total of age and years of service. These transition contributions range from 2% to 10% of eligible compensation.

LPCO employees will receive a non-elective employer contribution equal to 2% of compensation, as defined. LPCO employees shall be entitled to this annual contribution for each plan year in which they are credited with at least one hour of service.

Effective January 1, 2018, LCPN employees will receive a non-elective employer contribution equal to 2% of compensation, as defined. LCPN employees shall be entitled to this annual contribution for each plan year in which they are credited with at least one hour of service.

Effective March 1, 2019, the Plan permits Roth elective deferrals. Roth elective deferrals shall be treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not “pre-tax” deferrals as defined in the Internal Revenue Code (“IRC”).

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan, including a self-directed brokerage option, which allows a participant to invest in assets outside of the investment options offered by the Plan. Participants who do not elect an investment option will have their contributions directed to a default fund.

### ***Participants Accounts***

Each participant’s account is credited with the participant’s contribution, matching contributions, and a pro-rata allocation of the fund’s investment gains or losses. The Plan’s core contribution and match true-up are credited on an annual basis. The benefit to which a participant is entitled is the vested portion from the participant’s account.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts plus actual earnings thereon is based on years of vesting service. A participant is credited with a year of vesting service for each plan year in which they complete at least 1,000 hours of service and is 100% vested after the completion of three years of credited service.

Effective June 1, 2016, employee’s vesting will include past service credited from Northeast Health System, Inc. and affiliates and Winchester Hospital and affiliates, as defined in the amendment to the Plan.

### ***Forfeitures***

At December 31, 2023 and 2022, forfeited non-vested employer contributions totaled \$-0- and \$1,364,866, respectively. These amounts will be used to reduce future employer contributions. Forfeitures used to reduce employer contributions during the year ended December 31, 2023, amounted to \$2,516,852.

### ***Administrative Expenses/Revenue Credit***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

The plan recordkeeping agreement provides for an annual payment by the recordkeeper to the Plan, payable quarterly in arrears, and was \$1,631,467 for the year ended December 31, 2023. The Plan Sponsor may direct the recordkeeper to reimburse the Plan Sponsor for fees and expenses associated with services provided to the Plan. Amounts unused for expenses may be allocated to participant accounts, as outlined in the amendment. The amount available in the revenue credit account at December 31, 2023 and 2022, is \$3,925,953 and \$2,769,944, respectively. During the year ended December 31, 2023, \$475,457 was used from the revenue credit account to offset plan expenses.

Administrative expenses such as participant loan processing fees and other participant specific fees are deducted directly from participant accounts. The amounts deducted from participant accounts in 2023 amounted to \$98,931.

### ***Participant Loans***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are able to have only one loan outstanding at a time. Loan terms range from one to five years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus .5%, as determined on a daily basis by the plan custodian. Principal and interest are paid ratably through payroll deductions. Effective July 1, 2015, all new participant loans will be repaid through individual ACH transactions between the participant and Fidelity Management Trust Company ("Fidelity") and not through payroll deduction.

### ***Payment of Benefits***

Upon separation of employment due to termination, death, disability, or retirement, participants may receive the value of the vested interest in their account as a lump-sum amount. Prior to termination of employment, participants can withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59½ years of age.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its discretionary contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements have been prepared on the accrual basis of accounting.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan’s management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### *Payment of Benefits*

Benefits are recorded when paid.

## **3. Certified Investments**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity (trustee and recordkeeper), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022 and the related investment income activity and interest income on notes receivable from participants reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2023.

At the request of the plan administrator, the Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

## **4. Fair Value Measurements**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

### ***Mutual Funds***

Valued at the daily closing net asset value ("NAV") as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### ***Self-directed Brokerage Accounts***

The Plan's holdings in the self-directed brokerage accounts consist of mutual funds valued at fair value. At December 31, 2023 and 2022, the Plan's holdings in the brokerage accounts and mutual funds were valued using level 1 inputs.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 6. Related-Party Transactions and Party-in-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the custodian are considered party-in-interest transactions.

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity, the plan custodian. In addition, Fidelity is the plan recordkeeper, and therefore, these transactions qualify as party-in-interest transactions. These investments and transactions are considered to be party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

### 7. Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Subsequent Events

The Company has evaluated all subsequent events through October 15, 2024, the date the financial statements were available to be issued.
