Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Hawaii Mainland Administrators 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of the Hawaii Mainland Administrators 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General – The Plan was a defined contribution plan covering substantially all employees of the Hawaii Mainland Administrators, LLC (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company was the Plan's sponsor and served as Plan administrator.

Effective January 1, 2024, the Hawaii Mainland Administrators 401(k) Plan merged into an existing plan (MedImpact Healthcare Systems Inc. Salary Saving 401k Plan) of an affiliated entity. The Plan legally ceased to exist as of January 1, 2024, and all assets of the Plan were transferred to the MedImpact Healthcare Systems Inc. Salary Saving 401k Plan by January 11, 2024.

Eligibility – Prior to the Plan merger, substantially all employees of the Company were eligible to participate in the Plan upon employment. Participants were eligible for matching contributions when they had completed three months of service. Participants had to be employed as of the last day of the plan year to be eligible to receive any employer discretionary nonelective contributions.

Contributions

Participant contributions – Prior to the Plan merger, each year, participants were able to contribute between 1–75% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Discretionary matching contributions – Prior to the Plan merger, the Company was able to make discretionary matching contributions to the Plan. During 2023, the Company matched 15% of employee contributions on the first 5% of eligible compensation deferred to the Plan. There were no discretionary matching contributions for the years ended December 31, 2023 and 2022.

Discretionary nonelective contributions – Prior to the Plan merger, the Company could elect to make discretionary nonelective contributions to the Plan. There were no discretionary nonelective contributions for the years ended December 31, 2023 and 2022.

Contributions were subject to regulatory limitations.

Participant accounts – Each participant’s account was credited with the participant’s contributions and Company matching contributions, as well as allocations of plan earnings. Participant accounts were charged with an allocation of an administrative expense that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants directed the investment of their contribution into various options offered by the Plan.

Vesting – Participants were immediately vested in their contributions, as well their related earnings thereon. Vesting in the employer contribution portion of their accounts plus related earnings thereon was based on plan years of continuous service. To qualify as a completed plan year of service, the participant had to work at least 1,000 hours in the plan year. Upon completing one year of service, a participant became 20% vested and continued to vest an additional 20% per year of completed service until fully vested upon completion of five years of service. Participant’s follow the vesting requirements of the new Plan effective the date the merger.

Notes receivable from participants – Prior to the Plan merger, participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest principal amount of any other loan outstanding within the past 12 months, or 50% of their vested account balance less the total amount of all loans outstanding during the year. Participant loans were secured by the balance in the participant’s account and bore a fixed interest rate set at 1% above the prime rate. Principal and interest were paid ratably through payroll deductions and were recorded when received. A participant was able to have two outstanding loans at one time. At December 31, 2023, the rates of interest on outstanding loans ranged from 5.25% to 10.50%, with various maturities through January 2038.

Payment of benefits – Prior to the Plan merger, on termination of service due to death, disability, or retirement, a participant was able to elect to receive either a lump-sum amount equal to the value of his or her vested account, or annual installments over a term not to exceed normal life expectancy. Participants also were able to elect to receive in-service distributions upon reaching age 59½ or hardship distributions under certain circumstances. Hardship withdrawals could not exceed the amount of the employee’s cumulative deferral, and the participant may not make additional deferrals for a period of six months after the date of withdrawal.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's trustee, Dubuque Bank & Trust Co., certifies the fair market value of all investments as of December 31, 2023 and 2022. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at the unpaid principal balance, plus any accrued but unpaid interest. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative plan fees. Investment-related expenses are included in net appreciation in fair value of investments.

Excess contributions payable – Excess contributions payable represent amounts refunded to participants after year end to comply with regulatory contribution limitations.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 15, 2024, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used for the years ended December 31, 2023 and 2022:

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Dubuque Bank & Trust Co., the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022;
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023; and
- Investments reflected on the schedule of assets (held at end of year).

Note 5 – Tax Status

The Plan document was a prototype non-standardized profit sharing plan with cash or deferred arrangement that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC).

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Party-in-Interest Transactions

The Plan paid expenses related to plan operations and investment management to various service providers. Certain plan investments are managed by Dubuque Bank & Trust Co. Dubuque Bank & Trust Co. is the trustee of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.
