4. for any plan year in which the participant terminates his employment, if at least an hour of service was completed during that plan year, credited service on a proportional basis will be granted and will be determined by dividing the number of hours of service which the participant completes during such plan year, by 1,800.

Credited service shall not include the following periods of service:

1. that portion of any personal leave which is in excess of six months' duration;
2. that portion of any period of layoff in excess of six months; and
3. effective January 1, 2008, no years of credited service shall be taken into account with respect to plan years beginning after December 31, 2007.

Vesting service

1. for plan years prior to January 1, 1989, continuous service is granted pursuant to the terms of the plan then in effect; plus
2. for any plan year ending after December 31, 1988, the aggregate number of plan years during each of which the Employee completed at least 900 hours of service; plus
3. if the employee completed less than 900 hours of service during the plan year immediately preceding the plan year in which the employee first becomes a participant or resumes participation, as the case may be, a partial year for such immediately preceding plan year, determined by dividing the number of hours of service that the employee completes during such preceding plan year, by 900; plus
4. a partial year for the plan year during which employment terminates, determined by dividing the actual number of hours of service that the employee completes during such plan year, by 900.

Optional forms of benefit payments

The optional forms of benefit payments are:

- A straight life annuity
- Monthly annuity payable for 10 years certain and life.
- Monthly annuity payable as a survivorship life annuity with survivorship percentages of 50, 66 2/3, 75 and 100.

The optional form conversion basis based on the more favorable option of a) 7.5% interest and the GAM-1971 mortality table, weighted for 80% males and 20% females and b) 417(e) prescribed mortality table and interest rates. The optional form conversion basis uses the applicable interest rate and applicable mortality table as set forth in Code Section 417 for lump sum payments. The applicable interest rate uses the second calendar month preceding the first day of the stability period which is the plan year.
