### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pinnacle Orthopaedics & Sports Medicine Specialists, LLC Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Pinnacle Orthopaedics & Sports Medicine Specialists, LLC Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Notes to Financial Statements

#### **Note 1: PLAN DESCRIPTION**

The following description of the Pinnacle Orthopaedics & Sports Medicine Specialists, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees and part-time employees of Pinnacle Orthopaedics & Sports Medicine Specialists, LLC (the Company). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Plan's Retirement Committee (Retirement Committee) determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Bank of America, N.A. ("Bank of America" or "BOA"), the custodian and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Retirement Committee and provides certain recordkeeping services. Bank of America, N.A. also acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

On September 6, 2023, the Retirement Committee resolved to merge the plan into the 401(k) Plan sponsored by United Musculoskeletal Partners, LLC (the "UMP 401(k) Plan") effective December 31, 2023. This decision was made pursuant to an Asset Purchase Agreement dated June 1, 2023. As part of this transition, contributions to the Pinnacle 401(k) Plan were frozen effective December 31, 2023. Liquidation and transfer of plan assets to the UMP 401(k) Plan was completed on February 16, 2024. A final Form 5500 was filed for the Plan. See Note 8 reconciling the financial statements to the final Form 5500.

#### ***Eligibility***

Employees may become a participant of the Plan when they have reached one year of service, with 1,000 hours of service, and are age twenty-one or older. An eligible employee may enter the Plan on the next quarterly entry date after all entry requirements have been met.

Effective July 25, 2022, employees may become a participant of the Plan when they are age twenty-one or older. An eligible employee may enter the Plan on the day the entry requirement has been met.

#### ***Contributions***

Each participant may make pre-tax and Roth contributions of up to 100% of eligible compensation as defined by the Plan, not to exceed a maximum of \$22,500 in 2023, plus additional "catch-up" contributions of up to \$7,500 for those participants who have attained age 50. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

***Contributions (continued)***

Effective July 25, 2022, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Company matching contributions are equal to 50% of the participant's elected deferral up to 2% of eligible compensation. The Company may make discretionary profit sharing contributions. In 2023, there were no profit sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, rollovers, the Company's contribution and earnings on the investments, and is charged with certain fees related to specific investment options chosen by the participant, specific transactions and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. Participants direct the investment of their accounts into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. Participants are 100% vested on a graduated scale after six years of credited service. If continuous service is terminated by death, disability or retirement a participant is immediately 100% vested.

***Notes Receivable from Participants***

Participants may borrow from their vested account amounts not to exceed the lesser of 50% of the participant's balance or \$50,000, reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. The minimum loan amount is \$1,000. The maximum term of such loans is five years, except for a loan for the purchase of a primary residence, which has a fifteen-year maximum term. The interest rate is set at the prime rate plus 1% and is fixed over the life of the loan. Principal and interest is paid ratably through payroll deductions.

***Benefit Payments***

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution. The participant's vested amount may also be withdrawn for in-service distributions upon reaching age 59½ or certain hardship situations.

***Forfeitures***

Forfeitures are used to reduce future employer contributions. At December 31, 2023 and 2022, forfeited, nonvested accounts totaled \$46,746 and \$22,410, respectively. The 2023 plan expenses were reduced by forfeitures of \$23,180. The 2022 employer contribution, which was deposited in 2023, was reduced by forfeitures of \$27,300.

***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

**Note 2: SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The FASB provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

***Use of Estimates***

The preparation of U.S. GAAP financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments generally are reported at fair value but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV.

The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Distributions to participants are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan (investment fees and self-directed brokerage account fees) unless otherwise paid by the Company (legal, accounting and administrative fees). Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 15, 2024. See Note 9 for relevant disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

**Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by BOA, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2023 and 2022.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2023 and 2022.
- c) Investment income and interest income on notes receivable information included in the statement of changes in net assets available for benefits for the year ended December 31, 2023.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2023.

**Note 4: FAIR VALUE MEASUREMENTS**

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Cash and Cash Equivalents (Held in the Self-Directed Brokerage Accounts):* Valued at cost, which approximates fair value.

*Common Stocks (Held in the Self-Directed Brokerage Accounts):* Valued at the closing price reported on the active market on which the individual securities are traded.

*Corporate Bonds (Held in the Self-Directed Brokerage Accounts):* Values are determined on the basis of the last reported sales prices, or if no sales prices are reported, based on quotes obtained from a quotation reporting system, established market makers, or pricing services.

*Mutual Funds and Money Market Funds (Held directly by the Plan and in the Self-Directed Brokerage Accounts):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts (CCTs):* The Plan's CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5: TAX STATUS**

Effective January 31, 2015, the Plan adopted the Merrill Lynch Prototype Defined Contribution Plan and Trust Document which obtained an opinion letter dated March 31, 2014, in which the IRS stated that the underlying prototype document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator has determined that it is eligible to and has chosen to rely on the current opinion letter. Although the Plan has since been amended, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax exempt.

Tax positions are recognized only if it is “more likely than not” that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds and common/collective trusts managed by Bank of America. Bank of America is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Bank of America also receives administrative fees from the Plan. The fees paid by the Plan to Bank of America were \$900 for 2023. The remaining fees of \$21,053 were paid to a third party investment advisor.

**Note 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
